## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Philadelphia College of Osteopathic Medicine Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### (1) Description of Plan

The following description of the Philadelphia College of Osteopathic Medicine Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering most hourly and salaried employees of Philadelphia College of Osteopathic Medicine (PCOM), except students, non-resident aliens, and leased employees. Participants become eligible to participate in the Plan immediately upon employment. Full-time employees participating in the Plan become eligible to receive employer contributions on the first day of the month following the completion of sixty (60) days of consecutive service. Part-time employees participating in the Plan become eligible to receive employer contributions on the first day of the month following the completion of ninety (90) days of consecutive service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### ***Contributions***

Each year, participants may contribute a portion of their annual compensation, as defined in the Plan up to the Internal Revenue Service (IRS) limitation. Participants may elect to have their deferrals be either pre-tax and after-tax (Roth) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Additionally, the Plan allows participants with more than fifteen (15) years of service to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The PCOM employer required contribution is made on an age-tiered basis. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and PCOM required contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in their elective contributions, as well as any employer contributions made to the Plan on their behalf, plus actual earnings thereon.

### (1) Description of Plan, Continued

#### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may range from one to five years, or longer for a loan used to acquire a principal residence. The loans are secured by the balances in the participants' accounts and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with prevailing rates. Principal and interest are paid by participants directly to the custodians.

#### *Payment of Benefits*

Depending on the type of investment and the investment provider with whom amounts are invested, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, a qualified optional survivor annuity or annual installment payments not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and their designated beneficiary.

### (2) Summary of Significant Accounting Policies

#### *Basis of Presentation*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive insurance contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### (2) Summary of Significant Accounting Policies, Continued

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of the Plan are paid by the Plan as permitted in the plan document while other expenses are paid by PCOM. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### *Subsequent Events*

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

### (3) Financial Information Certified by the Custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ending June 30, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Equitable Financial Life Insurance Company, Lincoln National Life Insurance Company, Lincoln Financial Group Trust Company, Inc., Newport Trust Company and TIAA and CREF, the custodians of the Plan.

### (4) Fair Value Measurements

FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

The money market funds and registered investment companies not affiliated with TIAA and CREF, one of the Plan's custodians, are valued at the daily closing price as reported by the fund. These funds held by the Plan are open end funds that are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The stable value funds are valued at NAV of units held. The NAV is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The practical expedient is not used when it is determined that the fund will sell the investment for an amount different than the reported NAV.

The CREF Money Market account represents a registered investment company. The investment is exchange traded and is classified within level 1 of the fair value hierarchy.

The CREF investments represent registered investment companies. The fair values of accumulation units held by these investments are based on each account's daily NAV. The accounts are exchange traded daily and are classified within level 1 of the fair value hierarchy. NAV data is also available daily to plan administrators and client investors on TIAA and CREF's website.

The fair value of the Plan's interest in the TIAA Real Estate Account (REA) is based on the fund's daily NAV, which is considered by plan management to be the best approximation of fair value. The NAV is used as a practical expedient to estimate fair value. The unit value of the fund is calculated daily and available to plan administrators and client investors on TIAA and CREF's website. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Accumulation units in the REA are available for transactions at the closing NAV on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter. Although the underlying assets of the REA cannot be quickly sold and converted to liquid assets, the TIAA General Account provides the REA with a liquidity guarantee (TIAA ensures that the REA has funds available to meet participant redemption, transfer or cash withdrawal requests executed at quoted unit values).

The TIAA Access investments represent separate non-exchange traded investment accounts that invest in proprietary and nonproprietary mutual funds through various subaccounts. TIAA Access accounts are valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value.

Investments in TIAA Traditional Annuity contracts are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

Investment objectives:

- (i) High total return over time through either a combination of capital appreciation and income or primarily through income with a secondary emphasis on capital appreciation.
- (ii) Long-term total return, mainly through capital appreciation, primarily from equity securities of either small, medium, or large domestic companies or from domestic and foreign issuers.
- (iii) Long-term total return, mainly through capital appreciation, by investing in either foreign equity investments or small to large domestic companies, all of which are based on a market index.

There were no significant transfers among investment levels during the years ended June 30, 2024 and 2023.

### ***Changes in Fair Value of Level 3 Assets***

During 2024, there were no transfers into or out of investments included in level 3 of the fair value hierarchy. Purchases of level 3 investments amounted to \$3,545,936.

### (5) Guaranteed Insurance Contracts

The Plan has entered into benefit-responsive guaranteed insurance contracts with Equitable Financial Life Insurance Company (Equitable) and TIAA and CREF, plan custodians, totaling \$8,483,524 and \$7,902,706 at June 30, 2024 and 2023, respectively. Each contract maintains the respective contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

### (5) Guaranteed Insurance Contracts, Continued

Because the guaranteed insurance contracts are fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributed to the guaranteed investment contracts. Contract value, as reported to the Plan by Equitable and TIAA and CREF, represents contributions under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed insurance contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity dates.

There are no reserves against contract values for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan, or (4) the failure of prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### (6) Investments

TIAA and CREF is not a direct filing entity with respect to its pooled separate accounts, with the exception of the REA. Consequently, those investments are reported as registered investment companies on Schedule H of the Form 5500.

### (7) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of money market funds, pooled separate accounts, registered investment companies, stable value funds and guaranteed annuity contracts managed by AXA, Equitable, Lincoln National, TIAA and CREF, Lincoln Financial Group, Newport Trust Company and Vanguard. Equitable, Lincoln National, TIAA and CREF, Lincoln Financial Group and Newport Trust Company are the custodians of the Plan, and AXA and Vanguard are affiliated with the custodians, and, therefore, these transactions qualify as party-in-interest transactions, for which the parties are paid a fee for investment management services. These transactions are exempt from prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment.

### (8) Plan Termination

Although it has not expressed any intent to do so, PCOM has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### (9) Tax Status

The Plan has a written plan document and an adoption agreement sponsored by Lincoln Retirement Services Company LLC. The IRS has determined and informed Lincoln Retirement Services Company LLC by a letter dated March 31, 2017, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
