### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of JDRF International 403(b) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

## Notes to Financial Statements

### 1. Description of the Plan

The following description of the JDRF International 403(b) Retirement Savings Plan provides only general information. Participants should refer to the Plan agreement and summary Plan description for a complete description of the Plan's provisions.

#### *General*

The Plan was established as a tax-deferred annuity plan, effective April 1, 1990, intended to meet the requirements of Section 403(b) of the Internal Revenue Code (IRC), and conforms with the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees of Breakthrough T1D (f/k/a JDRF International) (the Employer), are eligible to participate in the Plan and to contribute, by means of a salary-reduction agreement, to a custodial account at State Street Bank and Trust Company (SSBT) and in guaranteed investment contracts issued by Transamerica Financial Life Insurance Company (TFLIC).

#### *Contributions*

Participants are permitted to contribute to the Plan up to the maximum amount permitted by law. Participants may designate these contributions as pre-tax salary deferral contributions, irrevocably designate all or any part of salary deferral contributions to the Plan as Roth deferrals, as defined, or a combination of both. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions.

The Plan provides a payroll-based employer matching contribution to each eligible participant equal to 100% of the first 3% of participant contributions plus 50% of the next 3% of participant contributions, which will allow employer matching contributions on up to 4.5% of participant contributions.

Participants can roll over part or all of an eligible rollover distribution they have received from an eligible retirement plan into this Plan as a rollover contribution.

#### *Participant Accounts*

Each participant's account is credited with (a) the participant's contributions, (b) employer matching contributions, if any, and (c) Plan net earnings, and charged with (a) withdrawals, (b) allocation of Plan losses, and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

For participant and rollover contributions, participants are at all times 100% vested in their account balances, including any earnings thereon. Employer matching contributions are fully vested after three years of service on a cliff basis.

#### *Investment Options*

The Plan offers various mutual funds and a guaranteed investment contract to participants.

Participants also have the option to direct contributions to a personal choice retirement account (PCRA). This account consists of various investment options offered by Charles Schwab, which include other mutual funds.

### ***Notes Receivable from Participants***

The Plan allows participants to borrow from their individual accounts no more than the lesser of 50% of their vested account balance or \$50,000, with a minimum loan amount of \$1,000. Loan terms range from 12 months to five years but can be up to ten years if the loan is used to acquire a principal residence. Only two loans can be outstanding at a time. The loan has a setup charge of \$75 per loan (which is deducted from the participant's account) plus an annual loan administration charge not exceeding 1% of the outstanding loan balance. The interest rate is based on the prime rate plus 1%. Loans are repaid ratably through payroll deductions.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or resignation, a participant may elect to receive benefit payments under three different methods. A participant may receive annuity payments in the form of a joint and survivor annuity, if married, or life annuity, if unmarried, spread over not more than the participant's lifetime or surviving spouse's lifetime, if married. A participant may receive a payment in a lump-sum amount equal to the value of the participant's vested interest in his or her account. Finally, a participant may receive payments in installments, or an annuity spread over not more than the participant's life expectancy or the designated beneficiary's life expectancy.

In cases of financial hardship, as defined by the Plan, participants may be eligible to receive a distribution from their salary deferral, rollover, and vested matching contributions, including any earnings thereon.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Notes Receivable from Participants***

Notes receivable from participants are stated at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes are reclassified as a distribution based on the terms of the Plan document. No allowances for credit losses have been recorded as of June 30, 2024 and 2023.

### *Investment Valuation and Income Recognition*

The Plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of investments, which consists of the realized and unrealized gains or losses on investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Forfeitures*

Non-vested accounts are forfeited upon termination (at the end of the waiting period, as defined by the Plan) or withdrawal and are deposited in a TFLIC guaranteed investment contract, a Plan-level unallocated account, temporarily before allocation. Forfeited non-vested amounts are first used to reduce employer contributions. The remaining forfeiture amounts are used to offset Plan expenses and restore participant accounts.

At June 30, 2024 and 2023, the forfeited non-vested accounts totaled \$31,310 and \$122,522, respectively. Approximately \$240,000 of forfeited funds were used to offset employer contributions for the year ended June 30, 2024.

### *Expense Budget Account*

The Plan has an Expense Budget Account (EBA) with Transamerica Retirement Solutions Corporation (TRSC), which may be used to pay Plan-related expenses or can be allocated to Plan participants at the end of the year. The EBA is held in a TFLIC-guaranteed investment contract, which is a Plan-level unallocated account that may be credited with fund revenue in excess of the amount of compensation TRSC receives during the year. The fund revenue may include distribution fees and administrative fees that TRSC or its affiliates receive from the Plan's investment options. For the year ended June 30, 2024, additions to the fund were \$80,594, and \$81,588 was used to pay administrative expenses. At June 30, 2024 and 2023, the EBA had a balance of \$42,323 and \$43,316, respectively. Administrative expenses are shown net of the EBA balance on the statement of changes in net assets available for benefits.

### *Administrative Expenses*

Administrative expenses of the Plan are shared between the Plan and the Employer, except for loan-processing fees, which are paid by participants. Annual fees related to participant retirement accounts with Charles Schwab and withdrawal fees were charged directly to the participant accounts and were included in administrative expenses. Expenses that are paid by the Employer are excluded from these financial statements.

### 3. Risks and Uncertainties

The Plan provides for various investment options in mutual funds and a guaranteed investment contract. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 4. Information Certified by the Custodians

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by SSBT and TFLIC, qualified institutions.

### 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024.

*Personal Choice Retirement Account (PCRA)* - The PCRA is a brokerage option, whereby participants can elect to invest their Plan accounts in numerous publicly traded securities not offered by TRSC. The Plan invested in a money market fund and mutual fund, within the PCRA, which were valued at unadjusted quoted market prices.

*Mutual Funds* - Mutual funds are valued at quoted market prices whose value is based on the net asset value (NAV) of shares owned by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. Investment Contracts with TFLIC

The investment contract is a guaranteed investment contract under group annuity contracts issued by TFLIC. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Plan's balance in the guaranteed investment contract, including accrued interest, is guaranteed by TFLIC.

The Plan's investment in the guaranteed investment contract is a fully benefit-responsive guaranteed investment contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TFLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract contains a minimum guaranteed interest rate, which is in effect throughout the life of the contract. At the beginning of each calendar year, TFLIC determines the declared interest rate

(portfolio rate) that will be credited to all monies invested in the guaranteed investment contract during such calendar year. In no event will the declared rate of interest be less than the contract's minimum guaranteed interest rate.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to, a merger, layoffs, bankruptcy, full or partial Plan termination, and early retirement incentive programs, and excluding Bona Fide Termination of Employment, as defined in the contracts. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The issuer may terminate the contract and settle at amounts that differ from contract value if certain conditions within the investment contract are not met.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan. Participants will become 100% vested. Disbursements to participants would be made, in accordance with the Plan document, to the extent permitted under Section 403(b) of the IRC and related U.S. Treasury regulations.

### **8. Tax Status**

The Plan has adopted the Transamerica Retirement Solutions, LLC Volume Submitter 403(b) Plan (the 403(b) Plan). Accordingly, the Plan is permitted to rely on the opinion letter, dated March 31, 2017, stating that the 403(b) Plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Related Party and Party-in-Interest Transactions**

Certain Plan investments are investment contracts managed by TFLIC, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers and has an EBA with TRSC.

### **10. Delinquent Participant Contributions**

During the Plan year ended June 30, 2024, participant contributions and loan repayments totaling \$332,622 were not remitted to the Plan within the period prescribed by the Department of Labor (DOL) regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Employer is in the process of correcting these transactions. The related lost earnings are expected to be remitted to the Plan during 2025.
