### 1. DESCRIPTION OF PLAN

**General** --- The following description of the Gramon and Affiliates Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Basic Plan Document and the Adoption Agreement for a more complete description of the Plan's provisions.

The Plan is a tax-exempt defined contribution plan established July 1, 1984, restated on July 1, 2015 and amended September 1, 2016, covering all employees of ELO, Incorporated T/A The Gramon School, the Plan Sponsor (the "Agency"). The Agency is a member of a controlled group, which includes KDDS, Inc. T/A Glenview Academy, KDDS III, Inc. T/A New Beginnings, NB Annex, Inc. T/A New Beginnings Annex, NB Annex II, Inc. T/A New Beginnings Annex II, NB Annex III, Inc. T/A New Beginnings at Emerson, NB Annex IV, Inc., T/A New Beginnings at Memorial Elementary Schools. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Hand Benefit and Trust Company, a BPAS Company ("Hand") serves as the trustee for the Plan.

The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions.

**Eligibility** --- All employees, except union, leased and non-resident aliens with non-US source earned income are eligible to make voluntary salary reduction contributions, including elective deferrals. Employees can enter the Plan immediately following their date of hire.

**Contributions** --- Each year, participants may contribute both pre-tax and/or Roth contributions up to the maximum allowable amount as mandated under the Internal Revenue Code Section 415 or 100% of annual compensation (whichever is less). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in various mutual funds and a stable value fund.

The Agency makes matching contributions in an amount equal to 100% of the participant's contributions up to 3% of the participants compensation. Additionally, the Agency will match 50% of participants contributions in excess of 3% and up to 5% of employee compensation, resulting in a maximum employer match of 4%.

The Agency has the option to provide a discretionary non-elective contribution to the Plan for participants who are employed on the last day of the Plan year and have 800 hours of service. These non-elective contributions are allocated to participants based on the percentage of their compensation to the total compensation of all eligible participants. For the years ended June 30, 2024 and 2023 discretionary contributions were \$0, respectively.

**Investment options** --- Participants may direct the investment of their contributions to the Plan into various investments offered by the Plan. Investment options include mutual funds and a stable value fund, a collective investment trust.

### 1. DESCRIPTION OF PLAN (CONT.)

**Participant accounts** --- Each participant's account is credited with the participant's contributions and Agency matching contributions, as well as allocations of the Agency's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. The amount of investment income a participant's account earns is contingent upon the nature of the investments chosen by the participant. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** --- Participants are fully vested immediately in their contributions plus actual earnings thereon. Vesting in the Agency's contribution portion of their accounts is based on years of continuous service and follows the chart below. Moreover, participants are fully and automatically vested in their accounts after becoming eligible for retirement, incurring a disability prior to termination, or upon death.

**Notes receivable from participants** --- Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum amount that may be borrowed from a qualified plan without being subject to income tax (currently, \$50,000 or, if less, 50% of the value of a participant's non-Roth vested account balance). This amount may be further limited by the provisions of the contract or if participants have other loans under this plan. The loans are secured by the balance in the participant's account and bear interest at the highest prime rate in the "Money Rates" section of The Wall Street Journal on the last business day of the calendar month prior to the loan being initiated. Loans in the plan bear interest at a rate that ranges from 4.25% to 9.50% for the years ended June 30, 2024 and June 30, 2023, respectively. Principal and interest is paid over a five year term by equal payments made at least quarterly. Loans providing payments on principle residences may exceed the five year term and are determined according to the loan document.

**Payments of benefits** --- Normal retirement age to withdraw money is 65 years, but under this plan may be extended to a participant's 5<sup>th</sup> year in the Plan, whichever is earlier. Early retirement is not permitted under the Plan. On termination due to death, disability or retirement, a participant or his or her beneficiary will receive payment equal to the value of the participant's vested interest in his or her account through a lump-sum payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Hardship withdrawals** --- Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts contributed by the employee may be withdrawn for a hardship purpose. A participant may withdraw up to 100% of their elective deferral balance and up to 100% of their vested interest in matching contributions and non-elective contributions accounts to pay for a financial hardship. Terms are specified in the plan document.

### 1. DESCRIPTION OF PLAN (CONT.)

**Forfeited accounts** --- At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$8,319 and \$36,710 respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$36,700 and forfeitures used to offset Plan fees were \$14,210 for from forfeited nonvested accounts. In 2023, there were no forfeiture balances utilized to offset plan expenses or reduce employer contributions.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** --- The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates** --- The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets available for benefit and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** --- Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** --- Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a deemed distribution is recorded. These deemed distributions were included in benefits paid to participants for the years ended June 30, 2024 and 2023 on the statements of changes in net assets available for benefits. Total deemed distributions from participant loans from the trust for the years ended June 30, 2024 and 2023 amounted to \$29,630 and \$48,671, respectively.

**Payments of benefits** --- Benefit payments to participants are recorded upon distribution.

**Expenses** --- Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Agency. Expenses that are paid by the Agency are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net (depreciation) appreciation of fair value of investments.

### 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market prices. Level 1 inputs are considered "observable" inputs.

*Collective investment trusts:* These inputs are "observable for the asset or liability, either directly or indirectly", including quoted prices for similar securities, interest rates, credit risk, etc. that are determined for an asset based on independent market data. These investments have net asset values that are considered published.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. COLLECTIVE INVESTMENT TRUSTS

The Plan offers stable value funds, for which Reliance Trust Company serves as trustee and investment manager. The investments of the collective investment trust may consist of fully benefit-responsive investment contracts, fixed income securities, pooled separate accounts and other low risk securities. While the fund seeks to preserve the account holders principal investment, it is possible to lose money by investing in this fund, as the funds have net asset values that are considered published. Total amounts of collective investment trusts were \$2,773,373 and \$2,651,173 respectively for the years ended June 30, 2024 and 2023.

### 5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Hand is the trustee for the Plan, and, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

Benefit Plan Admin Services, Inc. ("BPAS"), serves as recordkeeper for the Plan and is a branch of Hand. BPAS provided investment advisory services, based on a fiduciary services agreement entered into on August 28, 2018 and updated on November 1, 2019. Reasonable compensation for this arrangement is paid for by the Agency and is not made on the basis of a share of capital gains or capital appreciation of the funds.

### 6. PLAN TERMINATION

Although it has not expressed intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of a Plan termination or if employer contributions are permanently discontinued, the rights of the participants under the Plan will become fully vested and non-forfeitable.

### 6. PLAN TERMINATION (CONT.)

Should the Plan terminate at some future time, the assets of the Plan are to be distributed to the participants, their beneficiaries, or estates, in accordance with the value of the accounts such participants hold as of the date of the termination of the Plan.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 8. TAX STATUS

The Internal Revenue Service ("IRS") has determined by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to tax examinations generally up to three years since its latest filing.

### 9. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Certain information related to investments and disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand (the trustee of the Plan).
