## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**Note 1: Description of the Plan**

The following description of Community Support Services of Missouri 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

***General***

The Plan is a defined contribution plan established by Jasper County Sheltered Facilities Association, Inc. D/B/A Community Support Services of Missouri (the "Organization") for the benefit of eligible employees of the Organization. All employees of the Organization are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

***Plan Administration***

The Plan is administered by Community Support Services of Missouri. The Plan's custodian, Capital Bank and Trust, is responsible for the custody and management of the Plan's assets.

***Contributions***

Participants may contribute up to 100% of their annual compensation limited to the maximum amount allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Each year, the Organization may contribute a discretionary matching contribution. The approved contribution percentage for the years ended June 30, 2024 and 2023 was 3%. The participant contributions and organization matching contributions may be allocated to various mutual funds offered by American Funds as the participant directs.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Organization's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Eligibility***

Employees are eligible to participate in the plan immediately upon their hire date.

***Vesting***

Participants are immediately vested in their voluntary contributions and the Organization contributions plus earnings thereon.

***Payment of Benefits***

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) will automatically be paid a single lump sum payment if the participant's vested account has a balance of \$5,000 or less. If the participant's vested amount has exceeded \$5,000, several installment options are available to the participant, including rollover contributions to another qualified plan. In addition, hardship distributions are permitted if certain criteria are met.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to 50% of their vested account balance not to exceed \$50,000, subject to limitations described in the plan document. A participant is allowed only one outstanding loan at a time. The loans are secured by the participant's vested account balance. The maximum loan repayment period is five years unless the loan is for purchase of a residence, in which case the period may be up to fifteen years. Loans are payable semimonthly through payroll withholdings with a commercially reasonable interest rate equal to prime, as defined by the Plan.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments in mutual funds are stated at fair market value based on quoted market prices. Fair value is the price that would be received if an asset were sold or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024, or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Plan's sponsor or the Plan, at the Plan's sponsor's discretion. All major expenses of maintaining the Plan are paid by the Organization. Minimal fees are charged to participant accounts for contributions and distributions.

**Note 3: Certification of the Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the custodian of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of June 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially adversely affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 5: Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation of methodologies used for assets and liabilities measured at fair value on a recurring basis and recognized in the accompanying statements of financial position, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at June 30, 2024 and 2023. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The mutual funds held by the plan are deemed to be actively traded.

A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The Organization uses appropriate valuation techniques based on the available inputs to measure the fair value of its assets and liabilities. When applicable, the Plan measures fair value using at least Level 2 inputs. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

There were no Level 2 or Level 3 measurement items as of June 30, 2024 and 2023.

**Note 6: Rollover Contributions**

Participants may also contribute amounts to the Plan representing distributions from other qualified plans (rollover contributions). An aggregate of \$0 and \$18,520 was rolled into the Plan during the years ended June 30, 2024 and 2023, respectively.

**Note 7: Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50 percent or more of such an employer, or relatives of such persons.

All of the Plan investments are shares of mutual funds managed by American Funds, the service provider of the Plan's assets as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Plan is established by Community Support Services of Missouri. The Organization provides certain administrative services at no cost to the Plan and pays for certain accounting and other administrative expenses incurred by the Plan.

**Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**Note 9: Plan Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Sections 403(b).

GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). Plan Management has analyzed the tax positions table by the Plan, and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10: Subsequent Events**

Subsequent events have been evaluated through April 13, 2025, which is the date the financial statements were available to be issued.
