Independent Auditor's Report

To the Plan Administrator and Participants
of the Seiler LLP 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Seiler LLP 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of November 22, 2024 (Liquidation basis) and December 31, 2023 (Going concern basis), and the related statement of changes in net assets available for benefits for the period January 1, 2024 to November 22, 2024 (Liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 22, 2024 and December 31, 2023, and for the period January 1, 2024 to November 22, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment

information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation



and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Plan Termination

As further discussed in Note 1, Seiler LLP decided to terminate the Plan effective June 30, 2024 and all plan assets were distributed by November 22, 2024 in accordance with the provisions of ERISA. The Plan changed its basis of accounting from the going concern basis used in presenting the December 31, 2023 financial statements to the liquidation basis used in presenting the November 22, 2024 financial statements. Our opinion is not modified with respect to this matter.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Seiler LLP 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

In 2024, Seiler LLP ("the Partnership" or "Plan Administrator") was acquired by Baker Tilly US, LLP. The Partnership decided to terminate the Plan effective June 30, 2024 and all plan assets were distributed in accordance with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

General - The Plan is a defined contribution plan that was established on January 1, 1990 by the Partnership covering all eligible employees and partners of the Partnership as defined in the Plan agreement. Certain classes of employees and partners as defined in the Plan agreement are excluded from plan participation. The Plan is subject to the provisions of ERISA.

A Plan Committee ("the Committee") managed the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Partnership contracted with Empower Trust Company, LLC to act as custodian, and with Empower Annuity Insurance Company of America (collectively referred to as "Empower") to hold the assets of the Key Guaranteed Portfolio Fund ("KGPF"). Empower Retirement, LLC acted as record-keeper to process and maintain the records of participant data. Certain partners of the Partnership served as plan trustees.

The provisions of SECURE 2.0 Act of 2022 continue the themes and reforms that began with the 2019 SECURE Act. Certain provisions of both Acts have been implemented by the Plan. Participants should refer to plan documents for any changes made to the Plan.

Contributions - Each year, participants could contribute an amount of eligible pre-tax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. The Plan allowed for ROTH deferral contributions. Participants who are age 50 or older could elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants could also contribute amounts representing distributions from other qualified eligible plans.

The Plan allowed for an employer discretionary matching contribution and an employer discretionary nonelective contribution subject to certain eligibility requirements. For the period January 1, 2024 to November 22, 2024 and the year

ended December 31, 2023, the Partnership matched 50% of a participant's deferrals up to 3% of the participant's eligible compensation. The total discretionary matching contribution amount for 2024 was \$692,415 of which \$27,403 was funded by forfeitures. The total discretionary matching contribution amount for 2023 was \$1,203,456 of which \$8,375 was funded by forfeitures and \$194,777 was a receivable as of December 31, 2023 and was paid in 2024. No discretionary nonelective contribution was made for the period January 1, 2024 to November 22, 2024.

Participant Accounts - Each participant's account was credited with the participant's contribution, the partnership's discretionary matching contribution, an allocation of the partnership's discretionary nonelective contribution (if any), plan earnings or losses, and plan expenses as applicable to the Plan. Allocations of the partnership's discretionary nonelective contribution were based on participant compensation. Allocations of plan earnings and losses were based on individual participant investment choices. All contributions/investments were participant directed. The benefit to which a participant is entitled was the benefit that could be provided from the participant's vested account.

Vesting - Participants were 100% vested in their contributions and rollover amounts plus actual earnings thereon. Vesting in the discretionary matching contributions, discretionary nonelective contributions, and earnings was based on years of credited service at the rate of 25% per year and full vesting after four years. Participants became fully vested in the event of death, disability, retirement age, or plan termination. In connection with the Plan termination, participants became 100% vested in their accounts.

Notes Receivable from Participants - Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes were secured by the balance in the participant's account and bear interest at rates which were commensurate with prevailing rates as determined by the Plan Administrator. There was no outstanding notes receivable from participants as of November 22, 2024. Outstanding notes receivable from participants as of December 31, 2023 carry interest rates which range from 4.25% to 9.50%. Principal and interest were paid per the terms of the note and in accordance with plan provisions. The Plan Administrator established the specific terms and conditions of such notes.

Payment of Benefits - Upon the satisfaction of certain distributable events, participants or their beneficiaries could elect to receive their vested account balance and are paid in accordance with plan provisions.

Forfeited Accounts - Forfeited accounts could be used to pay plan expenses, reduce employer contributions, or reallocated to eligible participants.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. In connection with the Plan termination on June 30, 2024 and in accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the going concern basis used in presenting the December 31, 2023 financial statements to the liquidation basis used in presenting the November 22, 2024 financial statements.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investments which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Empower. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Contributions - Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. As of November 22, 2024 and December 31, 2023, there were no excess contributions payable.

Plan Expenses - For the period January 1, 2024 to November 22, 2024, some plan fees were paid by the Partnership and these amounts are excluded from the Plan's financial statements. Investment/fund fees, certain participant transaction fees, quarterly fees and investment advisory fees are paid through the Plan and charged to participant accounts as applicable. Plan audit fees were paid through the forfeiture account. The Plan maintains a Plan Expense Account which is funded by excess revenue credit amounts (fees generated by charging applicable participants). These amounts can be allocated as earnings to participants or used to pay plan expenses. Certain fees were paid by the Plan through the Plan Expense Account.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through December 30, 2024, the date the financial statements were available to be issued.

NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at November 22, 2024 and December 31, 2023, interest, dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the period January 1, 2024 to November 22, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 22, 2024 and December 31, 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their

daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts: The trusts are reported at fair value based on the underlying investments which are actively traded. The NAV of each trust is calculated based on a compilation of primarily observable market information. The number of units of a trust that are outstanding on the calculation date is derived from observable purchases and redemption activity in the trust. The NAV is used as a practical expedient to estimate fair value for these trusts. This practical expedient would not be used if it is determined to be probable that the trusts will sell the investments for an amount different from the reported NAV. For these trusts, there are no unfunded commitments, the units can be redeemed daily, and redemption notice periods are subject to the contracts.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. There were no plan assets as of November 22, 2024.

NOTE 6 - FIXED ACCOUNT

The Plan entered into a fixed annuity contract for the KGPF with Empower which maintains the contributions in a general account. Interest is earned and

compounded daily to the effective annual interest rate as determined by Empower. Because the KGPF is considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the KGPF. The account was liquidated as of November 22, 2024. Contract value approximates fair value as of December 31, 2023.

For the KGPF, there are no unfunded commitments and the units can be redeemed daily. There is a twelve months redemption notice for this fund which can be enforced by Empower. Either party to the Group Annuity Contract may terminate the contract with at least 60 days advance written notice to the other party. Certain events as described in the contract limit the ability of the Plan to transact at contract value with the issuer. The Plan termination did not limit the ability of the Plan to transact at contract value with Empower or with participants. There are no reserves against contract value as of December 31, 2023.

NOTE 7 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments were held by Empower. Any purchases and sales of these investments were performed in the open market at fair value or contract value. Plan related fees were paid to Empower, Empower Retirement, LLC and investment advisory firms. The Plan had other service providers. All these transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8 - TAX STATUS

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated November 14, 2022 from the IRS. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
