**NOTE 1 - PLAN DESCRIPTION AND BASIS OF PRESENTATION**

Willow Run Foods, Inc. (the Company) established the Willow Run Foods, Inc. Employee Stock Ownership Plan (the Plan) effective as of July 2, 1988. The Plan has operated as a leveraged employee stock ownership plan (ESOP) and is designed to comply with an employee stock ownership plan under Sections 401(a) and 4975(e)(7) of the Internal Revenue Code (IRC) of 1986, as well as Section 407(d)(6) of ERISA. The Plan is administered by the committee of ESOP trustees appointed by the Board of Directors of Willow Run Foods, Inc.

The Plan purchased Company common shares using the proceeds of three bank borrowings to Willow Run Foods, Inc., and then loaned on similar terms from the Company to the ESOP. The ESOP holds the stock in a trust established under the Plan. The loans were repaid over their specific terms by fully deductible Company contributions to the trust fund. As the Plan made each payment of principal, an appropriate percentage of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the Code. The borrowings were collateralized by the unallocated shares of stock. The lender had no rights against shares once they were allocated under the ESOP. The Plan completed its last loan obligation and as of June 28, 2013, is operating as a non-leveraged ESOP.

Employees of the Company become eligible to participate in the Plan after six months of service if they worked at least 1,000 hours during such plan year. Participants who do not have at least 1,000 hours of service and six months of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

No distributions from the Plan will be made until a participant retires, becomes disabled, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. All benefits paid under the Plan will be paid in cash. The distribution of benefits attributable to the stock purchased with the Employee Stock Ownership Plan loans will be paid as follows. For shares purchased with proceeds from the 1989 loan, the distribution will be made in five annual installments beginning the year after the end of the plan year in which a participant terminates employment. For shares purchased with the proceeds of the 1993 or 2003 loans, the distribution will start the later of five years after termination or the year after the end of the plan year in which the Plan makes the final loan payment. In the case of death, disability or normal retirement, the distributions will be made in five annual installments beginning the year after the end of the plan year in which the participant terminates employment without reference to the loan status of any allocations. For stock allocated from discretionary contributions not connected to any loan (reissued treasury stock), distributions will be made in five annual installments beginning the year after the end of the plan year in which the participant terminates employment.

The Company reserves the right to terminate the Plan at any time by action of the board of directors. If the Plan is terminated, all participants will automatically become fully vested in their account balances as of the date of termination. Upon such termination of the Plan, the interest of each participant in the Plan will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

**NOTE 1 - PLAN DESCRIPTION AND BASIS OF PRESENTATION (Continued)**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock from the current year amounts repurchased and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation.

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on date of hire and total years of service with the Company. Participants hired prior to July 1, 1995 vest 20% per year of service and are 100% vested after five years of service. Participants hired after June 30, 1995, with no hours of service after June 28, 2013, vest 20% after three years of service and 20% each subsequent year of service; they are 100% vested after seven years of service. Participants hired after June 30, 1995, with an hour of service on or after June 28, 2013, vest 20% after two years of service and 20% each subsequent year of service; they are 100% vested after six years of service.

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. Each qualified participant may elect to transfer up to 25% of his or her account balance in each of the first five years of this period. In the final year, the qualified participant may transfer up to 50% of his or her account balance. These elections must be made within ninety days after the close of each plan year.

Each participant is entitled to exercise voting rights if the value of employer securities constitutes more than ten percent of the assets of the Trust. The participant will be entitled to vote the shares allocated to their account with respect to any merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets, which must be approved by the shareholders of the Company. With respect to these matters, the Trustees will vote any shares that are not voted by participants. On all other matters requiring a vote of the shareholders, the Trustees will direct the vote of any shares held by the Trust.

As of June 28, 2024 and June 30, 2023, forfeited, non-vested accounts totaled \$349,497 and \$435,836, respectively. These accounts were reallocated to participants during the year forfeited in the same manner as employer contributions.

Administrative costs of the Plan are paid by the Company.

For a more complete description of relevant plan features, reference should be made to the Summary Plan Description published by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Investment Valuation and Income Recognition** - The common shares of the Company are valued at fair market value. See Note 7 for discussion of fair value measurement.

**Use of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties** - The Plan's investment consists of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Subsequent Events** - The Plan has evaluated subsequent events through April 15, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - TAX STATUS**

The Plan obtained its latest determination letter on September 16, 2013, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Therefore, the related trust is exempt from taxation. Although the Plan has been amended since the Plan document was submitted to the IRS for review, the Plan trustees and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date. See Note 9 for disclosure of contingency related to tax status.

**NOTE 4 - ADMINISTRATION OF PLAN ASSETS**

The Plan's assets, which consist of Willow Run Foods, Inc. common stock, are administered by the Trustees of the Plan.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 28, 2024 and June 30, 2023.

The Willow Run Foods, Inc. common stock held by the Plan is reported at fair value based upon an independent appraisal. This appraisal considers a combination of the asset, market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity market comparable and the fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. These approaches yield various conclusions and require the appraiser to exercise judgment, either by weighing these values or deciding one value over the other is the appropriate fair value. For the year ended June 28, 2024, the appraiser determined that the asset approach yielded the appropriate fair value as illustrated in the following table.

The valuation process involves the selection of an appraiser. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of per share value that a participant will receive upon distribution. Willow Run Foods, Inc.'s President, CFO, and Board of Directors review and approve the appraisal. The CFO verifies the data used in the methodology to reach the appraisal value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in the Company's common stock. This is a related party and party-in-interest transaction. The Plan also utilizes certain service providers. Such parties are parties-in-interest under ERISA.

**NOTE 9 - CONTINGENCY RELATED TO TAX STATUS**

During the year ended June 24, 2022, incorrect distribution payments to participants were made which were in violation of the Plan provisions. Plan distributions were calculated incorrectly by the Plan's third-party administrator and plan distributions were issued to select participants by the Plan Sponsor based on the incorrectly calculated distribution amounts. As a result, numerous but select participants received plan distribution payments in excess of the amounts they were due, which violated the rules within the Plan provisions. The total of the excess distribution payments made to these select participants amounted to \$248,386 as of June 24, 2022. During the years ended June 28, 2024 and June 30, 2023, adjustments to participant distributions were made to correct a portion of the prior year errors. The total remaining balance of advance distribution payments amounted to \$61,400 and \$112,676 as of June 28, 2024 and June 30, 2023, respectively. The Plan trustees expect to continue to reduce future plan distributions to these select individual participants who received excess distribution amounts during the year ended June 24, 2022, in order to totally recoup the excess distribution amounts paid. The Plan trustees and Plan's tax counsel believe that this method of self-correction will adequately address the Plan violation, and strongly feel the Internal Revenue Service will not disqualify the Plan due to these incorrect distribution amounts.
