Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Main Brothers Oil Company, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The Main Brothers Oil Company, Inc. 401(k) Plan (Plan) was established effective January 1, 1995. The Plan is sponsored by Main Brothers Oil Company, Inc. (Company). The Plan was most recently restated effective February 18, 2022.

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan assets are held by Principal Financial Group, the Custodian of the Plan. Company contributions, participant elective deferrals, and participant accounts are held by the Custodian, which invests cash received and income from investments based on instructions from the Company and participants and makes distributions to participants.

The Plan Trustees are responsible for the oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

b. Contributions

Each year, participants may contribute a percentage or fixed dollar amount of their pre-tax annual compensation to the Plan, subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). In addition, participants may contribute after-tax Roth elective contributions to the Plan. The maximum participant deferral limits are based on a calendar year and were \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have reached age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Auto-enrollment deferral rates are increased each year by 1% until the participant's deferral rate reaches 7%.

Each year, the Company may elect to make a discretionary matching contribution to the Plan. The discretionary matching contribution for both years ended June 30, 2024 and 2023 was 25% of a participant's contribution, up to a maximum employer contribution of \$1,000. Discretionary profit sharing contributions may also be made at the option of the Company's Board of Directors and is allocated in the same ratio as each participant's eligible compensation bears to the total of eligible compensation of all participants for the year. There were no discretionary profit sharing contributions made for the years ended June 30, 2024 or 2023.

Participants direct the investment of their contributions, as well as Company contributions, into various investment options offered by the Plan. Participants may change their rate of contribution at any time effective with the first eligible payroll after the request is received.

c. Plan Eligibility

In general, employees are eligible to participate in the Plan with respect to elective deferral contributions, discretionary matching contributions, and discretionary profit sharing contributions after reaching age 21 and completing two months of service. After eligibility requirements are met, the participants may enter the Plan on the first day of the following month. Participants must be employed on the last day of the Plan year or must have completed 500 hours of service during the Plan year to be eligible to receive the Company's discretionary profit sharing contributions. Participants who are not actively employed due to death, total and permanent disability, or normal retirement, but otherwise meet the eligibility requirements, will share in the Company's discretionary profit sharing contributions, if any.

d. Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, if any, as well as allocations of the Plan's investment earnings, net of investment expenses, and administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account.

e. Vesting

Participants are 100% vested immediately in their contributions and rollover contributions, plus actual earnings thereon. A participant is fully vested upon termination of service due to death, normal retirement at age 65, disability, or Plan termination. A participant's vested interest in the Company's discretionary matching and profit sharing contributions is determined by the number of years of credited service as follows:

f. Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. In addition, the \$50,000 limit is reduced by the highest outstanding loan balance of any loans made in the previous 12 months. Participant notes are secured by the vested balance in the participants' accounts and bear interest at a rate commensurate with the local prevailing rates. Principal and interest are paid ratably through regular payroll deductions. In general, loans must be repaid within five years.

g. Payment of Benefits

Upon death, disability, reaching the normal retirement age, or termination of service, a participant (or their beneficiary upon death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. If the vested portion of a participant's account balance is less than \$5,000, but greater than \$1,000, and the distribution takes place before the participant's normal retirement age, the amount will be distributed to the participant's Individual Retirement Account for their benefit as soon as possible following termination or disability, or to the beneficiary following death. If the value of a participant's vested interest in their account is less than \$1,000, a lump-sum distribution will be made to the participant as soon as administratively feasible following termination, disability or retirement, or to the beneficiary following death.

Prior to termination, a participant may receive a distribution in the event of undue financial hardship, subject to the provisions of the Plan. The Plan also provides for in-service distributions for participants who have reached age 59½, subject to the provisions of the Plan.

h. Forfeiture Accounts

The nonvested portion of terminated participants' accounts, as defined by the Plan, represents a forfeiture. Forfeitures may be used first to pay administrative expenses and then to reduce employer contributions. The Company used approximately \$7,700 of forfeitures to reduce employer contributions during the year ended June 30, 2024. There were no forfeitures used during the year ended June 30, 2023. There were no unallocated forfeitures as of June 30, 2024. There were approximately \$9,100 of unallocated forfeitures as of June 30, 2023.

Note 2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for defined contribution plans.

b. Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants on the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and the Custodian.

c. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

d. Participant Notes Receivable

Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Loans treated as distributions totaled \$4,575 and \$30,809 for the years ended June 30, 2024 and 2023, respectively.

e. Payment of Benefits

Benefits are recorded when paid.

f. Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan and the Company. Fees related to the administration of participant notes receivable from participants are charged directly to the participant's account and included in administrative expenses. Other administrative expenses paid by the Plan are allocated proportionately to participants based on the value of their account balances. Investment-related expenses are included in net appreciation in fair value of investments.

g. Subsequent Events

The Plan has evaluated subsequent events for potential recognition or disclosure through April 10, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on participant notes receivable for the years then ended, was obtained by management and agreed to, or derived from, information certified as complete and accurate by the Custodian of the Plan.

Note 4. Investments and Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 or 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds are deemed to be actively traded.

Note 5. Group Annuity Contract

The Plan has a group annuity contract with Principal Life Insurance Company (Principal Life). This contract meets the fully benefit-responsive contract criteria and, therefore, is reported at contract value. As described in Note 2, contract value is the relevant measure attribute for fully benefit-responsive contracts because that is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses.

Principal Life maintains the contributions in a general account. Principal Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Principal Life, which is reviewed on a semiannual basis for resetting. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and
4. A material amendment to the Plan without the consent of the issuer.

Upon contract termination, at the Plan's direction, payment may be made in one lump sum according to contract provisions or in annual installment payments.

Note 6. Related-Party and Party-in-Interest Transactions

Administrative expenses paid by the Company on behalf of the Plan totaled approximately \$15,600 and \$15,900 for the years ended June 30, 2024 and 2023, respectively.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation for such functions from the Plan.

Certain Plan investments are managed by Principal Financial Group, the Custodian of the Plan.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, participants will become 100% vested in their accounts, and the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

Note 8. Tax Status

The Plan and the trust established under the Plan are qualified under the appropriate section of the IRC and intend to continue as a qualified plan and tax-exempt trust. The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan, as designed, is qualified and the trust established under the Plan is tax-exempt under the appropriate section(s) of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Company has engaged Principal Financial Group to perform the compliance testing. The Plan has not yet received the results of the compliance testing for the years ended June 30, 2024 or 2023. The Company has evaluated the effect that any potential noncompliance would have on the financial statements and determined that it is immaterial.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more likely than not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. These securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
