Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Employee Benefit Plan of The Arc Middlesex County, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion



The Employee Benefit Plan of The Arc Middlesex County, Inc. (Plan) is administered by The Arc Middlesex County, Inc. ("Organization" or "Plan Sponsor"). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Document and Plan Document, both of which are available from the Organization.

General

The Plan is a voluntary, participant-directed, defined-contribution savings plan, which became effective November 1, 1988. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All employees of the Organization, excluding nonresident aliens with no U.S. source of income, independent contractors, leased employees, and employees under age 21, are eligible to participate in the Plan. Participants can make elective contribution deferrals and receive employer-based contributions after completing one year and at least 1,000 hours of service. Participants can enter the Plan on the first day of the month following the month eligibility requirements are met.

Employee Contributions

Each Plan Year, participants may make voluntary pretax and Roth 401(k) contributions to the Plan up to 100% of eligible compensation, up to the annual Internal Revenue Service (IRS) dollar limit. Participants who are age 50 or older at the end of the calendar year may make an additional pretax contribution subject to IRS limitations. Participants may elect to change their deferral percentage daily. The Plan accepts rollover contributions from qualified plans. The Plan has an automatic enrollment and automatic deferral election feature. Under the automatic enrollment option, an employee who meets the eligibility requirements will be automatically enrolled as a participant with an election to contribute 1% of their compensation to the Plan, unless there is an affirmative decline of enrollment.

Employer Contributions

The Organization makes an ADP safe harbor contributions to the Plan equal to 3% of the eligible employees' taxable earnings and ACP safe harbor matching contributions equal to 100% of an employee's elective deferral contributions, up to 2% of eligible compensation for the Plan year. The Organization made employer safe harbor contributions of \$330,665 and \$334,096 for the Plan years ended June 30, 2024, and 2023, respectively.

Employer Profit-Sharing Contributions

The Organization may elect to contribute a profit-sharing contribution on behalf of each eligible participant each Plan year, based on an allocation of each employee's eligible compensation. There were no profit-sharing contributions for the Plan years ended June 30, 2024 and 2023.

Investment Options

Upon enrollment in the Plan, participants may direct their employee and employer contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Organization's contribution; Plan earnings, gains or losses; and is charged with an allocation of administrative expenses. Allocations are based on a participant's compensation or account balances, as defined in the Plan Document.

The Plan permits participants to self-direct the investments of their accounts in a variety of investment options. All participants have elected to self-direct their accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elected contributions, rollover contributions, ADP safe harbor contributions, and qualified nonelective contributions, plus actual earnings thereon. A participant's vested interest in their account balance of profit-sharing contributions and ACP safe harbor matching contributions is based on years of service as defined by the Plan. A participant is 100% vested after reaching age 55; termination by reason of death, or total and permanent disability before their vested retirement age; or after 3 years of credited service as follows:

<u>Years of Vesting Service</u>	<u>Percentage</u>
Less than 3 Years	0%
3 Years or More	100%

Notes Receivable from Participants

Plan participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest loan balance in the participant's account during the preceding twelve-month period. Participants may have up to 2 loans outstanding at any given time. Interest rates on new loans bear interest at the prime rate. The interest rate will remain fixed throughout the duration of the loan. Loans are repaid in installments of principal and interest for terms up to 5 years, paid ratably through biweekly payroll deductions. However, a loan used to acquire a principal residence for a participant may be repaid over a period not to exceed 30 years. If a participant is terminated prior to repayment of the loan balance, the remaining balance on the loan is considered to be a deemed distribution to the participant.

Notes Receivable from Participants (Continued)

A participant's vested account balance will be considered by the Plan as security for the outstanding loan balances of all Plan loans made to that participant. There is no penalty for early repayment of loan balances.

Payment of Benefits

After retirement, death, or disability, participants are entitled to receive a lump-sum distribution. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as the later of April 1st following the calendar year of attaining the age 72, or 73 effective January 1, 2023. Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account (IRA), or distributed through a lump-sum payment, partial payments, a monthly life annuity or joint-and-survivor annuity, or through installment payments for a certain dollar amount. If the vested balance is \$5,000 or less, a cash out with occur without consent. If the vested balance is \$1,000 or less, the participant will receive a lump-sum distribution.

Hardship withdrawals are subject to approval by the Plan Administrator and also subject to income tax withholding and penalties.

In-Service Withdrawals

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account.

Retirement

The Plan's normal retirement age is 65. The Plan allows for early retirement age of 55 and completion of 3 years of vesting service.

Forfeitures and Suspense

Forfeitures and suspense accounts are used to pay Plan expenses first. Any amount of forfeitures remaining will be used to offset any contribution the Plan Sponsor may make. For years ended June 30, 2024 and 2023, \$1,250 and \$3,322, of forfeitures were used to pay Plan expenses, respectively. At June 30, 2024, \$48 and \$36, respectively, remained available in the forfeiture account. For the years ended June 30, 2024 and 2023, \$0 and \$65, of suspense were used to pay Plan expenses, respectively. At June 30, 2024 and 2023, \$7,664 and \$7,185, respectively, remained available in the suspense account.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. Delinquent participant loans are recorded as distributions in accordance with the provisions of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Organization, as provided by the Plan document. Expenses paid directly by the Organization are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value investments.

Subsequent Events

The Plan has evaluated subsequent events through March 26, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Ascensus, LLC (an affiliate of Ascensus Trust Company), as authorized agent for Ascensus Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of June 30, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability, and
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

Money Market Fund – Valued at the closing price reported on the active market on which individual securities are traded (Level 1 input).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by Ascensus, LLC, the authorized agent for Ascensus Trust Company, Trustee of the Plan and The Vanguard Group, record-keeper, and therefore, those transactions qualify as party-in-interest transactions. Notes receivable from Plan participants qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, or partially terminated, the total value of the participants' accounts will be fully vested.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
