Trustees and Participants A Second Chance, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of A Second Chance, Inc. Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. 1. Plan Description

The following description of A Second Chance, Inc. Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, sponsored by A Second Chance, Inc. (Agency), in accordance with Section 401(k) of the Internal Revenue Code (IRC). Participation in the Plan is automatic for all employees who have completed at least one year of service, as defined by the Plan, and attained the age of 21. Participation begins on the first day of the month after which the employee meets the participation criteria.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The accompanying financial statements include only the activity and financial position of the Plan and are not intended to reflect the Agency as a whole.

Employer Contributions

The Agency may provide a discretionary contribution as determined by the Agency's Board of Directors during each Plan year. Discretionary contributions totaled \$353,087 and \$163,000 for the years ended June 30, 2024 and 2023, respectively, and are reported as employer contribution receivable on the statements of net assets for benefits. Participants are only permitted to make rollover contributions into the Plan.

Investment Options

All contributions, including the employer contributions, may be directed at the discretion of each participant into the various investment options offered by the Plan.

Participant Accounts

The plan administrator maintains separate accounts for each participant. Each participant's account is credited with participant rollover contributions, earnings on their account investments, and an allocation of the Agency's contribution and forfeitures of terminated

participants' nonvested accounts. Participant accounts are decreased by any account distributions, as well as certain expenses that are directly attributable to the participant. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan does not permit participants to borrow from their accounts.

Vesting and Forfeitures

Participants are immediately vested in their rollover contributions and actual earnings thereon. Participants become fully vested in employer contributions following the third year of service. Participants must work 1,000 hours in the first year to become eligible, and work 500 hours in two additional years to become fully vested in the Agency's contributions and actual earnings thereon.

Nonvested accounts are forfeited upon participants' terminations. Forfeited amounts may be used to pay administrative expenses or to reduce employer contributions. Forfeitures used to pay administrative expenses and reduce employer contributions were approximately \$9,071 and \$5,881, respectively, for the year ended June 30, 2024. Forfeitures used to pay administrative expenses and reduce employer contributions were approximately \$10,500 and \$0, respectively, for the year ended June 30, 2023. The total amount of forfeited accounts was \$8,730 and \$5,860 as of June 30, 2024 and 2023, respectively.

Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may receive, upon request, a lump-sum distribution equal to the value of the participant's vested interest in his or her account or a life annuity. If the participant's account balance is less than \$1,000, the Agency may make a lump-sum payment without the participant's consent.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

Fair values for Level 1 investments are determined by reference to unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access. Fair values for Level 2 investments are determined by reference to quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Pooled separate accounts are valued using the net asset value (NAV) of the fund shares, which is calculated based on the valuation of the funds' underlying investments at fair value

at the end of the year. The investments are public investment vehicles, which are valued using the NAV provided by the trustee, acting as the administrator of the funds. The NAV is based on the value of the underlying assets owned by the fund, excluding transaction costs, minus its liabilities, and then divided by the number of shares outstanding. Units can be redeemed daily for the purpose of funding benefit payments or paying trustee fees. There were no unfunded commitments as of June 30, 2024 and 2023. As further discussed in Note 3, the pooled separate accounts have not been classified within the fair value hierarchy.

For the guaranteed investment contracts, fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination, or retirement. There is a possible surrender charge when funds are withdrawn prior to their maturity, thus the guaranteed investment contracts are considered non-benefit responsive. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates. The guaranteed investment contracts are classified within Level 3 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The cost of investments sold, distributed, or forfeited is determined using the specific identification method. Investment purchases and sales are accounted for on a trade-date basis. Interest and dividend income is recorded when earned.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments are recorded when paid. There were no significant benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of June 30, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Agency and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of investments. Fees related to the administration of member requested services are charged directly to the participant's account and are included as administrative expenses.

Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

The Plan maintains investment contracts with Principal Life Insurance Company (Principal). Principal maintains the contributions in guaranteed investment contracts. The guaranteed investment contracts are reflected in the financial statements at fair value, as they are non-benefit responsive. The interest rates ranged from 0.87% to 5.66% for 2024, and from 0.10% to 3.71% for 2023. The average interest rate for 2024 and 2023 was 3.06% and 1.46%, respectively. The interest rate is guaranteed for one year, with a new rate being

declared by Principal at the beginning of each Plan year. There were no material purchases or transfers during 2024 or 2023.

4. Certification of Financial Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, the custodian of the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

6. Tax Status

The Plan is a non-standardized prototype plan of Principal. Principal obtained a letter dated June 30, 2020, in which the Internal Revenue Service stated its opinion that the form of the prototype plan of Principal is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has been amended since receiving the determination letter. However, the plan administrator, the trustee, and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. In addition, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax

positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

7. Related Party Transactions and Party-in-Interest Transactions

Principal manages and is the contract holder of the Plan's pooled separate accounts and guaranteed investment contracts and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative and participant-directed services were not significant for the years ended June 30, 2024 and 2023.

8. Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near-term could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
