Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Apalachee Center, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Apalachee Center, Inc. Retirement Plan (“the Plan”) provides only general information as amended. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Apalachee Center, Inc. ("the Employer") who have completed 1,000 service hours within a 12 month measurement period and are age 18 or older. The Plan was established July 1, 1975 as a money purchase pension plan and was subsequently amended effective November 2, 1998 and January 1, 2002. Effective January 18, 2007, the Apalachee Center, Inc. Pension Plan and Trust Agreement was frozen and merged into the Apalachee Center, Inc. Retirement Plan, a profit sharing plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s investment assets were under the trustee responsibility of Branch Banking and Trust Company (BB&T). Effective March 1, 2021, the Plan’s investment assets were transferred under the trustee responsibility of Ascensus Trust Company (Ascensus), and the Plan was amended and restated effective May 1, 2021.

Contributions - Contributions to the Plan are discretionary. For the years ended June 30, 2024 and 2023, the Employer contributed 6% of compensation for each participant to the Retirement Plan. The Employer also makes discretionary matching contributions of employee elective deferrals to a 403(b)7 plan. For the years ended June 30, 2024 and 2023, the Employer did not make matching contributions.

Participant Accounts - Each participant has a separate Directed Investment Account which is credited with the employer's contributions. The Directed Investment Account is also charged or credited, as appropriate, with the net earnings, gains, losses and expenses, as well as appreciations or depreciations in market value during each Plan year attributable to such account. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account. Benefits are recorded when paid.

Vesting - Employer contributions are 20% vested when the participant attains two years of service and increase at a rate of 20% per year thereafter until they are fully vested after six years of service.

Distribution of Benefits to Participants - On termination of employment, death and/or total disability, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account, or payment in monthly, quarterly, or annual cash installments over a period not to exceed the participant's life expectancy or the joint life expectancy of the participant and the designated beneficiary.

NOTE 1 – DESCRIPTION OF PLAN (continued)

Forfeited Accounts - The Plan utilizes forfeited account balances to first reduce the employer's administrative expenses and secondly to reduce the employer's contribution. For the years ended June 30, 2024 and 2023, administrative expenses and employer contributions were reduced by \$273,169 and \$89,622, respectively, from forfeited non-vested accounts.

Administration of Plan Assets - Trustee fees are paid from forfeited non-vested participant accounts. In the event that forfeitures are not sufficient, the fees are paid directly by the Employer. For the years ended June 30, 2024 and 2023, trustee fees paid from forfeitures were \$70,270 and \$24,850, respectively. No trustee fees were paid directly by the Employer. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

Plan Termination - Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Reclassification – Certain prior year amounts have been reclassified to conform to current year presentation.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The purpose of the Plan is to accumulate Employer contributions and earnings on Plan assets for the payment of benefits to participants. Significant accounting policies of the Plan are as follows:

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments - Investments of the Plan are stated at fair value as reported by the trustee, Ascensus, at June 30, 2024 and 2023, respectively (See Note 1). Any change in unrealized appreciation or market loss is fully recorded as income or loss in the year of change. See Note 3 for discussion of fair value measurements.

The Plan invests in various mutual funds comprised of investment securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Plan Benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Net Appreciation (Depreciation) – Net appreciation (depreciation) in fair value of investments includes both realized gains and losses on dispositions of investments and unrealized gains and losses reflecting adjustments to fair value.

Payment of Benefits – Benefits are recorded when paid.

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3 - INVESTMENTS AND FAIR VALUE MEASUREMENTS

Plan contributions were invested in various retirement investment accounts for the fiscal years ended June 30, 2024 and 2023.

All information on Plan investment assets and related investment income transactions has been prepared and certified as both complete and accurate by Ascensus as trustee.

Fair Value Measurement and Disclosures Topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Fair Value Measurement and Disclosures Topic are described as follows:

- Level 1:* Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2:* Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.
- Level 3:* Inputs that are unobservable inputs for the asset or liability. Unobservable inputs are those that reflect the plan's own assumptions about the assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: The Morley Stable Value Fund, Resources Divers Risk Mitigation, Resources Diversified Equity, and Resources Diversified Fixed are funds valued at the net asset value of units of the funds collective trusts. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust(s), the issuer reserves the right to require a 12 month advance notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 4 – PARTICIPANT DIRECTED ACCOUNTS

Each participant has the ability to direct the investment of his or her account balance under the Plan. Participants who make no active investment election will default to having personalized portfolios managed by OneDigital for a fee. Such fees are deducted from the participant's account on a quarterly basis. OneDigital management fees for the years ended June 30, 2024 and 2023 were \$31,986 and \$30,709, respectively. To the extent participants and beneficiaries direct investments under the Plan, ERISA relieves trustees from liability for any loss resulting from such direction.

NOTE 5 – PARTIES-IN-INTEREST

During each of the Plan years ended June 30, 2024 and 2023, the Plan Sponsor absorbed the following fees:

These expenses are not included in the Statements of Changes in Net Assets Available for Plan Benefits, as they have been absorbed by the Employer.

NOTE 6 - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) made a favorable determination of the Plan and stated that the Plan, as then designed, is in compliance with the applicable requirements of the *Internal Revenue Code*. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the U.S. require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities. There are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2020.

NOTE 7 - EVALUATION OF SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through April 10, 2025, the date which the financial statements were available to be issued.
