Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mainstream Living, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mainstream Living, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the Mainstream Living, Inc. (“Organization”) 403(b) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General: The Plan is a defined contribution Plan covering substantially all full-time employees of the Organization. Employees are immediately eligible for participation, however an employee must have worked at least 12 months to be eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Trustees oversees governance of the Plan.

Contributions: The Plan provides for the following types of payments to be made to the Plan:

Participant salary deferred contributions: Employees who are eligible in this plan may elect to contribute a share of their compensation as defined in the Plan, up to the maximum amounts allowed by ERISA and the Internal Revenue Code. Employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Code. Participants may also designate all or a portion of their elective deferral as a Roth elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Organization matching contributions: The Plan provides that the Organization make a matching contribution as follows: employees with more than one but less than two years of service will receive a matching contribution equal to 100% of their salary deferrals up to 1% of eligible compensation; employees with more than two but less than three years of service will receive a matching contribution equal to 100% of their salary deferrals up to 2% of eligible compensation; employees with more than three but less than four years of service will receive a matching contribution equal to 100% of their salary deferrals up to 3% of eligible compensation; employees with more than four but less than five years of service will receive a matching contribution equal to 100% of their salary deferrals up to 4% of eligible compensation; employees with more than five but less than 10 years of service will receive a matching contribution equal to 100% of their salary deferrals up to 5% of eligible compensation; employees with more than 10 but less than 15 years of service will receive a matching contribution equal to 100% of their salary deferrals up to 6% of eligible compensation; employees with more than 15 years of service will receive a matching contribution equal to 100% of their salary deferrals up to 7% of eligible compensation. The matching contribution is paid each pay period by the Organization into the Plan.

Participants’ accounts: Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the Organization’s contributions, and charged with an allocation of administrative expenses. Allocations of income and expenses are based on the proportion that each participant’s account balance bears to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: The participant's salary deferral contributions and matching Organization contributions plus earnings thereon are fully vested immediately.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description (Continued)

Payment of benefits On retirement, death, disability, termination of service, or attainment of the age 59 ½, a participant (or participant’s beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant’s vested account balance, installment payments, or Ad-Hoc distributions, if the vested account balance is greater than \$5,000. If a participant’s vested account balance is less than \$1,000, the balance will be automatically distributed in cash. In addition, hardship distributions are permitted if certain criteria are met.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum 50% of their account balances not to exceed \$50,000. Two outstanding notes receivable are permitted at any time and the note receivable repayment schedule can be no longer than 60 months unless it is used for the purpose of a principal residence. Principal and interest is paid ratably through payroll deductions. The loan interest rate is determined by the Plan Sponsor’s management and shall be charged based on rates currently being used by financial institutions lending money under similar circumstances. The notes receivable are secured by the balance in the participant’s account.

Forfeited accounts: Forfeited balances of terminated participant accounts are used to pay Plan administrative fees or reduce Organization contributions. At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$989 and \$907, respectively. No forfeitures were used to reduce administrative expenses or Organization matching contributions during the year ended June 30, 2024.

Note 2. Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTES TO FINANCIAL STATEMENTS

Note 2. Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Plan fees and expenses, including fees and expenses connected with the providing of administrative services by external service providers are paid by either the Plan or the Organization, as provided by the Plan document. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's accounts. Investment related expenses are included in net appreciation of fair value of investments.

Excess contributions payable: Amounts payable to participants totaling \$0 and \$5,888 at June 30, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recoded as accounts payable, with a corresponding reduction to contributions.

Subsequent events: Subsequent events have been evaluated through April 8, 2025, which is the date the financial statements were available to be issued. Events occurring after that date have not been evaluated to determine whether a change in the financial statements would be required.

Note 3. Certification of Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group and Ascensus Trust Company, qualified institutions, have certified the following information in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024.
- Investment information included in the accompanying schedule of assets (held at end of year) as of June 30, 2024.

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTES TO FINANCIAL STATEMENTS

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Codification Topic 820, Fair Value Measurement, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

The Plan contracts with Lincoln Financial Group Trust Company, to serve as its custodian. The Plan also invests a portion of its assets in funds maintained by Lincoln Financial Group Trust Company and, therefore, these transactions qualify as party-in-interest transactions. For such responsibilities, Lincoln Financial Group Trust Company receives fees at customary and reasonable rates as provided in the Plan. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Fees paid directly to Lincoln Financial Group Trust Company for investment management incurred by the Plan totaled \$325 for the year ended June 30, 2024. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7. Tax Status

The Organization adopted a volume submitter 403(b) plan, which received a letter from the IRS dated January 1, 2018, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and related trust is tax-exempt.

NOTES TO FINANCIAL STATEMENTS

Note 7. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there have been no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
