### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Defined Contribution Pension Plan for Employees of A Very Special Place, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institution as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

### 1. Description of the Plan

The following description of Defined Contribution Pension Plan for Employees of A Very Special Place, Inc., also known as A Very Special Place, Inc. Pension Plan, (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan available to substantially all employees of A Very Special Place, Inc. (the Employer or AVSP) who are at least 21 years of age and have completed one year and at least 1,000 hours of service. Non-resident aliens, leased employees, and self-directed employees, as defined, are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Plan Administration*

Mutual of America Life Insurance Company (MOALIC) holds the assets of the Plan, and also serves as investment advisor and recordkeeper. AVSP, as the Plan administrator, controls and manages the operation and administration of the Plan.

#### *Contributions*

Under the terms of the Plan, the Employer shall make monthly contributions equal to 5% of the total compensation, as defined, of all eligible participants. No employee contributions are permitted.

#### *Participant Accounts*

Each participant's account is credited with the applicable portion of the Employer's contributions and allocations of investment earnings (losses), which are reduced by applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a vested participant is entitled is the value of the participant's account.

#### *Investment Options*

Participants may direct Employer contributions into any of the eligible funds of MOALIC and designate, for the contributions remitted on their behalf, the percentage of the contribution that is to be allocated to the interest accumulation account and any of the separate accounts.

#### *Vesting*

Participants become fully vested in the Plan upon completion of three years of service, upon attaining age 55, in the event of death or upon partial or full termination.

### ***Benefit Payments***

The Plan provides for normal retirement at age 65, or early retirement at age 55. The Plan permits distributions to participants upon termination of service, disability, or death. Distributions of benefits to participants will be made in the form of an annuity, unless a participant specifically elects to receive a single lump-sum payment.

### ***Forfeitures***

Forfeitures resulting from the nonvested portions of participants' accounts, who terminate prior to being fully vested, will be used first to pay certain plan expenses. Any amount of forfeitures remaining will be reallocated to the accounts of currently active participants in the Plan on the last day of the plan year in addition to any contribution AVSP makes. The balance in the forfeiture account as of June 30, 2024 and 2023 was \$49,318 and \$26,574, respectively. For the years ended June 30, 2024 and 2023, amounts forfeited totaled \$21,851 and \$13, respectively. There were no amounts used to pay Plan expenses or reallocated to participant accounts for the years ended June 30, 2024 and 2023.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements were prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments, consists of realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

### ***Contributions Receivable***

Employer contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of June 30, 2024 and 2023, and net appreciation in fair value of investments and interest income for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by MOALIC, a qualified institution.

### **4. Fair Value Measurements**

Accounting Standard Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

*Pooled Separate Accounts* - These assets are valued at their accumulation unit value (AUV), which approximates fair value. The AUV is used as a practical expedient and is determined daily based on the net asset value of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods, and no unfunded commitments. The pooled separate accounts invest in various registered investment companies (mutual funds), including target date funds, equity funds, fixed-income funds, money market funds, and real estate investment funds.

The investments in pooled separate accounts, which are valued at AUV as a practical expedient, are not required to be and have not been classified in the fair value hierarchy.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis as of June 30, 2024 and 2023.

### **5. Fully Benefit-Responsive Guaranteed Investment Contract**

The Plan entered into a fully benefit-responsive guaranteed investment contract with MOALIC. MOALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by MOALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (4) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract and settle at an amount different from contract value, such as a breach of material obligation under the contract.

### 6. Tax Status

The Plan uses a pre-approved plan document sponsored by Mutual of America Financial Group (MOAFG). MOAFG received an opinion letter from the Internal Revenue Service (IRS), dated November 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 8. Related Party and Party-in-Interest Transactions

Plan investments are units of a general account and pooled separate accounts managed by MOALIC, the custodian and recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Additionally, certain employees of the Employer, who are also participants in the Plan, perform administrative services for the Plan at no cost.

### 9. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant will become 100% vested and the net assets of the Plan will be distributed, as prescribed by ERISA.

### 10. Subsequent Events

Plan management has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring adjustment to the financial statements.
