### (1) Description Of The Plan

The following description of Magic City Enterprises 403(b) Plan (the “Plan”), provides only general information. Participants and all others should refer to the Plan Document for more complete description of the plan’s provisions.

#### General

The Plan is a defined contribution plan covering substantially all full time employees of Magic City Enterprises (the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Magic City Enterprises is the plan sponsor and plan administrator.

#### CARES Act

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was signed into law. The CARES Act allows retirement plans to provide participants who are impacted by the coronavirus (as defined in the CARES Act) with greater access to their savings.

Through June 30, 2021, qualified individuals are permitted to take a distribution in an amount up to \$100,000 from the Plan. Any such distributions are not subject to the 10% early distribution penalty or the mandatory 20% federal income tax withholding rate. Participants who take a qualified distribution have the option to have the distribution taxed over a three-year period, with the ability to retribute up to the full amount of the distribution within three years and not be subject to the federal income tax as a result.

#### Contributions

Each participant may elect to reduce his or her compensation and have such amounts contributed to the Plan as pre-tax contributions. Pre-tax contributions are excluded from a participant’s taxable compensation in accordance with the provisions of the Internal Revenue Code (IRC).

The IRC imposes certain restrictions on the amount of annual additions to an individual participants accounts, as well as an aggregate limit on contributions and requires compliance with certain nondiscrimination tests. The annual limit on a participant’s before-tax contributions was \$23,000 and \$22,500 for 2024 and 2023.

Plan participants who are age 50 or more by the close of the Plan year, may elect to make catch-up elective deferrals up to \$7,500 and \$7,500 per calendar year for 2024

and 2023. These elective deferrals are for eligible participants whose elective deferrals have been restricted by either a statutory ceiling or by a plan limit.

The Company may make a discretionary matching contribution. The Company's matching contribution is determined annually at the end of the prior fiscal year. For the fiscal years ended June 30, 2024 and 2023, the Company contributed 1% of eligible employees pretax compensation in which the participant contributed at least 1% of compensation to the Plan.

The Plan does allow rollover contributions from other qualified Plans.

Participant Accounts And Investment Options

Each participant's account is credited with the participant's contribution and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

The Plan does not allow loans.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts occurs according to the following schedule:

Forfeited Accounts

Forfeitures can be used to pay the administration expenses of the Plan or used to reduce the Company's contributions to the Plan.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship withdrawals are permitted by the Plan for certain allowable expenses only if all other means of withdrawals or loans have been utilized. Participant may not contribute to the Plan for six months following the hardship withdrawal, except as moderated under the provision of the CARES act.

Administration And Expenses

The Plan paid \$896 and \$434 for the years ended June 30, 2024 and 2023, respectively, in administrative fees. All other costs of the Plan are paid by the Plan Sponsor.

(2) Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use Of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Contributions

Participant contributions and related employer contributions are recognized in the period during which the Plan Sponsor makes the respective payroll deduction from the participant accounts.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

---

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs in the periods presented.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at their price. The mutual funds held by the Plan are considered to be actively traded.

*Interest accumulation account:* The fair value of the interest accumulation account is based on cost plus accumulated interest. The interest accumulation account held by the Plan is a variable annuity contract. Funds are allocated to the individual plan participants; therefore, the funds are always available to pay benefits.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the investment balances and the amounts reported in the statements of net assets available for benefits.

#### Subsequent Events

Management has evaluated subsequent events through April 9, 2025, the date which the financial statements were available for issue. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements.

#### (3) Financial Data Certified By The Investment Company Administered Trust Fund

(5) **Forfeited Nonvested Amounts**

As of June 30, 2024 and 2023, forfeited non-vested accounts totaled \$423 and \$360. During the years ended June 30, 2024 and 2023, \$299 and \$0, respectively were utilized to reduce employer contributions.

(6) **Plan Termination**

Although the Plan Sponsor intends to continue the Plan and to make discretionary contributions, the Employer reserves the right to terminate the Plan at any time, and its continuance is not guaranteed. The Plan Sponsor also has reserved the right to amend or otherwise modify the Plan, or to discontinue any further contributions or payments under the Plan, by a resolution of its Board. In the event of a termination of the Plan or discontinuance of contributions, the account of each affected participant shall become non-forfeitable.

(7) **Income Tax Status**

403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal

---

Revenue Code. Plan Sponsor has previously received notice from the Internal Revenue Service of exemption from the income tax under Section 501(c)(3) of the Internal Revenue Code and accordingly qualifies to maintain a 403(b) plan. The Plan Sponsor has evaluated its tax positions and did not note any matters which may have an affect on its tax-exempt status.

The Plan follows the *Accounting for Uncertainty in Income Taxes* accounting standard which requires the Plan to determine whether a tax position (and the related tax benefit) is more likely than not to be sustained upon examination by the applicable taxing authority, based solely on the technical merits of the position. The tax benefit to be recognized is measured as the largest amount of benefit that is greater than fifty percent likely of being realized upon settlement, presuming that the tax position is examined by the appropriate taxing authority that has full knowledge of all relevant information. During the years ended June 30, 2024 and 2023, the Plan evaluated its tax positions to determine the existence of uncertainties, and did not note any matters that would require recognition in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan is no longer subject to U.S. federal tax audits on its Form 5500 by taxing authorities for years ending prior to June 30, 2021. The years subsequent to this year contain matters that could be subject to differing interpretations of applicable tax laws and regulations. Although the outcome of tax audits is uncertain, the Plan believes no material tax liability would arise.

(8) **Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) **Party-In-Interest**

A party-in-interest by ERISA guidelines includes the plan sponsor, the plan administrator, a fiduciary, persons who have control over the Plan assets, investment advisors, and persons who provide services to the Plan.

Mutual of America investments amounted to \$553,969 and \$471,371 for the years ended June 30, 2024 and 2023. These transactions qualify as party-in-interest transactions, and are exempt from the prohibited transaction rules of ERISA.
