Employees' Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Trinity Services, Inc. Employees' Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Trinity Services, Inc. Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Trinity Services, Inc. (the Organization) who have completed one year with 1,000 hours of service and are 21 years of age or older. Nonresident aliens are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan is funded by discretionary contributions from the Organization. Each year, the Organization may make a discretionary contribution up to the maximum allowable limits of Code Section 401(a) of the Internal Revenue Code. For the year ended June 30, 2024, the Organization made a discretionary contribution in the amount of \$2,800,000. With the exception of rollover contributions, the Plan does not provide for contributions from participants.

Participant Accounts

Each participant's self-directed 401(a) account is credited with the Organization's contributions and earnings on the Organization's contributions, and is charged with plan expenses. Each participant with a rollover balance has a separate self-directed 401(a) account for rollover contributions, which consists of the participant's rollover contributions and earnings on the participant's rollover contributions, and which is charged with plan expenses.

Vesting

Vesting in the employer discretionary contributions portion of participants' accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Description of Investment Options

The Plan's assets are held in a trust administered by American United Life Insurance Company. Participants may elect to have their account contributions invested in one or a combination of investment options provided by the Plan. The investment options consist of a group annuity contract and various pooled separate accounts as selected by the Plan Trustees.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits and Distributions

On termination of service due to death, disability, retirement, or other reasons, a participant will receive an amount equal to the value of the participant's vested interest in a lump-sum payment or in a series of partial payments. In addition, the Plan provides for in-service withdrawals under certain circumstances.

Administrative Expenses

Certain administrative expenses have been paid by the Organization. Administrative expenses paid by the Plan include investment advisory and management fees.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$188,982, respectively. Forfeitures may be reallocated to eligible participants, used to pay administrative expenses, or used to reduce employer contributions. During the year ended June 30, 2024, forfeitures of \$304,158 were reallocated to eligible participants, and forfeitures of \$905 were used to pay administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Administration

The Plan is administered by the Plan Trustees.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and that also affect revenues and expenses during the reporting period. Actual results could differ from those estimates.

Date of Management's Review

For the current reporting period, subsequent events were evaluated through April 14, 2025, which represents the date the financial statements were available to be issued.

Recently Adopted Accounting Pronouncements

In June 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2016-13, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, which changed how entities will measure credit losses for most financial assets and certain other instruments. The Plan adopted ASU No. 2016-13 on July 1, 2023 with no material impact to the financial statements.

NOTE 3 - INVESTMENTS

The financial information relating to the Plan's investments is included in the accompanying financial statements based on information provided by the custodian. America United Life Insurance Company was the custodian of the Plan's investments at June 30, 2024 and 2023. All investments are participant directed utilizing the investment options provided by the Plan.

NOTE 4 – INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN

The Plan Trustees have elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The custodian also certified to the completeness and accuracy of \$2,380,196 of net realized and unrealized appreciation in fair value of investments and \$18,798 in interest income related to the aforementioned investments for the year ended June 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Fair Value Measurements and Disclosure Topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at June 30, 2024 and 2023.

Pooled separate accounts: Valued based on the latest quoted market prices of the underlying securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - GROUP ANNUITY CONTRACT

The Plan offers a traditional fully benefit-responsive investment contract (group annuity contract) with American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Subject to certain restrictions, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The group annuity contract is a traditional investment contract. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The group annuity contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the group annuity contract as of June 30, 2024 and 2023 was \$1,146,730 and \$1,127,633, respectively. The crediting interest rate is based upon a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on an annual basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the Plan, termination of the recordkeeping agreement, or written notice provided either by the Plan Trustees or the issuer. In the event of the issuer terminating the contract, the issuer will pay all participant account values to another provider or trustee as directed by the Plan Sponsor. The Plan Trustees believe that occurrence of such events that would limit the Plan's ability to transact at contract value is not probable.

Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value. This total liquidation is a contingent event, which cannot be initiated by the Plan's participants, and can only be initiated by the Plan Trustees upon termination of the Plan or complete termination of the contract.

NOTE 7 - TAX STATUS

The pre-approved plan sponsor has obtained an opinion letter dated August 19, 2020, in which the IRS stated that the pre-approved non-standardized plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Trustees timely adopted the restated pre-approved non-standardized plan. The Plan Trustees believe that the Plan is being operated in accordance with the IRC.

NOTE 7 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the Internal Revenue Service. The Plan Trustees have analyzed the tax positions taken by the Plan, and have concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Trustees believe the Plan is no longer subject to income tax examinations for years prior to the year ended June 30, 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - PARTY IN INTEREST TRANSACTIONS

Plan investments include a group annuity contract and various pooled separate accounts managed by American United Life Insurance Company (AUL). AUL is the custodian of the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid indirectly by the Plan to the custodian are included as a reduction of the return earned on the group annuity contract and pooled separate accounts.
