Notes to Financial Statements

Note 1: Description of Plan

The following description of the Cedar Community Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Benevolent Corporation Cedar Community (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

Eligibility and Participation

Employees are eligible to make employee contributions on the first day of the month subsequent to completing 30 consecutive days of employment and attaining the age of 18.

Employees are eligible to receive Sponsor matching and profit-sharing contributions upon attaining the age of 18 and completing one year of employment. The employee must also be employed on the last day of the Plan year and worked at least 1,000 hours of service for the Plan year. To qualify for matching contributions, the employee must also have made elective contributions during the Plan year.

Contributions

Each year, participants may elect to defer up to 100% of compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan also allows for Roth contributions.

The Plan allows the Sponsor to determine the amount or percentage of compensation that the Sponsor will match each year. The Sponsor may also make additional discretionary profit-sharing contributions to employees who meet eligibility requirements.

For the year ended June 30, 2024, the Sponsor matched 100% of participants' elective contribution up to 2% of participant compensation contributed to the Plan. There were no additional Sponsor profit-sharing contributions made for the year ended June 30, 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as allocations of the Sponsor's profit-sharing contribution and Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and any earnings or losses thereon. The Sponsor's contributions for participants hired on or after February 1, 2019, vest based on years of service in accordance with the following vesting schedule.

<i>Years of Service</i>	<i>Vesting %</i>
Less than 1 year	- %
1 year but less than 2 years	33 %
2 years but less than 3 years	67 %
3 years or more	100 %

Participants hired on or after February 1, 2019, are considered to have completed one year of service for purposes of vesting upon the completion of one hour of service at any time during 12 consecutive months.

If the participant earned at least one hour of service on or after January 1, 2014 through February 1, 2019, the participant is 100% vested in the Sponsor's contributions. If the participant did not earn one hour of service on or after January 1, 2014, the Sponsor's contributions vest based on years of service according to a 6-year graded vesting schedule. For vesting purposes for participants hired on or after January 1, 2014, a year of service is defined as a 12-consecutive month period beginning on the date an employee first performs an hour of service, or any anniversary of such date in which an employee completes at least 1 hour of service.

A participant's accrued benefit is 100% vested upon a participant's death, total disability, or attainment of normal retirement age (later of age 62 or 5th anniversary of year when hired).

Notes Receivable from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account. The note interest rate is commensurate with local prevailing rates as determined by the plan administrator. Existing notes bear interest at an interest rate of 4.25% to 9.50% on June 30, 2024. Principal and interest is paid ratably to the Plan through payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, a life annuity contract, a qualified joint and survivor annuity contract, or equal annual or more frequent installments. If the value of the account is \$5,000 or less, the participant will receive a lump-sum payment. The Plan also allows for in-service distributions upon attaining normal retirement age, as defined by the Plan.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in Sponsor's contributions. Forfeitures are used to pay administrative expenses or reduce Sponsor contributions. There were no unallocated forfeitures as of June 30, 2024 and 2023. During the year ended June 30, 2024, employer contributions were reduced by \$4,630 from the forfeited nonvested account.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent notes are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Professional fees and certain other expenses incurred in conjunction with the Plan are paid by the Sponsor and are excluded from these financial statements. Administrative expenses paid by the Plan are allocated proportionately to Plan participants on their respective account balances. Loan fees are charged directly to the participant's account.

Subsequent Events

Subsequent events have been evaluated through April 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of June 30, 2024 and 2023.

Money market funds: Measured using \$1 as net asset value.

Note 3: Fair Value Measurements (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of June 30, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 4: Information Certified by Plan's Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including cash equivalents, investments and notes receivable from participants at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended June, 30 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus Trust Company ("Ascensus").

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balance.

Note 6: Tax Status

The Plan Sponsor adopted a nonstandard prototype document with an IRS notification letter which states the prototype Plan Document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Party-In-Interest

Certain Plan investments are managed by Vanguard Fiduciary Trust Company, the custodian of the Plan. Notes receivable from participants are managed by Ascensus, investments and notes receivable from participants qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules of ERISA.
