Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Employees' Pension Plan of Glasstech, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Description of Plan

The following description of the Employees' Pension Plan of Glasstech, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan.

General

The Plan is a defined contribution plan established to provide income upon retirement to all eligible employees of Glasstech, Inc. (the Company and Plan Administrator). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Participant Accounts

Participant accounts are adjusted daily for a pro rata share of income and expenses of each fund, determined by the percentage that the participant's account balance bears to the total of all participants' account balances at that date prior to such adjustment. Company contributions plus actual earnings (losses) thereon vest 20% after one year of credited service (as defined in the Plan), 40% after two years, 60% after three years, 80% after four years, and 100% after five years of credited service. All Company contributions and earnings thereon are participant-directed. Company contributions may be reduced by participant forfeitures. The forfeiture account balance was \$2,888 at June 30, 2024 (\$12 at June 30, 2023).

Contributions

The Plan provides for an annual Company contribution of 5% of each participant's eligible compensation within certain limitations. The Plan met the minimum funding requirements of ERISA and Internal Revenue Service (IRS) Section 412 during 2024 and 2023.

Payment of Benefits

The Plan provides generally that upon retirement, death, disability, or termination, in the case of vested benefits, the standard form of payment will be in the form of a qualified joint and survivor annuity. Other forms of payment may be elected, including a single lump sum or single life qualified annuity. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, the participants' accounts become fully vested.

Administrative Expenses

Substantially all expenses for plan administration, rendered by parties-in-interest to the Plan, are paid by the Company.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used. The Plan's investments are held by Fidelity Management Trust Company (the Trustee).

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

Collective investment trusts (CITs) represent investments with various investment managers. Units held in CITs are fair valued at the net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The New York Life Insurance Company Anchor Account represents a group annuity contract that provides for a guarantee of principal and accumulated interest. The asset is a guaranteed investment contract valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Contributions to the Anchor Account are invested in New York Life's Pooled Separate Account No. 25. The Pooled Separate Account No. 25 is not chargeable with any other liabilities arising out of any other business of New York Life.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Investment Valuation and Income Recognition (continued)

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through March 4, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

All investment information disclosed in the accompanying financial statements and schedule, including investments held at June 30, 2024 and 2023, net appreciation (depreciation) of investments, and dividends and interest for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

Note 4 – Guaranteed Investment Contract

The Plan holds a traditional investment contract that meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reset every six months.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. The guaranteed investment contract permits the issuer or the Plan to terminate the agreement prior to the scheduled maturity date as a result of specific occurrences as defined in the contract.

Note 5 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level, within the fair value hierarchy, is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value, as of June 30, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Note 6 – Restrictions on Net Assets

For the New York Life Insurance Company Anchor Account, participants may deposit and withdraw on a daily basis at contract value. Any transfers to a competing fund must first go through a non-competing fund and be held there for at least 90 days. There are currently no competing funds offered in the Plan. If the Plan terminates the contract without providing a one-year notice, or if an employer-initiated event results in significant aggregate participant withdrawal requests, the Plan's balance in the fund may be subject to a market value adjustment.

The employer contributions per the financial statements are different from employer contributions per Form 5500 since the contributions receivable is not recorded in Form 5500. Ending net assets available for benefits also differ for this reason.

Note 8 – Income Tax Status

The Internal Revenue Service ruled on June 30, 2020, that the Fidelity Basic Plan Document No. 16 (the volume submitter plan of the Trustee upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (the Code) and the related trust is, therefore, not subject to tax under present income tax law. Subsequent to this ruling the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
