The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of the Plan

The following description of the Creative Works 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Creative Works (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Mutual of America Life Insurance Company (MOA) is the recordkeeper of the Plan.

Eligibility

The Plan is available to all Company employees upon employment with the Company. There is no minimum age or service requirement to participate in the employee elective deferral contributions.

All participants who have attained the age of eighteen and completed one year of service are eligible to receive employer matching contributions. From time to time, the Company will make discretionary flat dollar employer matching contributions to participating employees. There is no service requirement to receive discretionary flat dollar employer matching contributions.

Contributions

The Plan allows participant voluntary contributions of up to the maximum allowed as determined by the Internal Revenue Code (IRC). Participants who are over age 50 may make an additional pretax "catch-up" contribution pursuant to the IRC limitations. In addition, participant contributions may consist of transfers from other qualified retirement plans. The Company will contribute 1% of compensation if the participant's elected deferral is 2% of pay. The Company will contribute 2% of compensation if the participant's elected deferral is 3% of pay. The Company will contribute 3% of compensation if the participant's elected deferral is 4% of pay or more.

Vesting

Participants are always 100% vested in all employee elective deferrals. Participants become fully vested in the employer matching contributions based on a four-year schedule.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income, and charged with an allocation of the investment losses, certain administrative expenses, and any distributions. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in shares of mutual funds and group annuity contracts.

Payment of Benefits

Participants shall become eligible to receive their vested account balances upon termination, attainment of the normal retirement age, death, or disability. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump sum payment or a monthly annuity. In addition, participants may withdraw their pretax contributions upon demonstration they are suffering from a hardship, as defined in Section 403(b) of the IRC.

Notes Receivable from Participants

Participants may borrow from their accounts. These loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates.

Administrative Expenses

Administrative expenses are charged against the accounts of the participants to the extent they are not paid by the Company.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting and are presented in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investments

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Participant Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan document.

Subsequent Events

Management has considered transactions or events occurring through April 14, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fully Benefit-Responsive Investment Contracts

The Plan is invested in the Teachers Insurance and Annuity Association (TIAA) Traditional Annuity (the Fund). The Fund maintains the contributions in a general account. The contract allows the Plan to offer investment options with a guaranteed rate of return. Contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The TIAA Traditional Annuity crediting interest rates are based on a formula agreed upon with the issuers, but it may not be less than 3%. Such interest rates are reviewed on a quarterly and monthly basis, respectively, for resetting. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

4. Fair Value Measurement

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the quoted market price of shares held by the Plan at year-end.

Pooled separate account: Valued at fair value using the market approach based on the quoted underlying net asset value (NAV) of units held by the Plan at year-end. The NAV is provided by the custodian and is used as a practical expedient to estimate fair value. Pooled separate accounts have a daily redemption frequency and a daily redemption notice period.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan utilizes a volume submitter plan document sponsored by MOA. The Internal Revenue Service has determined and informed MOA, by letter dated March 31, 2017, that the volume submitter plan is designed in accordance with Section 403(b) of the IRC and the regulations issued thereunder. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

6. Information Prepared and Certified by Custodians

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and related interest, and interest and dividend income amounts were certified by TIAA, College Retirement Equities Fund (CREF) and Mid Atlantic Trust Company, the custodians, as complete and accurate. This information is included in the following:

7. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by TIAA and CREF as custodians of the Plan. Additionally, as the recordkeeper, MOA holds and manages the Plan's assets and makes distributions in accordance with instructions of the Company. These transactions are considered to be party-in-interest transactions. Fees paid by the Plan to MOA were \$12,626 for the year ended June 30, 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
