To Whom It May Concern;

This letter is submitted in response to the IRS CP406 notice dated March 17, 2025, regarding the late filing of Form 5500-SF for the CBO Financial Inc. 401(k) retirement plan (Plan #714386) for the plan year ending December 31, 2022.

CBO Financial Inc. had a 401(k) plan managed by ADP through the end of 2022. The last participant in the plan retired in 2022, and no additional contributions or participants have been added since that time. It appears the required Form 5500-SF for 2022 was not filed. This oversight may have resulted from either a mailed return not being received or processed, or due to the retirement of the individual who had been serving as the plan administrator, after which responsibility for the filing lapsed unintentionally.

Upon receipt of the CP406 notice, CBO Financial Inc. promptly contacted ADP and is working with them to finalize and file the 2022 Form 5500-SF. The delay was not due to willful neglect but was an inadvertent oversight during a period of transition. The company has otherwise maintained a compliant filing history with respect to its retirement plan obligations and has acted in good faith to remedy the situation as quickly as possible.

Based on the facts and circumstances, we respectfully request that the IRS waive the penalties under IRC Section 6652(e) on the grounds of reasonable cause. We believe this situation demonstrates that ordinary business care and prudence were exercised, and that immediate corrective action has been taken to comply with applicable filing requirements.
