We have performed audits of the financial statements of GBMC, Inc. 401(a) Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ## **1. Description Plan**

The following description of the GBMC, Inc. 401(a) Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***General***

The Plan is a defined contribution plan established by the Greater Baltimore Medical Center and its affiliates (Medical Center, or Employer) on July 1, 2007 (the effective date) and restated effective July 1, 2013. The Plan was most recently amended effective June 1, 2022. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

### ***Eligibility***

Employees of the Medical Center are eligible to participate in the matching component of the Plan immediately, provided they are making salary reduction contributions to the GBMC, Inc. Voluntary 403(b) Plan (the 403(b) Plan) and are not an excluded class of employee. Excluded classes of employees are members of a collective bargaining unit unless the collective bargaining agreement provides for the employee's participating in the Plan, leased employees, independent contractors, nonresident aliens, and persons classified as having an A5, A6 or A7 employment status as defined by the Plan. Employees of the Medical Center are eligible to participate in the Medical Center annual contribution component of the Plan on the first day of the payroll period in which the employee is first credited with one year of service, defined by the Plan as working 1,000 hours within a 12 consecutive month period, and provided they are employed on the last day of the year and not an excluded class of employee as described above.

### ***Contributions***

Under the terms of the Plan, the Plan only allows for Employer annual or matching contributions. The Medical Center will make the following contributions:

*Medical Center annual contributions:* The annual contribution was suspended for the year ended June 30, 2024 and 2023, reduced to 0% of eligible compensation by the Retirement Plan Committee (the Committee) resolution, to be further changed in the future at the Committee's discretion.

*Medical Center matching contributions:* For those Plan participants who have made an elective contribution to the 403(b) Plan for a pay period during the year, the Medical Center will make a matching contribution equal to 50% of the participant's elective contribution for each pay period during the year up to 6% of the participant's eligible annual compensation. Any participant catch-up contributions made under the 403(b) Plan shall not be treated as a salary reduction contribution for purposes of the matching contribution provision of this Plan.

Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Each participant's account is credited with the Medical Center's contributions and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

***Vesting***

Participants are immediately vested in any rollover contributions and earnings thereon. Vesting in the Medical Center's contribution portion of their accounts is based on years of credited service. A participant is 100% vested after three years of credited service. Notwithstanding the above, a participant is fully vested in the Medical Center's contributions upon death, disability, reaching normal retirement age, or the termination of the Plan.

***Payment of Benefits***

On termination of service, death, disability, or retirement, a participant with a vested balance of less than \$1,000 will receive a lump sum distribution. Participants or their beneficiaries who have a balance greater than \$1,000 may elect to receive the total vested balance in a lump sum distribution or may leave the balance in the Plan until minimum distribution is required. Effective January 1, 2021, upon termination of service or retirement, a participant may elect to receive all or a portion of their account balance in installments. Effective January 1, 2024, the Plan increased the involuntary cash-out limit to \$7,000.

***Forfeitures***

The Plan provides that forfeitures of nonvested Medical Center contributions, if any, shall be applied to reduce any administrative expenses of the Plan not paid through revenue sharing. Any remaining balances are used to reduce future Medical Center contributions.

As of June 30, 2024 and 2023, forfeited nonvested accounts totaled \$150,400 and \$52,042, respectively. Forfeitures of \$28,275 and \$25,144 and were used to reduce the Medical Center contributions during the years ended June 30, 2024 and 2023, respectively.

**2. Summary of Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ( U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, trustee, and insurance company. See Note 4 for discussion of fair value measurements. The Plan's fully benefit-responsive investment contracts (see Note 5) are valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Benefit Payments***

Benefits payments are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Medical Center and are excluded from these financial statements. Fees related to the administration of distribution transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***Revenue Credits***

The Plan's trust agreement with Empower provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds.

***Subsequent Events***

The Plan Administrator has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of June 30, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends, for the year ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (Empower), a qualified institution.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

A financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Self-directed brokerage accounts consist of mutual funds and money market funds. Money market funds are valued and traded at a stable \$1.00 NAV which approximates fair value. Mutual funds and money market funds are deemed to be actively traded.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Group Annuity Contracts with Insurance Company

The Plan has entered into traditional fully benefit-responsive group annuity contracts with Empower that invest in the Guaranteed Fixed Fund and Guaranteed Interest Fund as of June 30, 2024 and 2023. Empower maintains the contributions in separate general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average crediting rate is based on a formula established by the contract issuer but may not be less than 1.10%. The crediting rate is reviewed on an annual basis for resetting.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contracts. The Plan's management is not aware of any events which are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

## **6. Plan Termination**

Although it has not expressed any intent to do so, the Medical Center has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Medical Center contributions. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Medical Center may determine, in accordance with the Plan Document.

## **7. Related Party and Party-in-Interest Transactions**

The Plan's investments are managed by Empower, the insurance company as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. As described in Note 2, the Plan receives revenue credits and paid certain expenses related to Plan operations and investment activity to Empower. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

## **8. Tax Status**

The IRS has determined and informed the Plan by a letter dated September 19, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would

not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
