



NOTE 1 - DESCRIPTION OF THE PLAN AND SIGNIFICANT ACCOUNTING POLICIES

The following description of the Withers Bergman LLP Associates and Counsel Section 401(K) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all of the staff and current and former junior and senior equity partners of Withers Bergman, LLP (Company) who are age 21 or older. Employees are immediately eligible to make elective contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a target retirement fund unless changed by the participant. Participants are eligible for a discretionary contribution and match contribution after one year of service, provided they work 1,000 hours during the Plan year, and are employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, the Company can elect to make a discretionary contribution to the Plan and a match of participant contributions of 50% not to exceed \$1,000. The Company did not make a discretionary contribution for the year ended June 30, 2024. Participants may contribute a portion of their annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain Internal Revenue Services (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, Plan earnings and charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and in the Company matching contributions, plus actual earnings thereon. Vesting in the Company discretionary contributions portion of their account balance plus earnings thereon is based on the number of years of continuous service. A participant is 100% vested after six years of credited service.

Investment Options

All investments in the Plan are participant directed. A participant may direct employee and employer contributions into a variety of mutual funds and a collective investment trust made available by the Trustee.

Notes Receivable from Participants

Participants may borrow up to an amount equal to the lesser of \$50,000, or 50% of their vested account balance. Loan terms range from one to five years, or more than five years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate equal to the current prime rate plus 1.25 percentage points, as defined. For the year ended June 30, 2024, all loans had an interest rate ranging from 4.50% to 9.75%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant or beneficiary may elect to receive a lump-sum payment, installment payments, or have the payment paid as a direct rollover to a qualified retirement account. Termination for reasons other than death, disability or retirement, a participant will receive only the vested account balance and the remainder will be forfeited. In-service distributions are permitted upon attainment of age 59.5 and in the event of certain financial hardships. The Plan permits involuntary distributions of account balances of terminated participants when the account balances is less than \$5,000.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$42,292 and \$30,180, respectively. These accounts will first be used to reinstate previously forfeited account balances of former participants, if any; the remaining balance may be used to reduce employer contributions, at Plan management's discretion.

Basis of Accounting

The Plan prepares its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, investment income and contributions from the Company are recorded when received and benefits and administrative expenses are recorded when paid.

The Plan has consistently recorded participant contributions when they are withheld from the participants' wages. Any participant contributions withheld but not yet deposited in the Plan at the end of the year are shown as participant contributions receivable in the statement of net assets available for benefits. At June 30, 2024 and 2023, there were no participant contributions receivable.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value or net asset value (NAV), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, and certain investment related expenses are charged directly to the participant's account and are included in administrative expenses and the net appreciation of fair value of investments.

Date of Management's Review of Subsequent Events

Plan's management evaluated subsequent events that occurred through April 7, 2025, the date when the financial statements were available to be issued.

NOTE 2 - TRANSFER OF ASSETS OUT OF THE PLAN

For the year ended June 30, 2024, the Withers Bergman LLP Associates & Counsel Section 401(K) Profit Sharing Plan made plan-to-plan transfers to another 401(K) plan established by Withers Bergman LLP in the amount of \$-. These amounts represent transfers out of the Plan for eligible participants that have been promoted from associate or special counsel employment status to partner.

NOTE 3 - CERTIFIED INVESTMENTS

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Vanguard Fiduciary Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of June 30, 2024, and the related investment activity from participants reported in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 - FAIR VALUE MEASUREMENTS – (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: The Vanguard Retirement Savings Trust, a stable value fund, is held in a common trust. This fund is valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 6 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Under ERISA, parties-in-interest are defined to include the Plan sponsor, the Plan administrator, employees, officers and directors of the sponsor; direct and indirect owners (or their relatives), if they have combined voting power of 50% or more; the custodian or trustees; other parties with fiduciary responsibilities such as the investment advisor; and a person (or their relatives), who provides services to the Plan such as the Plan actuary, investment custodian, auditor, attorney, etc.

The Plan holds its investments in funds which are managed by Vanguard Fiduciary Trust Company, the Plan's Trustee. The Plan issues loans to participants, which are secured by the participant's account balances. The Plan pays administrative fees for recordkeeping, investment advisory and investment management. These related-party and party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE 7 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated June 30, 2020 that the Plan as then designed was in compliance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits – modified cash basis.
