Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Holistic Care Home Health Agency, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to August 31, 2024, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of August 31, 2024 and December 31, 2023, and for the period from January 1, 2024 to August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a Plan termination effective in 2022, and management determined liquidation was imminent. As a result, the Plan has used the liquidation basis of accounting in presenting the financial statements. Our presentation is not modified with respect to this matter.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4a - schedule of delinquent participant contributions for the period ended August 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Holistic Care Home Health Agency, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan was a defined contribution plan and was adopted by Holistic Care Home Health Agency, Inc. (the Company or Employer), effective January 1, 2021, to provide deferred tax benefits, savings, and Company contributions to eligible employees. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On December 1, 2022, the Plan was frozen and terminated. All participants were 100% vested in employer contribution accounts as of the effective date of the termination. As a result of the Plan termination, the Company distributed all assets, in accordance with the terms of the Plan, by August 31, 2024.

Eligibility

All employees, excluding union employees, leased employees and nonresident aliens, were eligible for participation upon age 21 and the completion of 12 months of service. Eligible participants may have entered the Plan on the first day of the first month and the first day of the seventh month of the Plan year following the date in which the participant satisfied the service requirements.

Contributions

Each year, eligible employees may have elected to contribute, on a pre-tax basis or Roth basis, up to 100% of their eligible compensation, as defined by the Plan, through payroll deductions, not to exceed the limit under the Internal Revenue Code (IRC). In addition, eligible participants were permitted to make catch-up contributions. Participants may have also contributed amounts representing distributions from other qualified plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company may have made a safe harbor matching contribution equal to 100% of the participant's contributions up to 3% of compensation, plus 50% of the participant's contributions that exceeded 3% of compensation but did not exceed 5% of compensation. In addition, the Company may have made discretionary employer match and non-elective contributions (collectively, discretionary contributions). In order to have shared in the allocation of the discretionary contributions, a participant was required to complete 500 hours of service and must have been employed on the last day of the Plan year. There were no safe harbor or discretionary contributions during the period from January 1, 2024 to August 31, 2024.

Participant Accounts

Each participant's account was credited with the participant's salary deferral contributions, allocations of any Company contributions, and his/her share of the Plan's income (loss). The Plan's income (loss), with respect to each investment fund, was allocated based on the proportion that each participant's account balance invested in such fund compared to the total of all participants' account balances invested in such fund.

1. Description of the Plan (cont.)

Notes Receivable from Participants

Participants may have borrowed, from their fund accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants would have been secured by the balance in the participant's account and would bear interest at a commercially reasonable rate of interest. Principal and interest payments would have occurred ratably through regular payroll deductions over a period not to exceed five years or twenty years for the purchase of a primary residence. Participants were only allowed to have one loan outstanding at a time. As of August 31, 2024 and December 31, 2023, there were no notes receivables from participants.

Vesting

Participants were immediately vested in the value of their salary deferrals, and rollovers, plus related investment earnings (losses), as well as Company safe harbor matching contributions.

Participants became fully vested in all Company contributions as the Plan was terminated on December 1, 2022.

Payment of Benefits

Participant accounts may have been withdrawn upon retirement, death, or termination of employment. Participants may have elected to have distributions paid in a lump-sum and were either paid directly to the participant or rolled over to another qualified retirement plan. Installments were permitted only for required minimum distributions. The Plan also allowed for withdrawals in the event of a financial hardship.

Forfeitures

The Plan allowed forfeitures to be used to reduce Company contributions or pay Plan expenses. Unused forfeitures available for use at August 31, 2024 and December 31, 2023 were \$0 and \$909, respectively. The Company utilized \$922 of forfeitures to pay Plan related expenses during the period from January 1, 2024 to August 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements were prepared on the liquidation basis of accounting. The liquidation basis of accounting was adopted as a result of the effective Plan termination.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) required the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could have differed from those estimates.

Investment Valuation and Income (Loss) Recognition

Investments were stated at fair value, except for the fully benefit-responsive investment contract, which was reported at contract value. Contract value was the relevant measurement for that portion of the net assets available for benefits because contract value was the amount participants normally would have received if they initiated permitted transactions under the terms of the Plan.

2. Summary of Significant Accounting Policies (cont.)

Investment Valuation and Income (Loss) Recognition (cont.)

Fair value was the price that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for information on fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation/(depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable

Notes receivable from participants would have been measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income would have been recorded on the accrual basis. Related fees would have been recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2024 and December 31, 2023. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance would have been reduced, and a benefit payment would have recorded.

Plan Expenses

Certain administrative expenses related to distributions and other participant-initiated transactions were charged to the account of the Plan participant. Other administrative expenses and investment management fees were paid from the Plan's forfeitures and through reductions of investment returns under the Plan's investment options.

Payment Benefits

Benefit payments to participants were recorded upon distribution.

3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln National Life Insurance Company (Lincoln) has provided certifications that the financial information included in the financial statements of August 31, 2024 and December 31, 2023, and for the period from January 1, 2024 to August 31, 2024, provided to the Plan, is complete and accurate. The information as to investment assets and transactions therein, and investment income (loss) included in the accompanying financial statements as of August 31, 2024 and December 31, 2023, and for the period from January 1, 2024 to August 31, 2024, is covered by such certifications.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at August 31, 2024 and December 31, 2023.

Pooled Separate Account - The fair value of the pooled separate account was based on the net asset value (NAV) of each account calculated by Lincoln and is based on the NAV of the underlying investments. The NAV was used as a practical expedient to estimate fair value.

The Plan's investments at fair value as of December 31, 2023 were made up entirely of a pooled separate account, which was measured at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan had no assets at December 31, 2023 that are classified in the fair value hierarchy. The Plan had no assets as of August 31, 2024.

The following table summarizes the investments for which fair value was measured using the NAV per share practical expedient as of December 31, 2023.

5. Investment in Insurance Contract

The Plan had entered in an investment contract with Lincoln. The investment contract was considered fully benefit-responsive and totaled \$910 at December 31, 2023. Lincoln maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract's issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was reviewed on a quarterly basis for resetting.

5. Investment in Insurance Contract (cont.)

As described in Note 2, because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represented contributions made under the contracts, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may have been affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required transaction exemption under ERISA. Furthermore, certain events would have allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events included (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan administrator did not believe that any events that would have limited the Plan's ability to transact at contract value with participants were probable of occurring.

6. Party-In-Interest Transactions

The recordkeeping and custody functions for the underlying investments held by the Plan were performed by Lincoln. Such transactions are exempt from the prohibited transaction rules.

7. Tax Status

The Plan was based on the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by The Retirement Advantage Inc (TRA). The Internal Revenue Service (IRS) opined and informed TRA by letter dated June 30, 2020, that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believed the Plan was qualified and the related trust was tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not based on the technical merits not to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan's investments included funds which invested in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have occurred, and those changes could have materially affected the amounts reported in the Plan's statements of net assets available for benefits.

9. Operational Error

Plan management had identified certain operational issues whereby eligible participants were not timely enrolled in the Plan during the year ended December 31, 2021. The Company took corrective action to make the affected employees whole. The correction was calculated and recorded as an other employer contribution receivable of \$80,181 as of December 31, 2022. The correction was funded during the year ended December 31, 2023.

10. Delinquent Participant Contributions

During 2022, employee withholdings of \$1,020 were not remitted within the appropriate time period by the Company. The Company remitted the delinquent contributions of \$1,020 to the Plan during 2022. This transaction constituted a prohibited transaction as defined by ERISA. The Company remitted the lost earnings for the delinquent contributions in 2024.

11. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through January 03, 2025, the date these financial statements were available to be issued, and has determined that no significant events occurred after August 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
