## Independent Auditor's Report

To the Administrative Committee  
of the Frontier Technology Inc. 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Frontier Technology Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of Frontier Technology Inc. and its wholly owned subsidiary, FTI Services Inc. (referred to collectively as the Company or Plan Sponsor), who are at least 18 years of age. The Plan administrator controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may elect to contribute between 1% and 100% of their eligible annual compensation, subject to limitations imposed by the Internal Revenue Code. The Company matches 100% of the first 6% of compensation that a participant contributes to the Plan. The Plan also allows participants to designate all or a portion of their elective deferrals as Roth contributions. Additionally, profit sharing contributions may be made to the Plan at the Company's discretion. No discretionary profit sharing contributions were received by the plan during the year ended June 30, 2024.

**Participant Accounts** - Each participant's account is credited with participant's contributions, the Company's matching contributions, the Company's discretionary profit sharing contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** - Participants are immediately vested in their voluntary contributions, employer matching contributions, qualified non elective contributions, plus actual earnings thereon. Vesting in the employer profit sharing is based on years of credited service using a scale that starts at 25% after one year of service and vests at a rate of 25% per year of service thereafter. Therefore, participant accounts are 100% vested after four years of continuous service. Participants are also 100% vested in all their accounts upon disability or attainment of normal retirement age, which is 65.

**Payment of Benefits** - On termination of service for death, disability or retirement, a participant will receive a lump-sum distribution of their vested balance as provided by Plan policy. Upon termination of employment for reasons other than death, disability, or retirement a participant may receive a distribution of their vested account balance.

**Notes Receivable from Participants** - Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range up to 5 years, unless a note is for the purpose of buying a primary residence in which case the note term may be up to 10 years. The notes are collateralized by the balance in the participant's account and bear interest equal to 1% above the prime rate at the loan's inception. Outstanding loans as of June 30, 2024 had an interest rates ranging from 4.25% to 9.50%.

**Direction of Investments** - The Plan provides for participant-directed investment programs for all funds contributed by the participants and by the Company. Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options. Investment elections may be changed daily.

**Forfeitures** - At June 30, 2024 and 2023, the forfeited, non-vested accounts totaled \$93,639 and \$188,230, respectively. These accounts originated primarily from employer match and profit sharing contributions and earnings thereon forfeited by employees who terminate their employment before becoming fully vested. These amounts are used to reduce future Company matching and profit sharing contributions or pay administration expenses.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The Accounting Standards Codification as produced by the Financial Accounting Standards Board is the sole source of authoritative U.S. GAAP.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a withdrawal is recorded.

**Use of Estimates** - The preparation of financial statements in conformity with the U.S. GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value, except for certain investment contracts, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

**Investment Contracts** - The Empower Annuity Insurance Company of America (Empower) general investment account investment option for defined contribution plans is a Guaranteed Interest Account (GIA) provided through a group annuity contract. Under the terms of the group annuity contract, a crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value.

The average interest rate credited to participants is calculated by dividing the annual interest credited to the participants during the plan year by the average annual fair value. The average interest rate credited to participants during the year ended June 30, 2024 was 3.0%.

Since the group annuity contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business. Such events also include: (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete Plan termination; or (3) Plan disqualification.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Payment of Benefits** - Benefits are recorded when paid. All persons who elected to withdraw from the Plan had withdrawn their balances as of June 30, 2024.

**Plan Expenses** - A portion of the Plan's administrative expenses are paid by the Company. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of investments.

**NOTE C - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive 100 percent of the balance in their accounts. The assets of the Plan will be distributed to the participants after payment of any expenses associated with the Plan are paid.

**NOTE D - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, the trustee of the Plan.

**NOTE E - FAIR VALUE MEASUREMENTS**

The Plan follows authoritative guidance that establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE G - PARTY IN INTEREST TRANSACTIONS AND ADMINISTRATION FEES**

Certain Plan investments are sponsored by Empower, the Plan's record-keeper, which qualifies as a party-in-interest.

The Plan's administrative fees result from services rendered by parties-in-interest.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE H - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

Subsequent events were evaluated through April 11, 2025, which is the date the financial statements were available to be issued.
