To the Administrator and Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pibly Residential Programs, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.



NOTES TO FINANCIAL STATEMENTS JUNE 30, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following brief description of the Pibly Residential Programs, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General – The Plan is a participant-directed defined contribution plan covering all eligible employees of Pibly Residential Programs, Inc. (the “Company” or “Plan Administrator”). All employees who are age 21 and over and have worked 1,000 hours of service within the first twelve months of employment or in any subsequent plan year are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The investment assets of the Plan are held and invested by Reliance Trust Company (“RTC”) who serves as trustee of the Plan (See Note 3).

Contributions – Employees who are eligible and elect to participate in the Plan may contribute, through payroll deductions, 1% to 60% of their eligible earnings in any combination of pre-tax elective deferrals and Roth elective deferrals up to a statutory maximum of \$23,000 for 2024. Certain eligible participants (age 50 and over) are permitted to contribute an additional \$7,500 as catch-up contributions, resulting in a total maximum contribution of \$30,500 for 2024.

The Company may make a profit-sharing contribution in an amount determined by the board of directors. Profit-sharing contributions shall be allocated to each eligible participant based on the ratio that such participant’s compensation, as defined, bears to the total compensation paid to all eligible participants. A profit-sharing contribution of \$752,366 was made for the year ended June 30, 2024.

Rollovers – Rollover contributions are permitted into the Plan in accordance with Internal Revenue Service (“IRS”) regulations and plan provisions.

Participant Accounts – A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution, the Company’s contribution, an allocation of plan earnings or losses and charged with an allocation of any administrative expenses paid by the Plan. Allocations of earnings or losses are based upon the investment performance of the individual securities in which each participant’s account balance is invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

The Plan currently offers various mutual funds and common/collective trusts as investment options for participants. Participants may change their investment elections from among these investment options at any time through the Plan’s record-keeper.

Vesting – Plan participants are fully vested in their contributions plus actual earnings or losses thereon. In addition, participants become 100% vested in employer profit sharing contributions after three years of service.

A participant will be 100% vested in the Company contributions if they attain age 65, incur a total and permanent disability or die while employed by the Company.

1. DESCRIPTION OF THE PLAN (continued)

Forfeited Accounts – Forfeited balances of participants' non-vested accounts are used to reduce future employer contributions. Forfeitures may also be used to pay expenses for the Plan, but the Plan Administrator has not elected to use them for this purpose. Unallocated forfeitures totalled \$17,270 and \$4,867 as of June 30, 2024 and 2023, respectively. During the year ended June 30, 2024, \$17,270 was utilized to reduce employer contributions.

Benefit Payments – Under the Plan, normal retirement age is 65. Upon termination of service due to death, disability, retirement or termination of employment, a participant shall have the option to receive an annuity payment over his or her life expectancy, a lump-sum amount equal to the full value of the participant's vested account balance, or a rollover to an IRA or other qualified plan. In situations in which a separated participant fails to elect a method of distribution, the Plan has the authority to initiate lump-sum payments for vested account balances below \$1,000 and automatic IRA rollovers for vested account balances between \$1,000 and \$5,000. Separated participants with account balances in excess of \$5,000 may elect to leave their account balances in the Plan until they reach the age of 70½, at which time one of the above options must be selected.

Prior to age 65, in-service withdrawals from the Plan are allowed for unusual hardship and upon attaining the age of 59 ½.

In the event a participant's employment is terminated, the participant's accumulated vested benefits will be distributed to the participant in accordance with the provisions of the Plan. A participant's account in excess of his or her vested interest shall be forfeited upon termination.

Notes Receivable from Participants – Participants may borrow from their individual account balances in accordance with the Plan's provisions. The maximum amount of any loan is the lesser of (a) \$50,000, reduced by the participant's highest loan balance during the previous one-year period, or (b) one-half the value of the participant's vested account but not less than \$500. Loans are collateralized by the participant's vested account. All loans bear an interest rate equal to the prime rate as published in The Wall Street Journal on the 14th of each month, plus one percentage point, and must be repaid in five years unless used for the purchase of the participant's principal residence (for which the repayment period may be extended to thirty years). The Plan allows a participant to have two loans outstanding from the Plan at a time, provided that no more than one loan is for the purchase of the participant's principal residence with a repayment period greater than five years. Principal and interest are paid ratably through payroll deductions. Notes receivable outstanding as of June 30, 2024 have interest rates ranging from 4.25% to 9.50% and mature on various dates through July 2029.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Valuation of Investments and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest, including interest on notes receivable from participants, is recorded when earned. Net appreciation in fair value of investments include the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 30, 2024 and 2023 no allowance for credit losses has been recorded. If the participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net depreciation in fair value of investments.

3. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan’s management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by RTC, except for comparing such information certified by RTC with information included in the Plan's financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Investments in the Invesco Stable Asset Fund are included in common/collective trusts. The underlying assets owned by the Invesco Stable Asset Fund consist primarily of fixed income securities, plus the contract value of the fully benefit-responsive wrapper contract. The Invesco Stable Asset Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The stable value fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Invesco Stable Asset Fund's NAV represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at NAV.

4. FAIR VALUE MEASUREMENTS (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

A party-in-interest is defined under Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, certain fees are paid from the Plan’s assets and therefore qualify as party-in-interest transactions. ADP, Inc. (“ADP”) acts as record-keeper for the Plan. For the year ended June 30, 2024 the Plan incurred administrative fees totaling \$8,154 for recordkeeping services provided by ADP. Loans to participants are secured by the balances in the respective participant accounts. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

6. FEDERAL INCOME TAX STATUS

The Plan’s administrator adopted a prototype non-standardized profit-sharing plan with cash or deferral arrangements which received a favorable opinion letter from the IRS on October 6, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

7. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the right to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

8. RISK AND UNCERTAINTIES

The Plan invests in various securities including mutual funds and common/collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The Plan’s exposure to concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into various financial instruments.

9. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement Act (“SECURE Act 2.0”). The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. There is no material impact to the Plan’s 2024 financial statements.

10. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain financial information in the accompanying financial statements differs from the financial information on Form 5500 as of June 30, 2024 and 2023 and for the year ended June 30, 2024. The differences arise from the fact that the Plan’s financial statements have been prepared on the accrual basis of accounting while Form 5500 recognized certain activity on a cash basis.
