### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform the audits of the financial statements of the Morgan Memorial Goodwill Industries 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.



### ***Basis for Disclaimer of Opinion on the Financial Statements***

As described in Note 2, the Plan has not maintained accounting records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficiently to determine the extent to which the financial statements may have been affected by these conditions.

Further, as described in Note 10, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. Under accounting principles generally accepted in the United States of America, these accounts and the related income and distributions should have been included in the accompanying financial statements. The effects of these excluded annuity and custodial accounts and the related income and distributions are not determinable.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion on the Financial Statements section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## *Notes to Financial Statements*

### **Note 1 - Description of Plan**

The following description of the Morgan Memorial Goodwill Industries 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary of Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

#### **General**

The Plan is a 403(b) retirement plan originally established on November 1, 2000 by Morgan Memorial Goodwill Industries (the "Employer") and was restated in full on July 1, 2019. The Plan covers all employees, as defined ("Participants"). The Employer is the Plan's administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant directed.

Lincoln Financial Group Trust Company, Inc. ("Lincoln Financial") serves as the main custodian of the Plan. Certain Plan assets are maintained with Lincoln National Life Insurance Company ("Lincoln National"), which was formerly the Plan's main custodian prior to 2016. Collectively, Lincoln National and Lincoln Financial are known as "Lincoln".

#### **Participants' Contributions**

Participants may defer a portion of their eligible annual compensation, as defined by the Plan, subject to dollar limits set by Federal law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with IRS regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("Participant Rollovers").

#### **Employer Matching Contributions**

The Employer contributes matching contributions to the participant's Employer contributions account in the amount equal to the sum of (i) 100% of the elective deferral contributions for the applicable payroll period that do not exceed the annual fixed amount (initially set at \$260), prorated with respect to the payroll period, plus (ii) 33% of the elective contributions elected for the applicable payroll period that exceed the prorated amount, not to exceed 5% of compensation actually received by the participant in the applicable payroll period. To be eligible for an Employer matching contribution, a participant must have once had 1,000 hours and one year of service.

#### **Participants' Accounts**

Each participant's account is credited with the Participant's and Employer contributions and Plan investment earnings, and reduced by administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the Participant's vested account.

### *Note 1 - Description of Plan (Continued)*

#### ***Vesting***

Participants are immediately fully vested in all voluntary contributions, including rollovers, and the earnings thereon. Participants become fully vested in Employer contributions after 4 years of service, as defined by the Plan. Participants also become fully vested upon death, disability or attainment of retirement age.

#### ***Payment of Benefits***

In-service withdrawals are permitted from all accounts that are 100% vested, excluding amounts held as security for a loan, upon the attainment of age 59½. Hardship withdrawals are also permitted from a participant's deferral account. Participants are entitled to their total vested account balance upon death, disability, retirement or termination of employment. A participant may elect to receive a lump-sum amount equal to the value of his or her accounts or in the form of the following: annuity or joint and survivor life annuity. If a participant's account does not exceed \$5,000, the Plan administrator shall distribute the entire account balance to the participant in a lump sum as soon as practical following a participant's severance from employment. Such distribution shall be made notwithstanding any other election or waiver in effect under the Plan.

#### ***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are generally up to five years (up to twenty years for the purchase of a primary residence). The loans bear an interest rate based on the quarterly prime interest rate adjusted by 1%. Principal and interest are repaid ratably through payroll.

#### ***Plan Loans***

Participants were allowed to take loans directly from Lincoln National secured by a participant's balance in the fixed rate annuity account. Principal and interest are paid directly to Lincoln National by the participant. In the fixed rate annuity loan collateral account, the balance earns interest, and as the loan is paid down, portions of the principal are moved from the loan collateral account to the participant's other investment accounts. The loans bear an interest rate based on the quarterly prime interest rate adjusted by 1%. Participants may only have one loan outstanding at any time. These loans are not Plan assets and totaled \$13,512 and \$13,119 at June 30, 2024 and 2023, respectively.

#### ***Forfeitures***

A participant who leaves the employ of the Employer forfeits any non-vested balance upon the earlier of five consecutive one-year breaks in service or the distribution of the entire vested portion of their account. Forfeited balances may be used to reduce Employer contributions and Plan expenses. As of June 30, 2024 and 2023, forfeited accounts yet to be used totaled \$17,839 and \$17,818, respectively. During 2024, \$1,990 was used to pay Plan expenses.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

In November 2007, the Department of Labor (“DOL”) issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting, disclosure, and audit requirements under Part 1 of Subtitle B of Title I of ERISA. The Plan, however, was established in 1994 and historically the Plan was viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Plan sponsor. Accordingly, various accounting and payroll records related to the Plan’s 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009 were not maintained by the Plan. Consequently, the financial statements have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, there can be no assurance as to the completeness or accuracy of the Plan’s reported financial information.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from those estimates.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of mutual fund investments are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Individual participant accounts are charged directly for loan recordkeeping and benefit disbursement processing fees, if applicable. Investment related expenses are included in net appreciation of fair value of investments.

#### ***Subsequent Events***

The Employer has evaluated subsequent events through April 4, 2025, the date that the financial statements were available to be issued. No significant items were noted for disclosure during this evaluation.

### **Note 3 - Information Certified by Custodians**

Plan investments are held by Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company (together "Lincoln"), the custodians of the Plan. The fair and contract values of the investments as of June 30, 2024 and 2023, and all investment transactions for the year ended June 30, 2024, including interest and dividend income and net appreciation in fair and contract values of investments are reported to the Plan and certified as complete and accurate by Lincoln. Information included in Schedule H, Line 4i - Schedule of Assets (Held at End of Year) and notes receivable from participants have also been derived from information certified by Lincoln.

The Plan offers investment choices to allow participants to create a diversified portfolio of assets based on the Participant's risk tolerance. Participants may invest their accounts in a combination of a fixed rate annuity, mutual funds and a stable value investment option.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Lincoln Fixed Rate Annuity***

The fixed rate annuity is a guaranteed investment contract and provides a guarantee of principal and a guaranteed minimum rate of interest. Fair value is based on discounted cash flows. Such interest rates are reviewed on a quarterly basis for resetting.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. For the year ended June 30, 2024, the crediting interest rate was 2.20%.

The fair values of accumulation units held by the Plan are based on each account's daily NAV. The NAV is based on the fair values of the underlying investments held by the fund less its liabilities. Data for NAVs are available daily to Plan administrators and client investors on Lincoln's website and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. These investments may be redeemed daily with one day's notice, with an annual cumulative percentage limit of 20% of the participant's account balance, with the exception of a participant's death, hardship, qualified domestic relations order, or to purchase an annuity option.

### Note 5 - Fully Benefit-Responsive Investment Contract

Following is a description of the investments and valuation methodologies for the fully benefit-responsive investment contract:

#### **Lincoln Stable Value Account**

The stable value account is a guaranteed investment contract and provides a guarantee of principal and a guaranteed minimum rate of interest. Fair value is based on discounted cash flows. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Such interest rates are reviewed on a quarterly basis for resetting.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. For the year ended June 30, 2024, the crediting interest rate was 2.00%.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### ***Note 6 - Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events such as an international conflict that could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### ***Note 7 - Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

### ***Note 8 - Tax Status***

The Plan adopted the Lincoln Retirement Services Company LLC, Volume Submitter 403(b) Plan document that received a favorable opinion letter on March 31, 2017 and, accordingly, has been deemed acceptable under Section 403(b) of the Internal Revenue Code ("IRC") for use by eligible Employers for the benefit of their employees. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently being designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***Note 9 - Related Party Transactions and Party-In-Interest Transactions***

Certain Plan investments are held by Lincoln, the insurance company/custodian of the Plan. Accordingly, these are considered exempt party-in-interest transactions. During the Plan year ended June 30, 2024, \$73,854 of administrative expenses was paid to Lincoln Financial Group Trust Company, Inc., Lincoln National Life Insurance Company and other service providers to the Plan. During the Plan year ended June 30, 2024, the Plan received revenue credit income of \$20,313 and is included in other income in the accompanying Statement of Changes in Net Assets Available for Benefits. The revenue credit income was used to pay a portion of the Plan expenses noted above. Notes receivable from participants also qualify as exempt party-in-interest transactions.

### ***Note 10 - Orphan Contracts***

The Plan has excluded from investments in the accompanying Statements of Net Assets Available for Benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The fair value of these assets at June 30, 2024 and 2023 is approximately \$389,000 and \$358,000, respectively. Investment earnings and distributions would have increased by approximately \$42,000 and \$12,000, respectively, for the Plan year ended June 30, 2024.
