We have performed audits of the financial statements of the Kruse Western Capital Accumulation Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of changes in net assets available for benefits for the period ended September 30, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 if the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting its financial statements to the liquidation basis. Our opinion is not modified with respect to that matter.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Kruse Western Capital Accumulation Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about Kruse Western Capital Accumulation Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters – Supplemental Schedules Required by ERISA**

The supplemental Schedule of Reportable Transactions, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

# Notes to Financial Statements

---

## Note 1: Description of Plan

The following brief description of the Kruse Western Capital Accumulation Plan (the Plan), formerly called Western Milling Employee Stock Ownership Plan, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### GENERAL

The Plan was established and became effective as of November 4, 2015 by Kruse Western, Inc. (the Company) to enable eligible employees to acquire stock ownership interest in the Company. The Plan operated as a leveraged employee stock ownership plan (ESOP) and has designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and it is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On November 4, 2015, the Plan purchased 2,000,000 shares of the Company's common stock with a loan of \$244,130,400 from the Company. The stock was purchased at a price of \$122.06 per share. The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company.

On June 9, 2022, the Company filed an amendment to freeze the Plan effective June 30, 2022. As part of this amendment, no individual that was not already a participant in the Plan shall be eligible to become a participant in the Plan; there would be no further contributions to the plan after the freeze date; no participant would accrue additional benefits under the Plan; and each participant with an undistributed account balance as of the freeze date that has not been previously forfeited would become 100% vested in their account balance.

On September 15, 2022, the Company terminated the Plan. The Plan Trustee entered into a Stock Purchase and Redemption Agreement with the Company and Kruse Western Enterprises, LLC to sell 400,000 shares of the Company's stock back at a price of \$125.00 per share, in exchange for the forgiveness of the outstanding indebtedness and the return of 1,600,000 unallocated shares of the Company stock. Distributions to participants started to occur in October 2022. The Plan elected to distribute 90% of the individual participant vested balance for the initial distribution. Subsequent distributions will occur after the Plan has received a favorable determination letter from the Internal Revenue Service (IRS) approving the Plan termination. The Plan received the favorable determination letter from the IRS on March 19, 2024.

Effective September 30, 2024, the Company liquidated all plan assets to the participants.

The trustee of the Plan is the GreatBanc Trust Company.

### **Note 1: Description of Plan (Continued)**

#### ELIGIBILITY AND PARTICIPATION

The Plan covers all of the employees of the Company and any controlled group of employers, except those covered by a collective bargaining agreement, leased employees or nonresident alien employees. As indicated in above, the Plan was frozen on June 9, 2022, which closed off the plan to new participants. No new participants have been admitted to the Plan since that date.

#### PARTICIPANT ACCOUNTS

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

#### PAYMENT OF BENEFITS

The Plan previously provided for the distribution of a participant's account upon normal retirement (age 65), disability, death, or termination of employment. However, the Plan was terminated as of September 15, 2022, and completely liquidated as of September 30, 2024. As part of the liquidation process, all participant accounts were fully distributed in accordance with the Plan's provisions and applicable regulations. No further benefits remain payable under the Plan, and the Company no longer has any repurchase obligations related to participant shares.

### **Note 2: Summary of Significant Accounting Policies**

#### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### USE OF ESTIMATES

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### INCOME RECOGNITION

Sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis.

#### ADMINISTRATIVE EXPENSES

As provided by the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan. In 2024, fees associated with each participant's withdrawal totaled \$29,725. These fees are the responsibility of the participants.

#### PAYMENT OF BENEFITS

Benefits are recorded when paid.

### **Note 3: Certification of Investment Information**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. GreatBanc Trust Company, Trustee, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information, presented in the accompanying statement of changes in net assets available for benefits for the period ended September 30, 2024, and the supplemental schedule of reportable transactions.

### **Note 4: Related Party and Party-In-Interest Transactions**

The Plan invested in Company common stock and had indebtedness guaranteed by the Company. These are related party and party in interest transactions. As described in Note 2, the Company pays all plan expenses, with the exception of fees associated with withdrawals. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

### **Note 5: Plan Tax Status**

The IRS has determined and informed the Company by a letter dated March 19, 2024, that the Plan is qualified and the Trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Company believes that the Plan is qualified and the related Trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

### **Note 6: Subsequent Events**

The Plan has considered the effect, if any, that subsequent events occurring through April 8, 2025, may have on the financial statements as presented. This date coincides with the date the financial statements were made available to be issued.
