Opinion

We have audited the accompanying financial statements of **Pruitt Corporation Employee Welfare Benefit Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits and statement of changes in benefit obligations for the year ended June 30, 2024, and the related notes to the financial statements.

Notes To Consolidated Financial Statements

NOTE 1. PLAN DESCRIPTION

The following description of the Pruitt Corporation Employee Welfare Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Pruitt Corporation Employee Welfare Benefit Plan is a Voluntary Employees' Beneficiary Association (VEBA) and is a single-employer plan. The VEBA is funded by a trust agreement established pursuant to Section 501(c)(9) of the Internal Revenue Code, which allows for the formation of such a plan.

The Plan (VEBA) provides health benefits (medical, hospital, surgical, major medical), dental, vision, supplemental life insurance coverage, disability benefits and flexible spending accounts, to and for the exclusive benefit of the employees of PruittHealth, Inc. and its affiliated companies and to the eligible dependents of such employees. The health insurance portion of the Plan is self-insured while the other benefits are purchased with premium payments. Participation in the Plan is available to all full-time employees having completed sixty days of employment.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company.

The Plan was amended effective January 1, 2012 to clarify that different employer contributions can be made with respect to employees of different participating employers in the Plan.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. See Note 9 for discussion of fair value measurements.

Payment of Benefits and Pharmacy Rebates

Claim payments are recorded when paid. Pharmacy rebates are recorded within benefits paid.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Stop-Loss Coverage

For the period from July 1, 2023 to December 31, 2023, the Plan had entered into a stop-loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). No such stop-loss arrangement was in place during the period from January 1, 2024 to June 30, 2024.

Benefit Obligations

The Plan has calculated its estimate of benefit obligations using subsequent period claims history and other relevant information provided by the third-party administrator. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Subsequent Events

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued, and has determined that no significant events occurred after June 30, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.

NOTE 3. FUNDING AND BENEFIT OBLIGATIONS

The Plan is self-insured for major medical coverage and is funded through employer and employee contributions. The lifetime individual maximum is unlimited. Prior to January 1, 2024, the Plan carried stop-loss insurance in order to limit its exposure. Beginning January 1, 2024, the Plan did not carry stop-loss insurance; thus, no amounts for the stop-loss arrangement are recorded in these financial statements.

The Plan records a liability for medical and prescription claims incurred but not reported as of the Plan year end (IBNR). The estimate is recorded at an amount based on a study performed by the Plan's actuary. This is the method preferred by the United States Department of Labor.

The Plan also records a liability for Flexible Spending Accounts (FSA) and Dependent Care claims incurred. This liability is determined by analysis of the claims paid from July 1, 2023 through June 30, 2024 with a service date prior to the Plan's June 30, 2024 year end. At June 30, 2024 and 2023, the accrued liability for all self-insured losses was \$2,870,630 and \$3,616,694, respectively.

Vision, dental, disability and life insurance coverages are provided through insurance carriers as part of the non-insured portion of the Plan and are funded through participant contributions.

The Plan has a COBRA program which is administered by the third-party administrator, Discovery Benefits. Discovery Benefits handles all billing and collection of premiums for the COBRA program.

NOTE 3. FUNDING AND BENEFIT OBLIGATIONS (CONTINUED)

The Plan allows for FSA for qualified medical and dependent care expenses. These accounts are administered by Elevance Health f/k/a Anthem Blue Cross Blue Shield ("Elevance"), a third-party administrator. The FSA accounts are "use-it-or-lose-it" plans, whereby the amounts in the account at the end of the plan year cannot be carried forward to the next plan year and are forfeited back to the sponsor. The Plan maintains a prefund deposit with Elevance based on 5% of total annual participant elections. The prefund amount at June 30, 2024 and 2023 was \$58,350.

Administrative costs of Elevance, the third-party administrator for the self-insured plan, are absorbed by the Plan. The Plan sponsor absorbs other administrative costs of the Plan, including legal and personnel expenses.

NOTE 4. PAYMENT OF BENEFITS

Premiums paid by the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statement of benefit obligations.

NOTE 5. TAX STATUS

The trust (VEBA) established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code per the exemption letter dated April 9, 1991, and, accordingly, the trust's net investment income is exempt from income taxes.

The trust has received a favorable determination letter from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. The Plan sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

It is the Plan's policy to account for any uncertainties in income tax law in accordance with FASB ASC 740, "Income Taxes", which clarifies the accounting for uncertain tax positions and requires that the Plan recognizes the impact of such a tax position in its financial statements if, upon ultimate settlement, that position is more likely than not to be sustained. The Plan has no unrelated business income (UBI). No such uncertain tax positions have been recognized by the Plan. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax purposes in progress.

NOTE 6. CONCENTRATIONS OF CREDIT RISK

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash accounts with various banks and bank sweep deposits. The Plan's deposit accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000 per banking institution at June 30, 2024 and 2023. At June 30, 2024 and 2023, the Plan had no uninsured balances.

NOTE 8. RISKS AND UNCERTAINTIES

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 9. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 9. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no assets measured at fair value as of June 30, 2024 and 2023.

NOTE 10. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has several arrangements with service providers, including Elevance for medical and pharmacy claims processing and Nativus Health Solutions ("Nativus") for pharmacy claims processing. These transactions are party-in-interest transactions under ERISA. For the year ended June 30, 2024, fees paid for these services to Elevance and Nativus totaled approximately \$2,247,000 and \$174,000, respectively, and were included in administrative expenses.

NOTE 11. PLAN TERMINATION

Although it has not expressed any intention to do so, the employer has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the employer or be used for purposes other than for the exclusive benefit of the Plan's participants.
