I am writing to inform you of a delay in finalizing the 2021 Solutions Advisors 401k plan audit. Two unforeseen circumstances have negatively impacted our ability to meet the targeted deadline:

1. **Solutions Advisors no longer has access to the payroll reporting software for 2021** - So unfortunately as a result, obtaining the payroll supporting documentation requested by the auditors has been a drawn out and time-consuming process.
2. **Unexpected Resource Constraints** - In Q3 of 2024 due to declining revenues, Solutions Advisors initiated a reduction in force plan which resulted in eliminating the positions of approximately 20% of the organization.

The 2021 plan audit remains ongoing and we are actively working with the auditors to address the open items needed to finalize the audit. However, as an organization we made the decision to file Form 5500 for the 2021 plan year even with the audit not yet finalized in order to participate in the Delinquent Filer Voluntary Compliance Program (DFVCP).


