Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Rovira Biscuit Corporation and Affiliates Profit Sharing & 1165 (e) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS
AS OF JUNE 30, 2024 AND 2023, AND FOR THE YEAR ENDED JUNE 30, 2024

1. DESCRIPTION OF THE PLAN

The following description of the **Rovira Biscuit Corporation and Affiliates Profit Sharing & 1165 (e) Plan** (formerly known as "Rovira Biscuit Corporation and Affiliates Retirement Plan") (the "**Plan**") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's information.

General — The Plan was established effective July 1, 1995. The Plan is a defined contribution plan covering substantially all employees of Rovira Biscuit Corporation and its affiliates, Ponce Can Company, Inc. and Rovira Foods Incorporated (collectively the "Companies" or "Sponsors"), who are not covered by another plan. The Board of Directors of the Companies has appointed the Retirement Plan Administration Committee to control and manage the operation and administration of the Plan.

The Plan is designed and operates in accordance regulations under the Puerto Rico Internal Revenue Code, as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions — Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Companies, (iii) discretionary contributions made by the Company, (iv) participant rollovers from another plan; and (v) profit sharing contribution made by the Companies.

Participants may elect to contribute a percentage of their compensation, excluding bonuses and commissions, to the Plan each year, subject to the limitations, as defined in the plan document. Such contributions are excluded from the participant's taxable income for Puerto Rico income tax purposes until received as a withdrawal or distribution from the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these additional contributions are ineligible for a Companies matching contribution.

The Companies makes a matching contribution to each participant's account equal to \$0.40 cents of each \$1.00 of the amount of the participant's salary reduction contribution. The maximum contribution amount eligible to be matched is 5% of eligible compensation as defined by the Plan. Additional profit-sharing amounts may be contributed at the discretion of the Companies' board of directors. No profit sharing contributions were made during the year-ended June 30, 2024 by the Companies to the Plan.

Participant Accounts — Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contribution and related matching and nonelective contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting — Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Companies' contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

Investments — Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers several mutual funds and a stable value fund.

Notes Receivable from Participants — Participants are not allowed to borrow from their accounts.

Payment of Benefits — On termination of service with the Companies (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or payments in monthly, quarterly, semiannual or annual installments over a period not to exceed 10-year period.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of twelve months.

Forfeited Accounts — When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future employer profit sharing contributions for the plan year. At June 30, 2024 and 2023, forfeited no vested accounts totaled \$42,037 and \$35,454, respectively. During 2024 and 2023, employer contributions were not reduced by forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses — Administrative expenses of the Plan are paid by the Plan Sponsor as provided in the plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Excess Contributions Payable — The Plan is required to return contributions received during the Plan year in excess of the IRC limits. Amounts payable to participants for excess contributions withheld by the Plan Sponsor are recorded as a liability with a corresponding reduction to contributions, due to the following: (1) an error in the deferral rate election, (2) withholdings in excess to the limits imposed by the 2011 PR Code, (3) failure to comply with ADP and ACP tests or (4) deferral withholdings for a period of up to 12 months following certain in-service withdrawals (financial hardship).

Payment of Benefits — Benefit payments to participants are recorded upon distribution. FASB ASC 962-205-50-1(i) requires disclosure for amounts allocated to accounts of persons who have elected to withdraw from the plan but have not yet been paid. These amounts shall not be reported as a liability on the statement of net assets available for benefits. At June 30, 2024 and 2023, \$27,255 and nil, respectively, balance allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid.

Expenses — Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Date of Management's Review of Subsequent Events — Subsequent events were evaluated through April 11, 2025, the date the financial statements were available to be issued. No events have occurred after June 30, 2024, but before April 11, 2025, the date the financial statements were available to be issued that require consideration as adjustments to or disclosures in the Plan's financial statements.

3. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques — Valuation technologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Money Market Funds — Valued at the amortized cost which approximate fair value.

Mutual Funds — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash Equivalents — Held primarily in short-term money market commingled funds, which are valued at cost plus accrued interest.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at June 30, 2024 and 2023.

Transfers Between Levels — The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended, June 30, 2024 and 2023, there were no transfers between levels.

4. INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

Certain unaudited information regarding the Plan as of June 30, 2024 and 2023 and included in the Plan's financial statements and supplemental schedules, was prepared by Banco Popular de Puerto Rico, custodian of the Plan's assets for the years ended June 30, 2024 and 2023. The information was furnished to the trustee of the Plan and to the plan administrator. The plan administrator has obtained a certification from the trustee, that such information, disclosed below, is complete and accurate, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA:

- Investments, at fair value, including cash and cash equivalents included in the accompanying Statements of Net Assets Available for Benefits of \$5,007,664 and \$4,706,239 as of June 30, 2024 and 2023, respectively,
- Net appreciation in fair value of investments (including net investment income), as reported in the accompanying Statement of Changes in Net Assets Available for Benefits of \$627,807 for the year ended June 30, 2024.
- All investment balances and investment information disclosed in Notes 3 and 5, excluding the classification of investments by level,
- All investments-related information, included in the accompanying Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year).

5. INVESTMENTS

During the year ended June 30, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$627,807.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The following transactions performed during the year 2023, qualified as party-in-interest transactions:

- Trustee, custodian and recordkeeping functions which are performed by Banco Popular de Puerto Rico Trust Division
- Certain administrative functions and transactions of the Plan, performed by Banco Popular de Puerto Rico Trust Division and fiduciaries, including employees of the Plan Sponsor and the administrative committee,
- Certain account balance fund options (BPPR Bank Deposit Open Account Variable Rate - Actual Rate 0.200% Participants Deposits, Banco Popular de Puerto Rico Cash Account) offered through a group contract by Banco Popular de Puerto Rico, the custodian and recordkeeper of the Plan, and also and Fidelity Government Cash Reserve cash account offered by Fidelity.
- Certain administrative and recordkeeping fees which were paid directly by the Plan's Sponsor. These fees, amounting to \$5,938 during 2024, are excluded from the statement of changes in net assets available for benefits.

Such transactions are exempt from being prohibited transactions under ERISA.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Companies has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. INCOME TAX STATUS

Effective January 1, 2019, the Plan adopted a prototype plan document sponsored by Popular Master Defined Contribution Retirement Plan Document and the Popular Master Trust established by Banco Popular de Puerto Rico. On June 15, 2020, a determination letter was requested from the Puerto Rico Treasury Department (the "PRTD"). The determination letter has not been received by the Plan yet, however the Companies and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Puerto Rico Internal Revenue Code, as amended, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department (the "PRTD"). The Plan is subject to routine audits by the PRTD; however, there are currently no audits for any tax periods in progress. Income tax returns are no longer subject to examination after four years after filing.

9. NONEXEMPT PARTY-IN-INTEREST TRANSACTION

Delinquent payment

During the year ended June 30, 2024, the Plan Sponsor did not remit certain participant contributions to the custodian on a timely fashion as required by the Department of Labor (DOL) Regulation 2510.3-102. Total participant contribution not remitted on a timely basis during the year ended June 30, 2024 amounted to \$11,543. Also, during the years ended June 30, 2023, 2022, 2021, 2019 and 2018, the Plan Sponsor did not remit certain participant contributions to the custodian on a timely fashion as required by the Department of Labor (DOL) Regulation 2510.3-102. Total participant contribution not remitted on a timely basis during the years ended June 30, 2023, 2022, 2021, 2019, 2018 and 2017 amounted to \$10,733, \$10,048, \$14,328, \$5,263, \$14,734 and \$11,465, respectively. The Plan is required to disclose the delinquent transactions until contribution is corrected.
