## Independent Auditor's Report

### The Plan Trustees The MAOF 403(b) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The MAOF 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1      DESCRIPTION OF THE PLAN**

The following description of The MAOF 403(b) Plan (the Plan) of the Mexican American Opportunity Foundation (the Plan Sponsor) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution retirement plan, as defined under Section 403(b) of the Internal Revenue Code (IRC). The Plan's purpose is to provide cash or a deferred benefit arrangement for participants and their beneficiaries. The Plan was established on July 1, 1997. On March 2, 2021, the Governing Board approved the restatement of the Plan effective July 1, 2019.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees are immediately eligible to participate in the Plan and may begin contributing to the Plan upon enrollment. However, employees are eligible for employer contributions after 90 days of service with the Plan Sponsor. Employees who normally work less than 20 hours a week are not eligible to participate in the Plan unless they are able to work at least 1,000 hours during the first year of employment or any subsequent plan year.

Each eligible employee shall become a participant in the Plan as of the earliest of (a) the effective date of the eligible employee's contribution agreement, and (b) the date on which the eligible employee submits the administrative forms necessary to make a rollover contribution.

**Contributions**

An employee makes before-tax payroll contributions to the Plan each payroll period subject to contribution limits allowed by the Internal Revenue Service (IRS). An employee who is age 50 or older before the end of a plan year can contribute an additional amount (a catch-up contribution) to the Plan subject to IRS limits.

The employer shall determine, in its sole discretion, the amount of employer matching contributions to be made each Plan year. The amount of such contributions is to be allocated to the account of each employee who is eligible for employer contributions. For the years ended June 30, 2024 and 2023, the employer's contribution was up to 5% of the non-highly compensated employee's annual eligible compensation or \$27.64 per pay period, whichever was greater. For highly compensated employees, the employer's contribution was 1.5% of the employee's annual eligible compensation with 6.5% supplemental of the employee's annual eligible compensation, a total of 8%.

Additionally, participants may rollover amounts representing distributions from other qualified retirement or profit sharing plans.

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**Participant Accounts**

Each employee's account is credited or charged with (a) the participant's contributions, (b) investment earnings or losses, (c) expenses, and (d) rollover contributions. Earnings or losses are allocated to the participants' accounts based on the proportion each account bears to the total of all account balances within each investment fund. The Plan offers the employees the opportunity to exercise control over their accounts by allowing them to choose from a wide range of investments, determine the manner in which assets will be invested and receive and access information necessary to make informed decisions with respect to the investment options under the Plan.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Participants who were hired by the Plan Sponsor as of June 30, 2010 are 100% vested in the Plan Sponsor's matching and discretionary contribution portion of their accounts and actual earnings or losses thereon. Participants who were hired after June 30, 2010 are 100% vested in the Plan Sponsor's matching and discretionary contributions after one year of service.

**Forfeitures**

Forfeitures from nonvested participant accounts are used to reduce future employer matching contributions. The changes in the Plan's forfeiture account balance for the years ended June 30, 2024 and 2023 are as follows:

**Payment of Benefits**

The value of a participant's account can be distributed upon the participant's normal retirement age (59 ½) unless specifically requested to be received at a later date. Upon termination of service, an employee may a) elect to receive a lump sum amount equal to the value of his or her account, b) receive annual installments over a set number of years, or c) delay receipt of benefits if the vested amount account balance is greater than \$5,000. Upon death, the beneficiary will be entitled to receive 100% of the participant's account.

While actively employed at the Plan Sponsor, a participant may be eligible to withdraw contributions from his or her account to meet a financial hardship per Plan provisions.

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**Notes Receivable from Participants**

Participants may borrow no more than twice in a given fiscal year against their vested account balance a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the excess of any outstanding loan balance within the previous 12 months.

Participant loans secured by the participant's investments in the insurance company's general account totaled \$1,209,541 and \$1,053,396 as of June 30, 2024 and 2023, respectively. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**Investment Options**

Participants may direct participant and employer contributions, as desired, in any of several investment options held by the custodian and may change their investment options daily.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition**

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value these investments. Shares of mutual funds held by the Plan are valued at their net asset value per share at the close of each business day.

Insurance contracts are stated at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts less any withdrawals. The Plan's investments in insurance contracts are guaranteed to earn at least a minimum rate of interest while invested in Variable Annuity Life Insurance Company's (VALIC) general account. Shares may be redeemed at any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Net Appreciation (Depreciation) in Fair Value of Investments**

Realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses had been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

**Benefits Paid to Participants**

Benefits are recorded when paid.

**Administrative Fees**

All usual and reasonable fees are paid by the Plan Sponsor, and any fees not paid by the Plan Sponsor may be paid from the Plan assets if not prohibited by applicable laws or regulations. Annual audit fees are paid by the Plan Sponsor.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3      FAIR VALUE MEASUREMENT**

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access, quoted prices for similar assets or liabilities in active markets and/or quoted prices for identical or similar assets or liabilities in inactive markets.

*Level 2* - Inputs to the valuation methodology include inputs other than quoted prices that are observable for the asset or liability and/or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023:

Mutual Funds – This category consists of publicly traded funds of registered investment companies. The net asset value of the mutual fund's shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan entered into fully benefit-responsive investment contracts with the VALIC, the custodian of the Plan. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer of the investment contracts is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contracts. The investment contracts are presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by VALIC, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the issuer of the contracts or otherwise. The contract value of the investment contracts on June 30, 2024 and 2023 was \$5,027,578 and \$8,895,534, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a monthly basis for resetting.

**NOTE 4 INVESTMENT CONTRACTS WITH INSURANCE COMPANY (CONTINUED)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan's management does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5 FINANCIAL INFORMATION CERTIFIED BY CUSTODIAN**

The Plan's asset information as of June 30, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified by VALIC, custodian, and American Trust Custody (ATC), custodian and trustee of the Plan. The Plan Administrator has obtained certifications from the custodians that information provided to the Plan Administrator by the custodians and trustee related to the Plan's assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

- Investments, as reflected in the Statements of Net Assets Available for Benefits as of June 30, 2024 and 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended June 30, 2024 and 2023;
- Investment information disclosed in Notes 3 and 4 of the Plan's financial statements; and,
- Investments, as reflected in Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of June 30, 2024.

**NOTE 6            INCOME TAX STATUS**

The Plan has adopted a volume submitter plan sponsored by Valic Retirement Services Company. The volume submitter plan provider has received an advisory letter dated April 5, 2018 from the IRS as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. Although the Plan has been amended since the volume submitter plan provider received the advisory letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of liability (asset) or disclosure in these financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7            RELATED PARTY TRANSACTIONS**

Certain investments of the Plan are shares on mutual funds and investment contracts managed by VALIC, ATC, and Mutual of America Life Insurance Company as defined by the Plan. Transactions in these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees paid by the Plan for investment advisory and recordkeeping services amounted to \$59,188 and \$6,644 for the years ended June 30, 2024 and 2023, respectively.

**NOTE 8            PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts and the net assets of the Plan will be allocated among the participants and their beneficiaries after payment of any expenses properly chargeable to the Plan, in accordance with the provisions of ERISA.

**NOTE 9            RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the various risk factors, in the near term, could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 10            SUBSEQUENT EVENTS**

The Plan Sponsor has evaluated events subsequent to June 30, 2024 to assess the need for potential recognition and/or disclosure in the financial statements. Such events were evaluated through April 9, 2025, the date the financial statements were available to be issued. Based upon this evaluation, it was determined that no subsequent events occurred that required recognition or additional disclosure in the financial statements.
