### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### 1. DESCRIPTION OF PLAN

The following description of Thrive Behavioral Health, Inc. Pension Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution 401(k) plan covering substantially all employees of Thrive Behavioral Health, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator and Retirement Plan Committee are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

#### b. Eligibility

Employees become eligible to participate in the Plan and receive discretionary matching contributions effective as of the first day of the calendar month subsequent to completing one month of service. Non-resident aliens and leased employees are excluded from participating in the Plan.

All participants who have completed at least eight hundred hours of service and are employed at the end of the year are eligible for the Plan Sponsor's discretionary profit-sharing contributions. Effective January 1, 2025, the SECURE Act of 2022 (SECURE Act 2.0) changed the eligibility service requirement to receive the Plan Sponsor's discretionary profit-sharing contribution for long-time part-time employees from 800 hours of service per year to 500 hours of service in the previous two consecutive years.

#### c. Contributions

Participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for participants to make post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). The Plan includes an auto-enrollment provision whereby all newly eligible employees, who do not affirmatively elect otherwise, are automatically enrolled in the Plan at 1%, and automatically increased 1% each year, up to 3% of eligible compensation. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor is not required to make contributions to the Plan but may make discretionary matching contributions. Discretionary matching contributions are allocated to participants based on the percentage of each employee's salary deferral. The Plan Sponsor made discretionary matching contributions of \$271,363 for the year ended June 30, 2024. The Plan Sponsor may also make discretionary profit-sharing contributions to the Plan. Discretionary profit-sharing contributions are allocated based on the ratio that each participants' compensation bears to the total of such eligible compensation of all participants. The Plan Sponsor did not make any discretionary profit-sharing contributions for the year ended June 30, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Plan Sponsor's discretionary matching and profit-sharing contributions, if any, and an allocation of plan earnings and net appreciation of investments and is charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Plan Sponsor's discretionary matching and profit-sharing contributions based on years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0%
2 years, but less than 3 years	25%
3 years, but less than 4 years	50%
4 years, but less than 5 years	75%
5 or more years	100%

A participant becomes fully vested upon death, disability, or attainment of normal retirement age.

#### f. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Participants may have two loans outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case the term is up to 30 years. The loans bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. Upon termination of service due to death, disability or retirement, a participant receives a lump-sum distribution. The Plan requires balances up to \$5,000 be paid out to participants upon termination. Effective January 1, 2024, the limit of involuntary distributions increased from \$5,000 to \$7,000 under the provisions of SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. Participant may request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeitures

Forfeitures represent non-vested Plan Sponsor discretionary matching and profit-sharing contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures are used to reduce future discretionary Plan Sponsor contributions or pay for plan expenses. The Plan had \$10,131 and \$8,767 of unallocated forfeitures as of June 30, 2024 and 2023, respectively. The Plan used \$25,419 of forfeitures to pay plan expenses and reduce Plan Sponsor discretionary matching contributions during the year ended June 30, 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

The assets of the Plan are invested in mutual funds and a common collective trust. Mutual funds are stated at fair market value as determined by the qualified institution, based upon the last reported sales price on the last business day of the plan year. The Plan's interest in the common collective trust is stated at net asset value (NAV) based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Gains and losses are recognized as incurred upon the sale or maturity of investments based on market value changes during the period.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Contributions

Contributions from plan participants and the Plan Sponsor's discretionary matching contributions are recorded in the year which the participant contributions are withheld from compensation. The Plan Sponsor's discretionary profit-sharing contributions are recorded when such contributions are authorized by the Plan Sponsor.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of June 30, 2024, there were \$1,695 of deemed distributions of participant loans included in benefit payments to participants in the accompanying statement of changes in net assets available for benefits.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of notes receivable and distributions are charged directly to the participant's account. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through April 11, 2025, which is the date the financial statements were available to be issued. Except as noted in Note 1b, there were no other events that met the criteria for recognition or disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of June 30, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date. *Fair Value Measurement* establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The following summarizes the fair value hierarchy:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The determination of where assets and liabilities fall within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of units of a collective trust. The NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the common collective trust will be sold for an amount different from NAV. As of June 30, 2024 and 2023, the Plan had no plans to sell the common collective trust at amounts different from NAV.

There have been no changes in the methodologies used at June 30, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. COMMON COLLECTIVE TRUST

The Plan's investment in the common collective trust (CCT) is represented by the CCT's underlying investment in the MetLife Reliance Stable Value Fund 25053 - Class 0, which invests in fully-benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts, synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT is not considered a fully-benefit-responsive investment contract and is reported at fair value (see Note 4).

### **6. TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated October 6, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with the applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions' however, there are currently no audits for any tax period in progress.

### **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### **8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions. The Plan has a service agreement with ADP Retirement Services, Inc., who has retained Reliance Trust Company, the qualified institution, as a subcontractor, to provide recordkeeping services for the Plan. Both ADP Retirement Services, Inc. and Reliance Trust Company are considered parties-in-interest.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to ADP Retirement Services, Inc., for its administrative services to the Plan. During the plan year ended June 30, 2024, the Plan paid the qualified institution, advisor, and other administrative service fees totaling \$68,278, which is presented net of \$1,282 of the revenue sharing credit in the statement of changes in net assets available for benefits. Amounts in the revenue sharing account will be used to pay administrative expenses of the Plan. As of June 30, 2024 and 2023, the balance in the revenue sharing account totaled \$2,272 and \$1,211, respectively, and is held in the common collective trust.

### **9. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in a number of investment securities. Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the statements of net assets available for benefits.
