Note 1 - Plan Description

The following description of the Evergreen Goodwill of Northwest Washington 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan established by Evergreen Goodwill of Northwest Washington (the Organization) under the provisions of Section 403(b) of the Internal Revenue Code (IRC) for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - All employees, excluding leased employees and all nonresident aliens who do not receive any compensation from U.S. sources, are eligible to make salary deferrals and receive employer contributions upon hire.

Contributions - Eligible employees may elect to defer up to 100% of their compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other eligible retirement plans.

The Organization may make discretionary employer contributions as determined by the Organization’s Board of Directors. For the plan years ending June 30, 2024 and 2023, the Board of Directors authorized discretionary matching contributions in the amount of 50% of the first 8% of compensation deferred into the Plan by each participant. The discretionary match is calculated and paid annually. Employees must be employed on the last day of the plan year to receive an allocation of the match unless the employee terminates employment as a result of death or disability, or terminates employment after reaching the Plan’s normal retirement age.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contribution, employer contributions, and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their contributions plus earnings thereon. Participants become vested in employer discretionary matching contributions based on years of credited services as follows:

Employees are credited with a year of service for each year in which they work at least 1,000 hours. Upon death, disability, or reaching retirement age, participants become fully vested in all account balances.

Forfeitures - At June 30, 2024 and 2023, the unallocated balance of forfeitures was \$1,182 and \$390, respectively. These amounts may be used to pay administrative expenses or reduce employer contributions. During the plan years ended June 30, 2024 and 2023, forfeitures in the amount of \$26,676 and \$13,761 were used to pay administrative expenses.

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loans are secured by the balance in participants' accounts. Loans must bear a reasonable rate of interest set at the time of borrowing. Loan terms range from one to five years, unless used for the purchase of a principal residence. In the event a loan is used to acquire a principal residence, the period of repayment shall in no event exceed 15 years or the repayment period currently in effect for a commercial home loan. Each loan is repaid through payroll deductions and the balance of the loan can be paid in full at any time.

Benefit Payments - Upon termination, death, disability, or retirement, a participant or their beneficiary may elect to receive the value of their vested account as a lump sum payment. Participants who have attained age 59 ½ may also elect to receive a distribution of their vested account balance prior to termination of employment (in-service withdrawals). The Plan also provides for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Benefits Paid to Participants - Benefits paid to participants are recognized when they are paid.

Investment Management Fees and Administrative Expenses - The Plan's investment options are subject to management fees based on a percentage of invested assets. All such fees are charged directly against the investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through April 10, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Fully Benefit-Responsive Investment Contract

The Plan invests in a fully benefit-responsive investment contract with Principal Life Insurance Company (Principal) that provides for full participant-directed liquidity and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Principal maintains contributions in its general investment account. The account is credited with earnings of the underlying investments and is charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based upon current market interest rates and are reset on a semiannual basis.

Certain events may limit the ability of the Plan to transact at the contract value with the issuer. For example, the contract has a surrender charge of 5% if the Organization terminates its interest in the contract without 12 months' advance notice. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Principal and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 - Certified Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2024 and 2023, and investment income or loss for the years then ended June 30, 2024, that is disclosed in the accompanying financial statements and supplementary information, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

The Plan holds a guaranteed investment contract with Principal as well as a mutual fund managed by an affiliate of Principal. Principal is the Plan’s recordkeeper. Therefore, transactions involving these investments qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 7 - Tax Status

The Organization adopted a Principal volume submitter 403(b) plan document. Principal received an approval letter from the IRS dated March 31, 2017, which states that the form of the plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan’s management believes that the Plan is currently designed and being operated in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for benefits.
