### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Los Angeles Tourism and Convention Board Retirement Income Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the statement of accumulated plan benefits as of June 30, 2023 and the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of the Plan

The following description of the Los Angeles Tourism & Convention Board Retirement Income Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a noncontributory defined benefit plan covering eligible employees of The Los Angeles Tourism & Convention Board (the "Board") and The Los Angeles Sports & Entertainment Commission ("LASEC"). As noted below, the Plan was retroactively amended in July 2018 to reflect its status as a multiple-employer plan, thereby including the Los Angeles Sports & Entertainment Commission. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective December 31, 2016, the Board amended the Plan to (1) close the Plan to employees hired after December 31, 2016, (2) freeze each participant's accrued benefit in the Plan as of December 31, 2016, (3) change the name of the Plan to Los Angeles Tourism & Convention Board Retirement Income Plan, and (4) change the definition of "Employer" to Los Angeles Tourism & Convention Board. Prior to the Plan's frozen status, participants were eligible to participate in the Plan on the January 1<sup>st</sup> or July 1<sup>st</sup> coincident with or immediately after reaching age 20-1/2 and completing one year of service.

#### *Plan Administration*

The trustee is Delaware Charter Guarantee and Trust Company, dba Principal Trust Company (the "Trustee"). The Board of Directors is responsible for oversight of the Plan. The Investment Committee, which is a committee of the Board of Directors, determines the appropriateness of the Plan's investments, monitors investment performance and reports to the Board of Directors.

#### *Funding Policy*

Section 412 of the Internal Revenue Code ("IRC") includes minimum funding requirements for defined benefit plans. The Board's policy is to meet these minimum funding requirements as determined by USI Consulting Group, the Plan's actuary (the "Actuary").

#### *Vesting*

##### *Normal Retirement - Prior to January 1, 2006*

Participants vest at a rate of 20% per year after one year of service and become fully vested after five years of service, as defined in the Plan document.

##### *Normal Retirement - Post January 1, 2006*

Participants become fully vested after five years of service, as defined in the Plan document.

#### *Distribution of Benefits*

Except as otherwise noted, participants who retired or terminated employment prior to January 1, 2006, were subject to the applicable sections of the Plan in effect at the time of their retirement or termination.

### *Normal Retirement Benefits - Prior to January 1, 2006*

The normal retirement date is the July 1<sup>st</sup> nearest to the participant's 62<sup>nd</sup> birthday. The monthly retirement benefit, payable during the participant's lifetime, is equal to 50% of the participant's average monthly compensation multiplied by a fraction where the numerator is the lesser of 15 and the participant's periods of service at retirement, and the denominator is 15.

### *Normal Retirement Benefits - Post January 1, 2006*

The normal retirement date is the July 1<sup>st</sup> nearest to the participant's 65<sup>th</sup> birthday. The monthly retirement benefit, payable during the participant's lifetime, is equal to the sum of the participant's pre-2006 retirement benefit, if any, and an amount equal to one percent of the participant's average monthly compensation multiplied by the participant's periods of service commencing on or after January 1, 2006, not to exceed 50% of the participant's average monthly compensation.

### *Optional Methods of Benefit Payment*

Subject to the consent of the participant's spouse, a participant may select an actuarially equivalent optional method of benefit payment, in lieu of the prescribed straight life income. The following options are available:

- Life annuity (normal form)
- Life annuity with 10 years certain
- Joint and survivor annuity (50%, 75%, or 100% continued to spouse or designated beneficiary)
- Lump sum - Available to non-highly compensated members. Highly compensated members' ability to receive lump sums is subject to various additional requirements. Lump sums for benefits earned after January 1, 2006 are limited to \$5,000.

### *Death Benefits*

For married participants, the surviving spouse shall receive a benefit computed as if the participant had terminated service on the day of death and elected a 50% joint and survivor annuity commencing on the earliest possible retirement date. If death occurs on or after the participant's earliest possible retirement date, the benefit is determined as if the participant had terminated on the day prior to death and elected a 50% joint and survivor annuity commencing on the 1<sup>st</sup> of the month immediately following the day of death.

No death benefit is provided to single participants.

### *Disability*

If a disabled participant has less than 5 years of vesting service, no benefit is provided by the Plan. A disabled participant that has completed 10 years of service may elect early retirement upon attaining age 55.

### *Other Termination of Employment*

If employment is otherwise terminated before retirement, death, or becoming fully vested after 5 years of service (post January 1, 2006), no benefit is provided by the Plan.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The present value of accumulated plan benefits is actuarially determined, and the method and assumptions of the valuations are discussed further in Note 6.

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. All other administrative expenses of the Plan are paid by the Company and excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

## **3. Certified Investment Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments and investment transactions for the years then ended,

was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedules, including assessing whether the supplemental schedules are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at June 30, 2024 or 2023. The following is a description of the valuation methodology used for assets measured at fair value:

*Pooled Separate Accounts:* Valued at fair value using the net asset value ("NAV") as a practical expedient which is determined based on the number of participation interests ("Unit") in the fund for that Plan's account. Principal Life Insurance Company determines the purchase price and redemption price of Units (the "Unit Value"). Pooled Separate Accounts are available through a group annuity contract with Principal Life Insurance Company. Principal Life Insurance Company

reserves the right to defer payments or transfers from the Principal Life Separate Accounts as described in the group annuity contracts providing access to the Separate Accounts or as required by applicable law. Such deferment will be based on factors that may include situations such as: unstable or disorderly financial markets; investment conditions which do not allow for orderly investment transactions; or investment, liquidity, and other risks, such as those associated with general and local economic conditions. There were no unfunded commitments as of June 30, 2024 and 2023. Further, the funds are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no investments required to be disclosed within the fair value hierarchy.

### 5. Contributions

The Board has agreed to make contributions to the Plan sufficient to provide the Plan with assets to pay pension benefits to participants, subject to the minimum funding requirements of ERISA and the maximum contribution limitations of the IRC. For the Plan years ended June 30, 2024 and 2023, the Plan was in compliance with the minimum funding requirements of ERISA. The value of the Plan's investments has a direct impact on its funded status. The actual impact, if any, and future required contributions cannot be determined at this time.

### 6. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the valuation date. Benefits payable under all circumstances—retirement, death, disability, and termination of employment—are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated Plan benefits.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations as of June 30, 2023 were (a) Pri-2012 Amount- Weighted White Collar with mortality improvement projected with Scale MP-2021, (b) the assumed average retirement age range of 55-67 and over, and (c) discount rate of 3.0%. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in

determining the actuarial present value of accumulated Plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of July 1, 2023. Had the valuations been performed as of June 30, 2023 there would be no material differences.

### 7. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Principal Trust Company. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

### 8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

As of June 30, 2024 and 2023, there were 3 investments held that individually accounted for more than 10% of total investments, respectively. See the supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at June 30, 2024.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

### 9. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions set forth in ERISA.

In the event the Plan terminates, the Plan's assets shall be used and applied first for the benefit of retired employees and employees who have reached their normal retirement dates, and second for the benefit of all other employees based on their accrued retirement benefits at the date of termination of the Plan in amounts proportionate to the actuarially determined present values of their retirement benefits at the date of termination of the Plan. Any balance remaining after satisfaction of all liabilities of the Plan shall be returned to the Plan sponsor.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation ("PBGC") if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

### **10. Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Plan by a letter dated September 15, 2016, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Plan management believes that the Plan and the related trust is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **11. Subsequent Events**

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

**Funding Method** Pure Unit Credit

The actuarial liabilities shown in this report are determined using software purchased from an outside vendor which was developed for this purpose. Certain information is entered into this model in order to generate the liabilities. These inputs include economic and non-economic assumptions, plan provisions, and census information. We rely on the coding within the software to value the liabilities using the actuarial methods and assumptions selected. Both the input to and the output from the model is checked for accuracy and reviewed for reasonableness.

**Employees Valued** Only participants as of the valuation date were valued.

**Changes in Assumptions and Methods since the Last Actuarial Valuation** Funding: No changes were made other than those to mortality and interest rates as required by law.

Interest Rate for developing Actuarial Value of Assets: Updated to use the plan's expected rate of return instead of the prior 3<sup>rd</sup> segment rate to develop Actuarial Value of Assets.

**Justification for Changes in Actuarial Assumptions** Interest Rate for developing Actuarial Value of Assets: Updated to use the plan's expected rate of return to match the ASC 960 discount rate. There was no impact to the overall Actuarial Value of Assets since it is limited to 110%

Compensation during any year may not exceed the indexed maximum permissible amount (\$245,000 in 2010). No compensation after December 31, 2016 will be recognized.
Normal Retirement – Prior Plan	<p><u>Condition:</u></p> <p>The normal retirement date is the July 1 nearest the participant's 62nd birthday.</p> <p><u>Benefit:</u></p> <p>The monthly retirement benefit, payable during the participant's lifetime, is equal to 50% of the participants' average monthly compensation multiplied by a fraction where the numerator is the lesser of 15 and the participant's service at retirement, and the denominator is 15.</p>

Normal Retirement –  
Current Plan

Condition:

The normal retirement date is the July 1 nearest the participant's 65th birthday.

Benefit:

The monthly retirement benefit, payable during the participant's lifetime, is equal to the sum of the participant's pre-2006 retirement benefit, if any, and an amount equal to one percent of the participant's average monthly Compensation multiplied by the participant's periods of service commencing on or after January 1, 2006, not to exceed 50% of the participants' average monthly compensation.

Early Retirement

Condition:

A participant may retire early on the first day of the month coincident with or next following attainment of age 55 and completion of 10 years of service.

Benefit:

The benefit, to commence at the participant's early retirement date, is the accrued benefit reduced by  $\frac{1}{2}\%$  for each month by which the early retirement date precedes the normal retirement date.

Delayed Retirement

Condition:

A participant's retirement may be deferred beyond the normal retirement age.

Benefit:

The benefit, payment of which commences at the participant's actual date of retirement, is computed in the same manner as the normal retirement benefit based upon service accrued and compensation earned through the date of retirement.

Termination of  
Employment with  
Vesting Service

If a participant terminates his employment after becoming partially or fully vested, he is entitled to a vested deferred retirement benefit commencing on his normal retirement date. The amount of the benefit is the accrued benefit multiplied by his vesting percentage, which is 0% for participants with less than 5 years of vesting service and 100% for participants with at least 5 years of vesting service.

**Death Before Retirement**

For married participants, the surviving spouse shall receive a benefit computed as if the participant had terminated service on the day of death and elected a 50% joint and survivor annuity commencing on the earliest possible retirement date. If death occurs on or after the participants earliest possible retirement date, the benefit is determined as if the participant had terminated on the day prior to death and elected a 50% joint and survivor annuity commencing on the 1st of the month immediately following the day of death.

No death benefit is provided to single participants.

**Disability**

The same as termination of employment with vesting service above, except the disabled member that has completed 10 years of service may elect early retirement upon attaining age 55.

**Other Termination of Employment**

If employment is otherwise terminated before retirement or death, no benefit is provided by the plan.

**Optional Methods of Benefit Payment**

Subject to the consent of the participant's spouse, a participant may select an actuarially equivalent optional method of benefit payment, in lieu of the prescribed straight life income. The following options are available:

1. Life annuity (normal form)
2. Life annuity with 10 years certain
3. Joint and survivor annuity (50%, 75%, or 100% continued to spouse or designated beneficiary)
4. Lump sum - Available to non-highly compensated members. Highly compensated members' ability to receive lump sums is subject to various additional requirements. Lump sums for benefits earned after January 1, 2006 are limited to \$5,000.

**Employer Contributions**

The employer contributes actuarially determined amounts to finance benefits.
