### **Opinion**

We have audited the accompanying financial statements of San Diego County Teamsters Health and Welfare Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The San Diego County Teamsters Health and Welfare Trust Fund (the "Plan") is a multiemployer health and welfare plan formed in 1966 under an agreement between the International Brotherhood of Teamsters, Local 36 and the contributing employers. The Plan provides health and other benefits to eligible participants and covered dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Continuation of Benefits (Bank Hours Provision)**

The Plan is required to provide benefits to certain active Plan participants, if such participants have accumulated credit amounts (bank hours) in excess of the hours required for current coverage. Under the Plan, a credit equal to three months coverage may be accumulated. The estimated liability is determined based on the Plan consultant's estimate of the average cost of benefits extended by bank hours accumulated.

**D. Employer Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

**E. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501 (c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Investment Valuation and Income Recognition**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The Plan administrator, Coast Benefits, Inc., shares common ownership with the Plan's legal counsel, Melissa W. Cook & Associates. The Plan paid \$60,000 in administrative fees and legal fees of \$25,375 and \$24,088 during the years ended June 30, 2024 and 2023, respectively.

**NOTE 5 - CONCENTRATION OF CREDIT RISK**

During the year ended June 30, 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

**NOTE 6 - PLAN TERMINATION**

Although there has been no expressed intent to do so, the Plan may be terminated in accordance with the provisions of ERISA and related regulations. In the event of termination of the Plan, the assets then remaining, after providing for the expense of the Plan and for the payment of any distributions already approved, shall be distributed among the participants.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The June 30, 2024 and 2023 employer contributions receivable included \$77,518 and \$71,067, respectively, from five and six significant employers, respectively. Employer contributions from these five and six employers totaled \$799,381 or 81% and \$579,098 or 76% of employer contributions for the years ended June 30, 2024 and 2023, respectively.

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investment. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risk in the near term would materially affect the amounts reported in the financial statements.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through March 27, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
