We have performed audits of the financial statements of the Zippy's 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) Description of Plan

The following description of the Zippy's 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan amended and restated effective July 1, 2021, by FCH Enterprises, Inc. (the Company), to provide benefits to eligible employees as defined in the plan document. Employees are generally eligible to participate in the Plan upon the earlier of: (1) the completion of one year of service (i.e., at least 1,000 hours of service within the 12 month computation period); or (2) the completion of three consecutive years of service measured by 500 hours of service per year (i.e., at least 500 hours of service per year in three consecutive 12 month computation periods) and are age twenty-one or older. Collective bargaining employees, nonresident aliens, leased employees, and independent contractors are not eligible to participate in the Plan. The Plan is subject to the provisions of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of Plan Assets

The Company has appointed a Retirement Plan Committee to manage the operation and administration of the Plan. Empower Trust Company, LLC (Empower) is the Plan's custodian. Empower Retirement maintains records of all the Plan's assets.

Contributions

Eligible employees of the Company are entitled to make salary deferrals to the Plan up to the lesser of 100% of the participant's eligible compensation or the maximum amount allowed by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified plans or individual retirement accounts. Additionally, participants who attain age 50 before the end of a calendar year may elect to make additional catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations, which was \$7,500 for the plan year ended June 30, 2024.

The Company, in its sole discretion, may make a discretionary Company match or profit sharing contributions as determined by the Company's board of directors. For the year ended June 30, 2024, the Company elected to make a discretionary Company matching contribution of 50% of the participant's deferral contribution to the Plan up to a maximum of 2% of the participant's eligible compensation. The Company did not elect to make any profit-sharing contributions for the year ended June 30, 2024. Employees are eligible for discretionary Company match or profit sharing contributions each year having completed 1,000 hours of service during the plan year and are employed on the last day of the plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of profit sharing contributions and plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Company's matching and profit sharing contribution portion of their accounts plus actual earnings or losses thereon is based on years of continuous service. Employees who were participants and completed at least three years of credited service as of the effective date of an amendment will be subject to the pre-amendment vesting schedule, if elected. All other employees will vest in their Company match and profit sharing contributions after five years of credited service in accordance with the following schedule:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance of the participant during the preceding 12 months or 50% of their vested account balance provided the loan is paid back with interest within five years. However, if the loan is for the purchase of a participant's principal residence, the plan administrator may permit a longer repayment term. The loans are secured by the vested balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Current interest rates range from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account. The plan also provides for hardship withdrawals and in service distributions subject to certain limitations.

Forfeited Accounts

As of June 30, 2024 and 2023, forfeited nonvested accounts totaled \$7,837 and \$9,188, respectively. These accounts will first be used to pay administrative expenses and any remaining forfeitures used to reduce future employer contributions. For the year ended June 30, 2024, forfeitures of \$3,835 were used to pay administrative expenses.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Cash Surrender Value of Life Insurance

Premium payments and changes in the cash surrender value of the life insurance policies are charged or credited to their respective accounts. The cash surrender value is determined annually by the insurer.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the respective participant's account and are included in administrative expenses. Participants are allocated a portion of custodial fees. Administrative expenses recorded in the Plan during the year ended June 30, 2024 totaled \$127,021. Investment related expenses are included in net appreciation in fair value of investments.

(4) Fair Value Measurements

The accounting guidance for fair value measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

The preceding measurement described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) General Account – Guaranteed Investment Account

The Plan invests in a fully benefit-responsive investment contract with EAIC. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract value of the investment contract as of June 30, 2024 and 2023 was \$2,294,421 and \$3,335,810, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

(6) Related-Party Transactions and Party-In-Interest Transactions

Notes receivable from participants are considered party-in-interest transactions. Certain plan investments represent units of mutual funds and a general account managed by Empower or an affiliate of Empower. Additionally, Empower receives revenue from investment providers for services Empower provides to the funds. This revenue is placed into a plan expense account and used to offset certain administrative expenses to the Plan. During the year ended June 30, 2024, the Plan applied \$54,799 to offset administrative expenses. These transactions, therefore, qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

(8) Tax Status

The Plan is based on the preapproved post-PPA model plan document sponsored by Carlsmith Ball LLP. The IRS has determined and informed Carlsmith Ball LLP, by a letter dated June 30, 2020 that the preapproved plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has subsequently been amended; however, in the opinion of the plan administrator and the Plan's tax counsel, the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

(10) Late Remittances

During the years ended June 30, 2024 and 2023, the Company failed to remit employee deferrals and loan repayments amounting to \$278,224 and \$646, respectively, to the Plan on a timely basis, according to Department of Labor regulations. All late deferrals and loan repayments have been remitted to the Plan. The Company is currently calculating lost earnings on the 2024 late remittances and will remit it to the Plan in 2025. The Company calculated lost earnings on the 2023 late remittances amounting to \$9 and remitted it to the Plan in December 2023.
