INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE A - DESCRIPTION OF PLAN

The following description of Anne Arundel Dermatology, P.A. (the “Company” and the “Plan Sponsor”) Profit Sharing Plan (the “Plan”), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have attained age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a qualified plan under the Internal Revenue Code (“IRC”) § 401(a) and 401(k) and is, therefore, exempt from federal income taxes under the provisions of IRC § 501(a). The Plan was amended during the year ended December 31, 2023, to add practices that were acquired as affiliated service groups or participating employers, which resulted in recognition of prior year service for employees of the acquired employers. In addition, the Plan was amended to permit rollovers of participant accounts as well as loans from specified plans. Effective January 1, 2023, the Plan was amended to remove the requirement of the safe harbor contribution. All safe harbor contributions are considered elective as of the date of the amendment.

Plan Merger

Effective March 28, 2024, the Plan was merged into the Aon Pooled Employer Plan (“Aon”). The total assets of the Plan transferred to Aon was \$65,289,696. Participants of the Plan should refer to the Aon official Plan documents for complete Plan information.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as well as up to 90 percent of any bonus, subject to limitations by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. In addition, the Plan allows for catch-up contributions for participants age 50 or older as permitted by the provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Trustees have elected safe harbor provisions, which allows the Company’s Board of Directors to make a nonelective Safe Harbor contribution, after the Plan year has commenced. Effective January 1, 2023, the Plan was amended to remove the requirement of the safe harbor contribution. Additional profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. In order to be eligible for these contributions, the participant must have attained age 21 and obtained one year (or 1,000 hours) of service. There was no profit-sharing contributions for the period January 1, 2024 through March 28, 2024 and for the year ended December 31, 2023. Qualified non-elective employer contributions were \$0 for the period January 1, 2024 through March 28, 2024, and \$2,456 for the year ended December 31, 2023.

Excess Contributions Payable

Amounts payable to participants in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase to distributions. Excess contributions payable of \$132,034 at December 31, 2023 were distributed in 2024.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions, employer contributions, if applicable, and allocations of the Plan's earnings and expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested accounts.

Vesting

Participants are immediately vested in participant and safe harbor contributions plus actual earnings thereon. Vesting for profit sharing contributions are based on the following vesting schedule. If, however, a participant dies, retires, or is permanently disabled, he/she will immediately become 100 percent vested in all employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Each participant may only have one loan outstanding at a time. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing interest rates charged on similar loans. Loan repayments are made through monthly payroll deductions. The repayment period of loans cannot exceed five years unless the proceeds are used to purchase the participant's principal residence, in which case longer loan terms are permitted. Notes receivable balances as of March 28, 2024 and December 31, 2023, were \$0 and \$470,084, respectively.

Payment of Benefits

Upon retirement, death, total disability, age 59½, or termination of employment, participants are entitled to the benefits in their separate accounts upon satisfaction of minimum distribution rules or proven financial hardship. Benefits will be paid in a lump sum. Hardship distributions are permitted if certain conditions are met. After the withdrawal, the participants may not make contributions to the Plan for six months.

Forfeited Accounts

Forfeitures may be used to pay plan expenses or to reduce employer contributions. No amount was used from forfeited non-vested accounts to pay plan expenses or reduce employer contributions during the period from January 1, 2024 through March 28, 2024, and for the year ended December 31, 2023, respectively. Forfeited non-vested accounts totaled \$0 and \$1,863, for the period from January 1, 2024 through March 28, 2024, and for the year ended December 31, 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through April 9, 2025, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. If a participant does not make loan repayments, and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of March 28, 2024, and December 31, 2023, management believes no allowance should be recorded as all loans outstanding have been deemed collectible. In addition, any delinquent notes receivable from participants that are unpaid are reported as deemed distributions on the Statements of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

Benefits

Benefits are recorded when paid.

Expenses

A portion of the operating expenses, including custodial, administrative, and other professional fees related to the Plan, are absorbed by the Plan Sponsor with the remainder paid by the Plan. Expenses paid for by the Plan Sponsor are excluded from the financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

Level 2 investments include a stable-value-collective trust fund. The value of the stable-value-collective trust fund is based on net asset value, which approximates fair value.

The Plan is subject to routine audits by tax authorities. The Plan's tax years of December 31, 2021 through March 28, 2024, remain subject to examination. There are currently no audits for any tax periods in progress.
