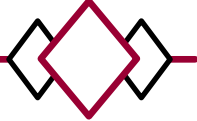

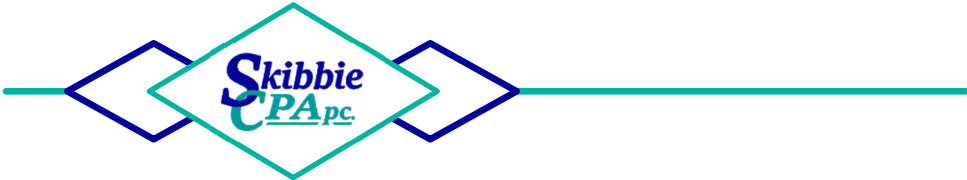

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Plan Management and Participants  
Davidson Academy 403(b) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Davidson Academy 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the ten months ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Davidson Academy 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of October 31, 2024 and December 31, 2023, and for the ten months ended October 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Davidson Academy 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Other Matter — Plan termination and liquidation***

During 2024, management of the Plan decided to discontinue contributions to the Plan and adopted the Tennessee Association of Independent Schools (TAIS) Multiple Employer Plan (MEP). As of October 31, 2024, all assets of the Plan were transferred to the TAIS MEP.

### Notes to Financial Statements

#### 1. Description of Plan

The following description of the Davidson Academy 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### *General*

The Plan was a 403(b) defined contribution plan covering all full-time employees of the Davidson Academy (the “Company”) with the exclusion of employees who normally worked less than 20 hours per week and student employees. Participants who had 1 year of service and were age 21 or older were eligible for Employer Matching contributions. The Plan was established on September 1, 1986 and is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA) as amended.

##### *Contributions*

Each year, participants could contribute pre-tax deferrals or Roth (after-tax) deferrals up to the dollar limit set by law and as defined in the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants also could contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions).

The Plan did not include an auto-enrollment provision. Eligible employees had to enroll if they wished to participate in the Plan.

The Company did not make safe harbor contributions to the Plan.

The Company made matching contributions equal to 100 percent of the first 3 percent of base compensation that a participant contributed to the Plan.

Participant and Company contributions were invested as directed by the participant from investment options offered by the Plan.

##### *Plan termination*

During 2024, management of the Plan decided to discontinue contributions to the Plan and adopted the Tennessee Association of Independent Schools (TAIS) Multiple Employer Plan (MEP). As of October 31, 2024, all assets of the Plan were transferred to the TAIS MEP.

### Notes to Financial Statements

#### 1. Description of Plan (continued...)

##### *Participant accounts*

Each participant's account was credited with the participant's contributions and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

##### *Vesting*

Participants were vested 100% immediately in their contributions and the Company's matching contributions plus actual earnings on the contributions.

##### *Notes receivable from participants*

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans were secured by the balance in the participant's account. At the time of the loan, the Administrator determined a reasonable rate of interest based on interest rates charged for similar types of loans by other lenders. The interest rate was fixed for the duration of the loan. Principal and interest was paid ratably through payroll deductions.

##### *Payment of benefits*

On termination of service, death, disability or retirement, a participant, or their beneficiary, could elect to receive distributions under the Plan, made in lump-sums. Participant consent was required only if the distribution is over \$5,000. In-service withdrawals could be taken after attaining age 59-1/2. Hardship withdrawals were not allowed.

##### *Forfeited accounts*

In the event that funds were forfeited, those forfeitures could be used to pay plan administrative expenses and/or used to reduce the Company's matching contributions. There were no forfeited account balances as of October 31, 2024, and December 31, 2023.

#### 2. Summary of Accounting Policies

##### *Basis of Accounting and Use of Estimates*

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America which require Plan management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments purchased and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Delinquent participant loans are recorded as distributions based upon the terms of the Plan documents.

##### *Payment Benefits*

Benefits are recorded when paid, except for material corrective distributions which are accrued during the year in which the originating contributions were made. The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan.

##### *Expenses*

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees charged directly to the participant's account are included in administrative expenses. Fund investment-related expenses are included in net appreciation of fair value of investments.

##### *Subsequent Events*

Plan management has evaluated events and transactions that occurred between October 31, 2024, and April 14, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

#### 3. Information Certified by the Plan Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of October 31, 2024, and December 31, 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of October 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the ten months ended October 31, 2024 has been reported to the Plan and certified as complete and accurate by the Plan's custodians, American United Life Insurance Company (AUL), a OneAmerica Company, and Teachers Insurance and Annuity Association of America (TIAA).

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### 4. Fair Value Measurements (continued...)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024, and December 31, 2023.

Pooled separate accounts. Investments in pooled separate accounts are valued using the unadjusted NAV as of the reporting date, which is the basis for current transactions. The NAV is used as a practical expedient to estimate fair value. Pooled separate accounts are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account. While the majority of the underlying assets values are based on quoted prices, NAV of the pooled separate accounts are not publicly quoted.

Collective Trust Funds: Valued at the NAV of the units held by the Plan at year-end. The NAV, as provided by the trustee/custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (issuances and redemptions) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require advance notification to ensure that securities liquidations will be carried out in an orderly business manner.

AUL Stable Value Account: a group fixed annuity, issued by American United Life Insurance Company. The Stable Value Account is provided through an AUL Group Annuity Contract and is supported by the general account of AUL. It is not a separate account, and plan participants do not own units, any portion of, or any entitlement to the AUL general account. The unit value for the Stable Value Account equals its previous daily unit value multiplied by 1 plus the daily equivalent of the guaranteed annual effective rate of interest credited on a daily basis to the Stable Value Account. A plan participant's Stable Value Account balance equals the number of units he or she has times the current unit value.

TIAA Traditional Annuity. A guaranteed annuity issued by Teachers Insurance and Annuity Association of America (TIAA) that is valued at Contract Value (see Note 5).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. TIAA Traditional Annuity

The TIAA Traditional Annuity is a guaranteed annuity issued by Teachers Insurance and Annuity Association of America (TIAA) that is valued at Contract Value. It is designed to be a core component of a diversified retirement savings portfolio. TIAA Traditional is designed primarily to help meet long-term retirement income needs; it is not a short-term savings vehicle. Therefore, some contracts require that benefits are generally paid in 10 annual or 84 monthly installments and, when lump sums are permitted, impose surrender charges on these withdrawals. These provisions are designed to allow the TIAA General Account, which backs the guarantees and benefits under TIAA Traditional, to invest in longer-term illiquid assets that often offer enhanced returns versus shorter-term, more liquid assets. For additional information, please check with one of TIAA's advisors.

The contract value is generally the amount a participant would receive if he or she initiated a withdrawal or transfer from the contract under the provisions of the Plan. The Contract values were...

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and other events that result in distributions exceeding a set amount. Currently, Plan management believes that the occurrence of an event that would cause the Plan to make distributions at less than contract value is not probable.

#### 6. Rollover Contributions

The Plan accepted a rollover, provided the rollover did not jeopardize the tax-exempt status of the Plan or create adverse tax consequences for the Employer. The amounts rolled over were separately accounted for in a "Participant's Rollover Account." For purposes of this Section, the term Participant included any Eligible Employee who was not yet a Participant.

#### 7. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts or collective trust funds managed by American United Life Insurance Company (AUL), a OneAmerica Company, and Teachers Insurance and Annuity Association of America (TIAA), the custodians as defined by the Plan. Fees incurred within these investments qualify as party-in-interest transactions. Investment fees paid to parties-in-interest are netted against investment returns. These fees included investment fees, third party administrative fees, and other professional service fees, and are based on customary charges as agreed upon by the Plan. These transactions qualify as party-in-interest transactions for which there is a statutory exemption. Certain administrative functions were performed by officers or employees of the Plan's sponsor. No such officer or employee received compensation from the Plan.

#### 8. Tax Status

Although the Plan has not received a determination letter from the Internal Revenue Service, it has adopted a pre-approved Prototype Plan. The Plan was amended and the Plan administrator believes that the Plan was designed, and was being operated, in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believes that the Plan was qualified and that the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS/DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions.

The Plan was designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator believes that terms of the Plan had been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Plan was required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

#### **9. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **10. Reconciliation of Financial Statements to Form 5500**

Certain differences may exist between the recording of accruals for financial reporting purposes and IRS/Department of Labor's (DOL) Form 5500 purposes. There were no such differences as of October 31, 2024, and December 31, 2023.
