Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of U.A. Local No. 159 Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023; the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended; and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of U.A. Local No. 159 Health and Welfare Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received. Reciprocity is recorded when employer contributions, income or payments are identified.

Reciprocity Agreements

The Plan has reciprocity agreements with other certain employers bound to collective bargaining agreements with the United Association of Journeymen and Apprentices of the Plumbing and Pipe Fitting Industry of the United States and Canada. In accordance with these agreements, the Plan is required to remit funds received and is entitled to receive funds from participating employers on behalf of temporary employees to and from the employees' participating local unions.

For the years ended June 30, 2024 and 2023, the Plan remitted \$65,893 and \$100,330, respectively, of reciprocal cash payments and received \$524,385 and \$765,473, respectively, of reciprocal cash payments in accordance with these agreements with the participating local unions. Reciprocal payments received are included in the employer contributions in the statements of changes in net assets available for benefits. No allowance for credit losses as of June 30, 2024 and 2023, was necessary for reciprocal payments due to the Plan. Payments made to other plans for reciprocal contributions collected on behalf of those plans are recorded as a reduction to the reciprocal contributions payable account and are not included in the statements of changes in net assets available for benefits as they do not represent an expense of the Plan.

Investment Valuation, Transactions and Income Recognition

General

Investments are reported at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific method used for the Plan's investment class is presented below.

Mutual Funds: The fair value of mutual funds is generally based on quoted market prices in active markets (Level 1).

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Current Benefit Obligations

Premiums payable was based on actual premiums paid subsequent to year-end for June and prior eligibility. The obligation for claims payable and incurred but not reported was estimated by the Plan's administrator based on claims experience.

Accumulated Eligibility Credits

Accumulated eligibility credits includes the Plan's estimated liability as of June 30, 2024 and 2023, for group insurance premiums and self-funded claims. The liability is based on actual premiums, claims and related administrative expenses for eligibility earned as of June 30, 2024 and 2023, to provide coverage for July through August.

Accumulated eligibility credits also includes the Plan's estimated "bank" liability as of June 30, 2024 and 2023, which was based upon the total number of months of eligibility banked as of June 30, multiplied by the estimated monthly cost to provide benefits.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The actuarial present value of accumulated Plan benefits is calculated based on certain assumptions pertaining to interest rates, participant demographics and other assumptions, all of which are subject to change. Due to the inherent uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the disclosure to the financial statements of the actuarial present value of accumulated Plan benefits.

The Plan invests in mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with these investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Accounting Pronouncements Currently Adopted

In June 2016, the FASB issued an Accounting Standards Update (“ASU”) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure, and other financial instruments recorded at amortized cost. The Plan adopted the new standard effective July 1, 2023, using the modified retrospective approach. Upon adoption, there was no cumulative-effect adjustment to the opening balance of net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The Plan, which is a successor to Bay Area Pipe Trades Health and Welfare Plan, was established during 1993 as a result of collective bargaining agreements. The Plan provides medical and prescription drug benefits through insured arrangements with Kaiser, Blue Shield, and United Healthcare. The Plan provides dental and vision benefits through insured arrangements with Delta Dental and VSP.

To become initially eligible for benefits, participants must be employed by one or more contributing employer, work within the jurisdiction of the local union, and have completed the number of hours of employment as dictated by their industry classification for which contributions are made on their behalf.

The Plan provides eligibility on a skip-month method whereby hours worked in one month are utilized to provide coverage for benefits starting the first day of the following second month. Hours reported in excess of those necessary to provide an active employee with monthly coverage are accumulated in a “bank” to provide eligibility during periods of unemployment or disability. During the years ended June 30, 2024 and 2023, the maximum “bank” allowed under the Plan was six months of eligibility.

The Plan established a Health Reimbursement Account (“HRA”) based on contributions from certain employers on behalf of eligible participants. The HRA accounts are separate from other contributions and hour-bank eligibilities of the Plan. HRA accounts may be credited (or charged) with income (or loss) at the discretion of the Board of Trustees. The Plan is not permitted to refund any of the balances to the participants, and the amounts can only be used for qualified expenses, as outlined in the Plan Documents.

The Plan received HRA contributions totaling \$533,572 and \$548,509 and paid HRA benefits to participants totaling \$472,432 and \$419,775 for the years ended June 30, 2024 and 2023, respectively. HRA contributions are included in employer contributions on the statements of changes in net assets available for benefits. The HRA asset balance is included in cash and investments on the statements of net assets available for benefits as of June 30, 2024 and 2023. The HRA asset balance as of June 30, 2024 and 2023, totaled approximately \$3,464,000 and \$3,419,000 respectively.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act ("COBRA"), has been adopted by the Plan.

Certain retiree benefits are being funded by current employer contributions and monthly co-payments from retirees. Retiree benefits are neither pre-funded nor vested. Retiree coverage shall be limited to funds available for retiree benefits, as determined by the Trustees. If contributions under the collective bargaining agreements become inadequate to maintain retiree benefits, the Trustees have the right to reduce benefits and/or increase self-pay charges or to terminate retiree coverage. The costs of the post-retirement benefit plan are shared by the Plan and retirees.

Employees may contribute specified amounts, determined periodically by the Plan's actuary, to extend coverage to eligible dependents. The cost of the post-retirement benefit plan is shared by the Plan's participating employers and retirees. In addition to deductibles and co-payments, for the both years ended June 30, 2024 and 2023, 22% of the estimated cost of providing post-retirement benefits in the current and prior years was through retiree contributions.

3. PRIORITIES UPON TERMINATION

Participants should refer to the Summary Plan Description for more complete information. The Plan's Board of Trustees has the right under the Plan to modify or discontinue any benefit provided.

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated November 20, 2019, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by contributions from employers and retirees and from members electing COBRA coverage. The contribution rates are established annually by the Board of Trustees based, in part, upon studies and recommendations by the Plan's consultant and on the applicable collective bargaining agreements.

The Plan places its cash with financial institutions deemed to be creditworthy. Cash balances may at times exceed the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations, and cash flows.

7. RELATED PARTY TRANSACTIONS

The Plan pays U.A. Local 159 (the "Local") an allocated percentage for certain administrative services they provide to the Plan. For each of the years ended June 30, 2024 and 2023, the amount paid to the Local totaled \$99,000. The Plan is related to the Local in that several of the Plan's trustees are also members of the Local's executive board.

Employer contributions for the various U.A. Local 159 Trust Funds are initially deposited into a transit account. Contributions are then allocated and transferred to the Plan based on hours worked by Plan participants. As of June 30, 2024 and 2023, contributions allocated but not yet transferred totaled approximately \$574,000 and \$643,000, respectively, and are included with cash in the statements of net assets available for benefits.

9. SUPPLEMENTAL BONUS BENEFITS

The Plan provides supplemental bonus benefits to eligible residential plumber participants. The benefits are funded through employer contributions, which are designated by the bargaining parties. The designated employer contributions are then allocated to eligible participants, in proportion to their hours of residential plumbing work. The benefits are paid once a year, in December, based on contributions received during the “determination” year (September 30).

For the years ended June 30, 2024 and 2023, self-funded benefits included supplemental bonus benefits totaling approximately \$83,000 and \$79,000, respectively, based on designated employer contributions for residential plumbing hours worked.

10. POST-RETIREMENT BENEFIT OBLIGATIONS

The amount reported as the post-retirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees’ service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Post-retirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee’s full eligibility date, the post-retirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that employee’s service in the industry rendered to the valuation date.

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the post-retirement benefit obligations as of June 30, 2024 and 2023, by \$6,451,100 and \$6,553,400, respectively.

For the year ended June 30, 2024, changes in actuarial assumptions and methods accounted for approximately \$346,600 increase. The increase was the net effect of increase due to updated mortality rates and decrease due to raising the discount rate from 5.00% to 5.25% reflecting the change in available rates of return on high-quality fixed income investments as of the valuation date.

For the year ended June 30, 2023, changes in actuarial assumptions and methods accounted for approximately \$2.93 million decrease. The decrease was due to updated mortality rates and raising the discount rate from 4.50% to 5.00% reflecting the change in available rates of return on high-quality fixed income investments as of the valuation date.
