### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of the Area Agency on Aging 11, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Area Agency on Aging 11, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from Newport Trust Company, a qualified institution, as of June 30, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

## Note A - Description of Plan

The following description of the Area Agency on Aging 11, Inc. Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### General

The Plan is a defined contribution plan with a 401(k) provision covering all employees of Direction Home of Eastern Ohio (formerly known as Area Agency on Aging 11, Inc.) (the Agency) who are 21 years of age or older. Employees are immediately eligible to make salary deferrals and to receive the employer-matching and discretionary contributions. The Company may also make discretionary contributions to the Plan for Participants who have met the deferral and matching eligibility and are also employed by the Company on the last day of the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

Under the Plan’s provisions, each participant may contribute a percent of his or her base pay not to exceed the maximum dollar limit in effect for such calendar year in accordance with the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans. The Agency will make matching contributions for the employees who make contributions to the Plan out of their base pay. The matching contribution is 100% of the first 1% of employees’ voluntary contributions. Any additional discretionary retirement plan contributions are determined by the Board of Trustees. Upon enrollment in the Plan, a participant may direct employee contributions and company-matching contributions in any of the available investment options. Participants may change their investment options at their discretion. All the balances in the Plan represent participant-directed investments. Additional profit-sharing amounts may be contributed at the option of the Agency’s Board of Trustees. During the plan years ended June 30, 2024 and 2023, the Agency made profit-sharing contributions to the Plan in the amounts of \$514,282 and \$476,814, respectively. Contributions are subject to certain IRS limitations.

### Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant’s vested account.

### Vesting

Vesting in participant accounts relating to the Agency-matching contributions is based on the years of continuous service. A participant is 100% vested in the Agency contribution after three years of credited service. 1,000 hours worked during the Plan year equals a year of credited service. Participants are immediately vested in their deferrals and contributions rolled over from other qualified defined-benefit or contribution plans, plus actual earnings thereon.

### Notes Receivable from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less, with maturity dates not in excess of five years. The loans are collateralized by the balance in the participant’s account and bear interest. The interest rate is set at an initial rate of Prime plus 2% and then fixed for the duration of the loan at that rate. Interest rates for loans outstanding in the current year range from 5.25-10.00%, with maturity dates ranging from September 2023 - February 2027. The participant is required to repay principal and interest ratably through payroll deductions based on payroll frequency.

## Note A - Description of Plan (continued)

### Payment of Benefits

Amounts contributed through salary reductions may be withdrawn by, or distributed to, a participant only upon (1) termination of employment or (2) attaining the age of 59 ½. Withdrawals prior to attaining age 59 ½ are not permitted, except in the event of retirement or as a hardship distribution. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purpose and for in-service withdrawals for childbirth and adoption expense. Roth elective deferrals are not available for hardship withdrawals. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½.

On termination of services due to death, disability, retirement or due to other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

### Forfeited Accounts

Forfeited accounts may be used to pay administrative expenses, such as accounting fees, and/or reduce future employer contributions. At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$1,122 and \$16,151. Forfeited non-vested accounts were used to pay plan fees and employer matching contributions in the amounts of \$30,400 and \$31,835 for the years then ended.

## Note B - Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Recently Adopted Accounting Standards

#### Allowance for Credit Losses

During the year ended June 30, 2024, the Plan adopted the provision of the Accounting Standards Codification (ASC) 326 Financial Instruments - Credit Losses. This replaced the incurred loss methodology with an expected loss methodology that is referred as the current expected loss (CECL) methodology. This methodology requires the immediate recognition of the estimated expected credit losses over the life of a financial instrument, including the participant and employer contributions. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events. The Plan adopted the standard effective July 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

### Participant Contribution Receivable

Participant contributions receivable represent participant deferrals withheld prior to June 30, 2024 and 2023. The balance is based on actual collections subsequent to year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

### Employer Contribution Receivable

Employer contributions receivable represent employer matching contributions related to participant deferrals withheld prior to June 30, 2024 and 2023, as well as any discretionary profit sharing contributions approved during the years then ended. The balance is based on actual collections subsequent to year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the stable value fund valued at contract value, as disclosed in Note D. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note E for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions and Agency-matching contributions in any of the available investment options. The Agency currently offers several mutual fund investment options for the participants. Participants may change their investment options at their discretion. All the balances in the Plan represent participant-directed investments.

### Payment of Benefits

Benefits are recorded upon distribution.

### Administrative Expenses

The Plan's expenses are paid by either the Plan or the Agency, as provided by the plan document. Expenses that are paid directly by the Agency are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Fees related to benefits paid to participants and for the administration of notes receivable from participants are charged directly to the participant's account and are not included in administrative expenses. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

## Note C - Information Prepared and Certified by the Custodians

The June 30, 2024 and 2023 statements of net assets available for benefits, the investment activities included on the related statements of changes in net assets available for benefits for the years then ended, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the custodians in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's investments were held in custodial accounts maintained by Newport Trust Company for the years ended June 30, 2024 and 2023. For the years ended June 30, 2024 and 2023, these certified investments amounted to \$8,572,027 and \$7,753,738 respectively. Total investment income amounted to \$978,970 and \$721,468, respectively, for the years ended June 30, 2024 and 2023.

Plan management obtained certifications from Newport Trust Company for the years ended June 30, 2024 and 2023. The Plan's independent certified public accountants did not perform audit procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

## Note D - Stable Value Fund

The Plan invests in a common collective trust fund, Morley Stable Value Fund, whose underlying assets are fully benefit-responsive investment contracts. This stable value fund seeks to provide preservation of capital and relatively stable returns by investing primarily in short-term investments and investment-grade stable value investment contracts. The underlying investments of the Morley Stable Value Fund consist of Conventional Guaranteed Investment Contracts ("GICs") and Synthetic Guaranteed Investment Contracts (wrap contracts) and cash equivalents. The GICs are typically issued with a fixed crediting rate and a fixed maturity date that does not change over the life of the contract. Whereas, wrap contracts typically reset on a monthly or quarterly basis as negotiated with the issuer and do not have a final stated maturity date. Gains and losses on the underlying portfolio are amortized over the duration of the investment, through adjustments to the future interest crediting rate. The rate of return based on actual earnings for the contract for the year ended June 30, 2024 was 6.88%. A number of factors can influence future crediting rates of wrap contracts, which may include but are not limited to: portfolio cash flows, underlying portfolio performance, current market interest rates for reinvestment, duration posture, change in credit ratings, default or bankruptcy by an asset or wrap issuer, the unexpected receipt of principal and interest payments, extraordinary withdrawals, and certain wrap contract terms, including wrap fees.

## Note E - Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of value hierarchy under FASB ASC Topic 820 are described as follows:

### Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

### Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are delivered principally from or corroborated by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used to maximize the use of observable inputs and minimize the use of unobservable measurements.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds - Valued at daily closing price as reported the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are reported as Level 1.

The preceding method described may produce fair value calculations that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

## Note G - Tax Status

The Plan is relying on IRS approval of the pre-approved plan it has adopted. The IRS has determined and informed the pre-approved plan sponsor by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended from the original pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the IRC, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

## Note H - Risks and Uncertainties

### Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

## Note I - Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others.

Newport Trust Company, the custodian of the Plan, provides recordkeeping and custodial services to the Plan. Quarterly fees are charged to the Plan, included in administrative fees, totaling \$21,320 and \$28,232 for the Plan years ended June 30, 2024 and 2023, respectively.

CBIZ Investment Advisory Services provides investment advisory services to the Plan. Fees charged to the Plan, included in administrative fees, is \$12,154 and \$11,194 for the years ended June 30, 2024 and 2023, respectively.

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions. Loan balances total \$103,335 and \$120,836 for the Plan years ended June 30, 2024 and 2023, respectively. Interest income earned related to these loans totaled \$9,325 and \$5,805 for the years then ended.
