#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Concepts of Independence, Inc. Supplemental Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of Plan**

The following description of the Concepts of Independence, Inc. Supplemental Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a non-contributory defined contribution plan covering employees of Concepts of Independence, Inc. (the "Employer" or "Plan Sponsor") and Concepts of Independent Choices, Inc., a related not-for-profit corporation, as defined in the Plan document. Excluded employees include: employees covered by a member of the controlled and/or affiliated service group Employer whose Employer does not affirmatively adopt the Plan, any other employees covered under the Concepts of Independence, Inc. Staff Profit Sharing Plan. An employee is eligible to participate in the Plan upon attainment of age eighteen or older and for employees hired on or after July 1, 2016 after 2 years of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

The Employer may make discretionary contributions as determined by the Board of Trustees of the Plan sponsor. Contributions are allocated to each eligible employee, who has completed at least 1000 hours in the Plan year, based on their annual service hours, as defined in the Plan document. There was no discretionary contribution made to the Plan for the year ended June 30, 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans.

***Vesting***

A participant is 100% vested in Employer contributions including allocated earnings thereon at all times.

***Participant Accounts***

Each participant's account is credited with the discretionary Employer's contribution, allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined in the Plan document.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account, in the form of a lump sum distribution, installment payments or an annuity distribution. A participant may request an in-service distribution once they have reached age 59 ½. In the event of a hardship distribution, only the participant's nonelective deferrals and earnings thereon are eligible to be distributed.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price and are deemed to be actively traded. The guaranteed interest account is valued at contract value, which represents contributions made plus credited interest less participant withdrawals and fees. Interest-bearing cash is valued at amortized cost which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Expenses***

Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Plan service charges and audit fees are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Expenses are recorded when they are accrued.

***Payment of Benefits***

Benefits are recorded when paid.

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 11, 2025.

**3. Information Certified (Unaudited) and Audited**

Certain information related to investments, which is listed in the unaudited and certified column below, and included in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, net appreciation in fair value of investments and interest and dividends for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York (“Empower Life & Annuity”) and Empower Trust Company, LLC, qualified institutions.

The Plan held a nonparticipant-directed interest bearing cash account of which the balance as of June, 2024 and 2023 and the activity and interest income for the year ended June 30, 2024 is not certified (Audited).

### 5. Guaranteed Interest Account

The Plan has a benefit-responsive investment contract with Empower Life & Annuity. The Guaranteed Interest Account (the "GIA") is provided through a group annuity contract (the "Contract"). The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or more than 3%. The average yield earned by the Plan for 2023 is 1.73% and for 2024 is 1.75%. The crediting rate is reviewed on a 6 basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Participants ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The group annuity contract represents 1.68% and 2.51% of the total investments as on June 30, 2024 and 2023. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investor Service (Aa3 as of March 2025), A.M. Best Company (A+ as of March 2025), Fitch (AA as of March 2025), and Standard and Poor's (AA as of March 2025).

### 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **7. Tax Status**

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, Empower Retirement LLC, dated November 14, 2022, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code (“IRC”). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **8. Party-in-Interest Transactions**

The group annuity contract was issued by Empower Life & Annuity, a custodian of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Empower was paid \$104,384 in fees during the June 30, 2024 plan year.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of cash on deposit with a financial institution. Deposits held at financial institutions insured by the Federal Deposit Insurance Corporation (“FDIC”) are insured up to \$250,000. At times cash balances may exceed the FDIC limit. As of June 20, 2024 and 2023, the Plan’s uninsured cash balance on deposit totaled approximately \$135,000 and \$179,000.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan’s net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan’s net assets available for benefits cannot be predicted.
