### **Report on the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Concepts of Independence, Inc. Staff Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **1. Description of Plan**

The following description of the Concepts of Independence, Inc. Staff Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a non-contributory defined contribution plan covering eligible employees of Concepts of Independence, Inc. (the "Employer" or "Plan Sponsor") and Concepts of Independent Choices, Inc., a related not-for-profit corporation, as defined in the Plan document. Excluded employees include: employees covered by a collective bargaining agreement, non-resident aliens, leased employees, certain highly compensated employees, employees of any member of the controlled and/or affiliated service group Employer whose Employer does not affirmatively adopt the Plan; personal assistants and any other employees covered under the Concepts of Independence, Inc. Supplemental Retirement Plan. An employee is eligible to participate in the Plan upon attainment of age twenty-one year or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

***Contributions***

The Employer may make discretionary contributions as determined by the Board of Trustees. Contributions are allocated to each eligible employee, who is active at end of the year and has completed at least 1000 hours in the Plan year, based on their eligible compensation, as defined in the Plan document. For the year ended June 30, 2024 the Employer made a contribution equal to 6% of each eligible participants eligible compensation, as defined by the Plan document. Transfers from qualified plans (rollover contributions) are also permitted. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

***Participant Accounts***

Each participant's account is credited with the discretionary Employer's contribution, allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined in the Plan document.

***Vesting***

Upon completing 3 years of service a participant is 100% vested in discretionary Employer contributions including allocated earnings thereon at all times thereon.

***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (“borrower”) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of the vested account balance or \$50,000 (whichever is less). Participants may only have five outstanding loan at a time. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant’s principal residence or the participant is on authorized leave of absence for a period which extends the maturity date of the loan beyond five years.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account, in the form of a lump sum distribution, installment payments or an annuity distribution. A participant may request an in-service distribution once they have reached age 59 ½. In the event of a hardship distribution, only the participant’s discretionary Employer Contribution and earnings thereon are eligible to be distributed.

***Expenses***

Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Plan service charges are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

***Forfeited Accounts***

At June 30, 2024 and 2023, the forfeited nonvested account totaled \$86,181 and \$6,033. This account will be used to pay Plan expenses. During the plan year ended June 30, 2024, no forfeitures were used.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies *(continued)***

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At June 30, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using Level 1 inputs.

***Investment Valuation and Income Recognition***

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Guaranteed interest account is valued at contract value, which represents contributions made plus credited interest less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and expensed when they are paid. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 11, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York (“Empower Life & Annuity”) and Empower Trust Company, LLC, qualified institutions.

**4. Guaranteed Interest Account**

The Plan has a benefit-responsive investment contract with Empower Life & Annuity. The Guaranteed Interest Account (the “GIA”) is provided through a group annuity contract (the “Contract”). The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or more than 3%. The average yield earned by the Plan for 2023 is 1.66% and for 2024 is 1.77%. The crediting rate is reviewed on a 6 basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Participants ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The group annuity contract represents 3.02% and 0.60%% of the total investments as on June 30, 2024 and 2023. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investor Service (Aa3 as of March 2025), A.M. Best Company (A+ as of March 2025), Fitch (AA as of March 2025), and Standard and Poor's (AA as of March 2025).

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

**6. Tax Status**

The IRS issued an opinion letter to the prototype plan document preparer, Empower Retirement LLC, dated November 14, 2022, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**7. Party-in-Interest Transactions**

The group annuity contract was issued by Empower Life & Annuity, a custodian of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Empower Life & Annuity was paid \$24,305 in fees during the June 30, 2024 plan year.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
