Opinion

We have audited the accompanying financial statements of Plumbers & Pipefitters Local 168 Vacation Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of August 31, 2024 (in liquidation) and 2023, and the related statements of changes in net assets available for benefits for the years then ended August 31, 2024 (in liquidation) and 2023 (ongoing), and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Plumbers & Pipefitters Local 168 Vacation Fund as of August 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Plumbers & Pipefitters Local 168 Vacation Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note A to the financial statements, the Board of Trustees of the Plumbers & Pipefitters Local 168 Vacation Fund approved a plan of termination on June 13, 2024, and management determined liquidation is imminent. As a result, Plumbers & Pipefitters Local 168 Vacation Fund changed its basis of accounting to the liquidation basis of accounting to present the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

August 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

Plumbers & Pipefitters Local 168, the Plan sponsor, terminated the Plumbers & Pipefitters Local 168 Vacation Fund effective August 31, 2024. In accordance with generally accepted accounting principles, the Plan changed its basis of accounting used to value Plan assets from the ongoing basis to the liquidation basis of accounting for the year ended August 31, 2024.

The following description of Plumbers & Pipefitters Local 168 Vacation Fund (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution vacation plan governed under an agreement between Local Union 168 (Local) of the United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada (Association), and the Marietta Area Plumbing-Heating and Mechanical Contractors (Employers). The Plan covers all employees represented by the Local who are employed under the terms and conditions of the collective bargaining agreement with the members of the Association.

Benefits

Vacation benefits are paid out on or before the fifteenth day of June and December each year. Prior to each payment, the Trustees determine if interest income is to be credited to the participants' accounts. The amount of income to be credited is determined from the excess of fund interest earned which is in excess of plan expenses. The payment made on or before June 15 is for contributions made during the months of November through April and the payment made on or before December 15 is for contributions made during the months of May through October. All participants can, by request, get payments bi-monthly. If the participant should retire or, if he or she should die, the balance in the participant's account will be paid immediately.

Contributions

Participating employers contribute to members' after-tax dollars earned to the Plan. From June 2022 to May 31, 2024 the contribution rate per hour paid was \$7.50. In June 2024, the contribution rate per hour paid increased to \$8.50. This rate remained in effect through plan termination.

Due to the termination of the Plan, July 2024 contributions were the last required contributions to be received by the Plan.

Vesting

The benefits provided under this Plan are not vested and can be modified or eliminated by the Trustees at any time.

Plan Termination

The Plan may be terminated only by joint agreement between the Employers and Local, subject to the provisions set forth in ERISA. The Plan was terminated on August 31, 2024 and the net assets of the Plan were distributed to the members on the basis of amounts in their individual accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of Plumbers & Pipefitters Local 168 Vacation Fund have been prepared in conformity with accounting principles generally accepted in the United States of America.

As discussed in Note A, upon termination of the Plan, the basis of accounting was changed to value plan assets from the ongoing plan basis to the liquidation basis of accounting for the year ended August 31, 2024.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Employer Contributions Receivable

Contributions for hours paid to participants during a particular month are required to be submitted to the Plan the following month. Accordingly, there is approximately one month's contributions outstanding at the end of each month. As of August 31, 2024, all required employer contributions were received by the Plan.

Funding Policy

Association employers make contributions to the Plan for each hour paid to participants. These contributions are included in the participant's gross income and are thus made from after-tax dollars. Each participant's contribution is accounted for separately.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE C – INVESTMENTS

Since vacation benefits are paid twice a year, the Plan must remain in a liquid position. Management invests excess cash only in diversified money market accounts managed by Meeder Asset Management, Inc., registered investment advisors and PNC Bank. These money market accounts are recorded at net asset value (NAV) and are presented as investments on the Statements of Net Assets Available for Benefits. As of August 31, 2024, all Plan investments were liquidated.

NOTE D – CONCENTRATIONS

The Plan maintains its cash in financial institutions. Accounts at these institutions are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per institution. Financial Accounting Standards require disclosure of all deposit balances in excess of insured limits. On occasion, the Plan maintains cash and cash equivalents balances at financial institutions in excess of insured limits.

Employer Contribution Concentration

For the year ended August 31, 2024, one employer remitted contributions in excess of 10% of total contributions. For the year ended August 31, 2023, two employers remitted contributions in excess of 10% of total contributions.

NOTE E – ADMINISTRATIVE FEE INCOME

Administrative fees charged on all participant withdrawals were \$34 per withdrawal effective January 1, 2023. Total administrative fees charged by the Plan for the years ended August 31, 2024 and 2023 were \$26,557 and \$33,804, respectively.

NOTE F – TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(a) of the Internal Revenue Code and, accordingly, the Trust is exempt from income taxes. Management believes the Trust, as amended, continues to qualify and to operate in accordance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is funded with after tax dollars from the individual participants. Therefore, if dividends are paid to the participants, then the participants would be required to pay income taxes on those monies.

NOTE G – PARTIES IN INTEREST

Certain parties provide services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. These services are parties-in-interest transactions. The Plan also invested in money markets which are owned and managed by the custodian. These transactions also qualify as party-in-interest transactions.

NOTE H – SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through April 8, 2025, which is the date the financial statements were available to be issued.
