Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Northeastern Center, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1. Plan Description

The Northeastern Center, Inc. Retirement Plan (the "Plan") is a defined contribution plan covering eligible employees of Northeastern Center, Inc. (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

Contributions

All employees who have attained age 21 and completed one year of service (1,000 hours) may make voluntary pre-tax contributions and after-tax Roth contributions of any amount not to exceed the maximum amount permitted under the Internal Revenue Code. Employee rollover contributions are also allowed. Participants may change their deferral amounts quarterly; however, they may stop contributions to the Plan at any time.

The Plan provides for an employer discretionary matching contribution and a discretionary profit sharing contribution. To be eligible for the discretionary employer contributions, a participant must have attained age 21 and completed one year of service. In addition, within the Plan year, the participant must complete at least 1,000 hours of service and be employed on the last day of the Plan year. The Employer will also make additional safe harbor contributions to the Plan in an amount not less than 3% of participants' compensation. The eligibility requirements for safe harbor contributions are attainment of age 21 and completion of one year of service (1,000 hours).

For the year ended June 30, 2024, the Employer made a discretionary matching contribution of 100% of employees' salary deferral amounts up to 4% of each participant's eligible compensation. The Employer also made a safe harbor contribution for 2024 in the amount of 3% of eligible compensation. There was no discretionary profit sharing contribution in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's contributions, an allocation of Plan earnings and is charged with an allocation of administrative expenses and any benefit payments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions into various funds offered by Ascensus Trust Company. All amounts in participant accounts are participant-directed and allocations can be changed daily.

Vesting

Participants are immediately vested in their elective (voluntary) contributions, safe harbor contributions and income or loss thereon. Vesting in the Employer's discretionary match and discretionary profit sharing contributions portion of their accounts plus actual earnings thereon is based on participants' years of continuous service. A participant becomes fully vested upon 5 years of credited service or 100% upon attainment of early or normal retirement age. Plan vesting is as follows:

Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their Employer discretionary match and profit sharing contributions. These forfeitures are used to reduce future Employer contributions or to pay Plan expenses. During the Plan year ended June 30, 2024, \$4,908 of forfeitures were used to reduce Employer contributions and pay Plan expenses. At June 30, 2024 and 2023, there was no balance of forfeited nonvested accounts.

Benefit Payments

Normal retirement age under the Plan is 65, with the option to withdraw in-service funds from limited accounts if fully vested and reached the age of 59 1/2. Minimum distributions are required once the participant reaches age 73. On termination of service or retirement, a participant has the following options regarding his or her value of the vested interest: a) receive a lump-sum payment, b) rollover the balance into another qualified plan, c) receive annuity payments over a period of time, or d) remain in the Plan as an inactive participant. However, if a terminated participant's vested account balance is \$5,000 or less and they have not elected a rollover, they will receive a lump-sum distribution. If a participant is still a current employee and has not yet reached the early retirement age of 55, the participant (or beneficiary) can only withdraw funds in the event of death or a disability which prevents them from working.

Notes Receivable from Participants

The Plan allows participants to borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and a minimum of \$1,000. Participants are only permitted one outstanding loan at a time. The loans are secured by the balance in the participant's account and bear interest at the current prime rate plus 2% (fixed at origination). The interest rates for loans outstanding as of June 30, 2024, range from 4.25% - 10.50%. The terms of the loan may not exceed five years, unless used to acquire a principal residence, in which case longer terms are allowed. Principal and interest is paid ratably through regular payroll deductions. The balance of the loan becomes due upon termination of employment of the participant. Loans outstanding at June 30, 2024, mature through July 2030.

Administrative Expenses

A portion of administrative fees and expenses are paid by the Plan and consist of investment management, audit, consultant, custodian and recordkeeper fees. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in the net appreciation in fair value of mutual funds.

Termination of the Plan

Although the Employer has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and capital gain distributions are recorded on the ex-dividend date. Net realized and unrealized appreciation includes the Plan's gains and losses on mutual funds bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Payments

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through April 11, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the custodian, Ascensus Trust Company and Newport Trust Company, LLC, and was not subjected to any auditing procedures performed by the independent public accountants.

- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, including interest, dividends and capital gain distributions and net realized and unrealized appreciation in fair value of mutual funds.

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

Money market fund: Money market funds generally include cash and cash equivalents that are highly liquid and are short-term in nature.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Income Tax Status

The Plan, which is a prototype plan, obtained its opinion letter on November 30, 2020, stating that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6. Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7. Transactions with Parties-In-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in a money market fund sponsored by the custodian. Notes receivable from participant transactions are also party-in-interest transactions.

The Employer provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal and other services are rendered by parties-in-interest and are paid by the Employer.
