1. DESCRIPTION OF PLAN

The following description of Porter-Starke Services, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution pre-approved plan and trust sponsored by Ascensus LLC for Porter-Starke Services, Inc. (the Company) for the benefit of eligible employees as defined by the plan document. Eligible employees are permitted to make elective deferrals as early as the first month following their first 30 days of employment. One year of service, as defined by the Plan, is needed to be eligible for the non-elective contribution and discretionary match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and Funding Policy

Non-elective contributions are discretionary as determined by the Company's Board of Directors. The non-elective contribution for 2024 and 2023 was 3% of eligible wages. Employees are allowed to make contributions to the Plan at their discretion. The Company, at its discretion, can match employee contributions. For 2024 and 2023, the discretionary matching rate was 20% of the employee deferral amount.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the allocation of the Company's contribution, the employee's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocation of Company contributions is based on participant wages or employee contributions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Each participant directs the investment of his or her account to any of the investments options available under the Plan.

Compensation

Participant compensation is defined by the Plan as wages, tips and other compensation reported on the Federal Form W-2, Wage and Tax Statement.

Vesting

A participant is 100% vested in previous voluntary contributions plus earnings thereon and 100% vested in Company contributions after six years of credited service or once a participant reaches normal retirement.

Forfeitures

After termination of employment, the nonvested portion of the participant's account is called a forfeiture and remains in the Plan to reduce Company contributions. In 2024, forfeitures of approximately \$21,000 were used of reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of the fair market value of their vested account balance built up from employer contributions, voluntary contributions and rollover contributions. The loans are secured by the balance in the participant's account and shall bear interest at a rate reasonable at the time of application. Principal and interest are paid in equal installments not less frequently than quarterly. As of June 30, 2024 and 2023, outstanding loans approximated \$104,000 and \$86,000, respectively. The loans bear interest with rates ranging from 4.25% to 9.50% and mature at various dates through 2029.

Payment of Benefits

Upon termination of service, participants may elect to receive a lump-sum amount equal to the value of their accounts. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Expenses of the Plan

The Company pays certain expenses of the Plan, including accounting and other administrative fees.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments

Investments are reported at fair market value. Shares of mutual funds are valued at the daily closing price as reported by the fund. Common collective trusts are valued at the net asset value of the units held based on the contract value of the underlying investments held less liabilities. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Due to Participants

Excess contributions due to participants represent contributions in excess of amounts allowed by Internal Revenue Service and are returned to the participant in the subsequent year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is April 11, 2025.

3. INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEES

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the schedule of assets at June 30, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023:

- *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common collective trust:* Funds that are composed primarily of investment grade, fixed and floating rate securities that are valued at NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.
- *Common collective trust holding a fully benefit-responsive investment contract:* The investment contract consists of the units of the insurance company's separate accounts and an insurance wrapper that guarantees Plan participants can transact at contract value in perpetuity. The fair value of the contract is estimated to be the sum of the fair value of the separate accounts owned by the insurance company and the fair value of the insurance wrapper. The separate accounts, which are invested in a variety of fixed income investments, are unitized and given a NAV by the insurance company using the observable market values of the securities comprising the separate accounts. The wrapper fair value is provided by the insurance company and calculated through discounting the required cash flows to maintain the wrapper guarantee using London Interbank Offered Rate swap rates over five years which are substantiated through available market data.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. Administrative fees are paid to Reliance Trust Company, the trustee. Fees for services paid by the Plan to the trustee were approximately \$94,000 for 2024. Blue & Co., LLC is the independent auditor for the Plan and receives payment for those services. The Company pays a portion of the expenses of the Plan, including accounting fees. These expenses qualify as party-in-interest transactions.

6. TAX STATUS

The IRS has determined by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan holds investments which are exposed to various risks such as interest rate, market, and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term that could materially affect the amounts reported in the accompanying financial statements.
