As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate to the best of their knowledge.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section it is inappropriate to and we do not express an opinion on these supplemental schedules.

Note 1. Description of the Plan

The following description of the Section 403(b) Plan for God's Love We Deliver (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

God's Love We Deliver, Inc. (GLWD) originally adopted the Plan on July 1, 1998. The Plan is a contributory-defined contribution plan covering all full-time and part-time employees who work a minimum of 20 hours per week. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Eligible participants are able to contribute up to 100% of their annual compensation on a pretax basis, as defined. Compensation is defined as total amounts paid to the employee for services rendered, although some items may be excluded. The total contribution to the Plan may not exceed the dollar limit for tax-deferred contributions set by the Internal Revenue Code. Participants over the age of 50 may make additional "catch-up" contributions.

All participant contributions made to the Plan were matched in each pay period by GLWD in amounts up to 2% of total compensation. Furthermore, GLWD may make a year-end discretionary contribution to the Plan for all full-time participants who have completed a minimum of 1,000 hours of service during the year and are still employed at fiscal year-end. Participants are not required to make voluntary contributions to the Plan in order to receive the employer's year-end discretionary contribution. For fiscal year 2024, eligible employees received a discretionary contribution of 2% of their total earnings. Contributions are subject to certain limitations.

The Plan permits participants, at their election, to roll over previous balances from qualified pension or profit-sharing plans. Participants are immediately vested in their transfer or rollover amounts.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and fixed-interest accounts as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) GLWD's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their employee and employer contributions (and the related earnings).

Forfeited Accounts

There are no forfeitures, as eligible participants are immediately vested.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, and if the vested benefit in the Plan does not exceed \$5,000, then benefits may only be distributed in the form of a lump-sum payment. If the vested benefit in the Plan exceeds \$5,000, distribution in a form other than an annuity payment requires the annuity form of payment to be waived.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000. The loans are secured by the balance in the participant's account. The interest rate for the loans for 2024 and 2023 ranged from 4.25% to 9.50% and 4.25% to 9%, respectively. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in Lincoln NY Stable Value Account is recorded at contract value. Contract value represents contributions made under the contract, plus a minimum rate of interest earned, at a rate determined by Lincoln Life and Annuity Company of New York, less withdrawals, and transfers to other accounts. This account does not have any liquidity restrictions, is fully benefit-responsive and has been classified as a fixed interest account (see Note 5 for a further discussion of the fixed interest account).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are recorded at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are deemed distributions based upon the terms of the plan document.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses other than investment management fees are paid for by GLWD, the Plan Sponsor. Contract administration fees are paid from the assets of the Plan. Fees paid by the Plan for investment management services are included as a reduction of the return on each fund (see Note 8).

Note 3. Disclosures About Fair Values of Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended June 30, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. There are Level 1 investments held by the Plan and are valued at the net asset value (NAV) of shares held by the Plan at year-end. There are no Level 2 or 3 investments held in the Plan.

Note 4. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc. (Lincoln), a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of June 30, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Guaranteed Interest Account

The Plan entered into a fully benefit-responsive guaranteed interest account with Lincoln through its subsidiary Lincoln Life and Annuity Company of New York totaling \$851,022 and \$864,882 at June 30, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified minimum interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%.

The fixed-dollar annuity contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligation. The issuer's ability to meet its contractual obligation may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the Code) or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

The Plan believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The fully benefit-responsive guaranteed interest account does not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, GLWD has the right under the Plan to discontinue its contributions at any time and/or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100% vested in their employee and employer contributions, which will be distributed in a lump sum.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's statements of net assets available for benefits.

Note 8. Party-in-Interest and Related-Party Transactions

Certain investments of the Plan are invested in mutual funds and guaranteed interest account held by Lincoln, the custodian of the Plan. Contract administration fees of \$40,415 were paid from the assets of the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return on each fund. These transactions qualify as party-in-interest transactions, which are deemed to be "exempt" from the prohibited transaction rules, as defined by Department of Labor regulations. GLWD provides certain administrative services at no cost to the Plan.

Note 9. Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by Lincoln Financial Group Trust Company, Inc. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Note 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Sponsor remitted all employee contributions and loan payments to the Plan, employee contributions and loan payments of \$32,644 were not remitted within the required time period for the year ended June 30, 2024.

Note 11. Subsequent Events

Subsequent events have been evaluated through April 14, 2025, which is the date the financial statements were available to be issued.

Effective February 1, 2025, the Plan was amended to allow for Roth deferrals and matching contributions on Roth deferrals.
