## **INDEPENDENT AUDITORS' REPORT**

To the Board of Trustees  
Jewish Community Health Plan  
Pittsburgh, Pennsylvania

### **Opinion**

We have audited the accompanying financial statements of Jewish Community Health Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of the Board of Trustees for the Financial Statements**

The Plan's Board of Trustees is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Trustees is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The Board of Trustees is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### NOTES TO FINANCIAL STATEMENTS

#### 1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Organization* - Jewish Community Health Plan (the Plan), which was formed on June 6, 2017, provides certain insured benefits to enrolled participants (and their eligible dependents) of participating employers that are Jewish community organizations. Specifically, employers whose general purpose is the furtherance of Jewish education, social, religious and/or community values in western Pennsylvania and whose participation has been approved by the Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and regulation under state law.

The Plan is a multiple employer welfare benefit association (MEWA) which utilizes a voluntary employee benefit association, a trust, as its operating vehicle. Medical, dental and vision benefits (benefits) are available to employees of participating employers and to their covered spouses, children and other dependents. If coverage under the Plan ceases because of certain qualifying events, participants may have the right to purchase continuation coverage for a temporary period of time under the Consolidated Omnibus Budget Reconciliation Act of 1996 (COBRA).

Benefits are provided under a group insurance contract between the Plan and University of Pittsburgh Medical Center (UPMC), which extends through June 30, 2025. The Plan offers life, accident, and critical illness coverage as well as disability coverage. Eligibility of participants varies by employer, each of which maintains plan documents describing those Plan coverages that are available to their employees and dependents, as well as any copay requirements.

The activities of the Plan are controlled by a Board of Trustees comprised of representatives of participating employers and members of the Jewish community. The Plan has no employees. My Benefit Advisor, a division of Emerson Rogers, LLC, serves as the Plan's third party administrator and consultant and uses AMCA Systems, LLC as a subcontractor for billing services.

*Basis of Accounting* - The accounts of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles accepted in the United States (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP often involves estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenues and expenses during the reporting periods. These financial statements do not include any significant estimates.

*Cash* - The Plan maintains, in a checking account at a financial institution, cash which may at times exceed federally insured amounts and which may at times exceed reported amounts due to outstanding checks.

*Contributions* - Billings related to group insurance coverage provided under contracts between the Plan and the insurer, as well as administrative charges, are recognized in the period to which the coverage and charges pertain. Administrative charges are reflected net of commissions (see Note 2).

Premiums for monthly coverage, as well as a charge for the Plan's administrative costs, are billed and due in the month prior to which the coverage pertains. These premiums are remitted to the insurer in the middle of the month to which coverage applies. Advance payments represent payments received for subsequent year coverage prior to the end of the current fiscal year. If a participating employer is delinquent in payment, coverage can be terminated.

*Subsequent Events* - Management has evaluated subsequent events through April 9, 2025, the date which the financial statements were available to be issued.

## **2. CONSULTING AGREEMENT**

The Plan has contracted with My Benefit Advisor to provide comprehensive administration and marketing services, whether directly or through the engagement of other professionals and consultants. My Benefit Advisor also provides billing and collection services for the Plan. For the year ended June 30, 2023, the Plan's obligation to My Benefit Advisor was partially satisfied via standard commissions of \$120,037 paid directly to My Benefit Advisor. The Plan owed My Benefit Advisor the remaining \$4,963 at June 30, 2023, which was included in accounts payable on the statement of net assets available for benefits. Effective July 1, 2023, the annual fee for the billing and collection services was increased from \$125,000 to \$150,000. For the year ended June 30, 2024, the Plan's obligation to My Benefit Advisor was fully satisfied via standard commissions paid directly to My Benefit Advisor.

## **3. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Board of Trustees has the right under the Plan to modify the benefits provided to active employees and to terminate the Plan subject to the provisions set forth in ERISA.

## **4. INCOME TAX STATUS**

The Plan requested and received tax-exempt status under Section 501(c)(9) of the Internal Revenue Code (IRC). The latest determination letter was received on August 16, 2019, in which the Internal Revenue

Service stated that the trust, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan has and continues to operate in compliance with the applicable provisions of the IRC.

U.S. GAAP prescribes a comprehensive model for the financial statement recognition, measurement, presentation, and disclosure of uncertain tax positions taken or expected to be taken in income tax returns. The trustees and third party administrator believe that there is no liability related to uncertain tax positions at June 30, 2024 or 2023. The Plan is no longer subject to tax examinations for years prior to June 30, 2021.

**5. CONCENTRATION**

The Plan had six participating employers that represented 79% and 77% of total premiums for the years ended June 30, 2024 and 2023, respectively.

**6. RELATED PARTIES**

Neither the participating employers or the trustees receive compensation from the Plan.


