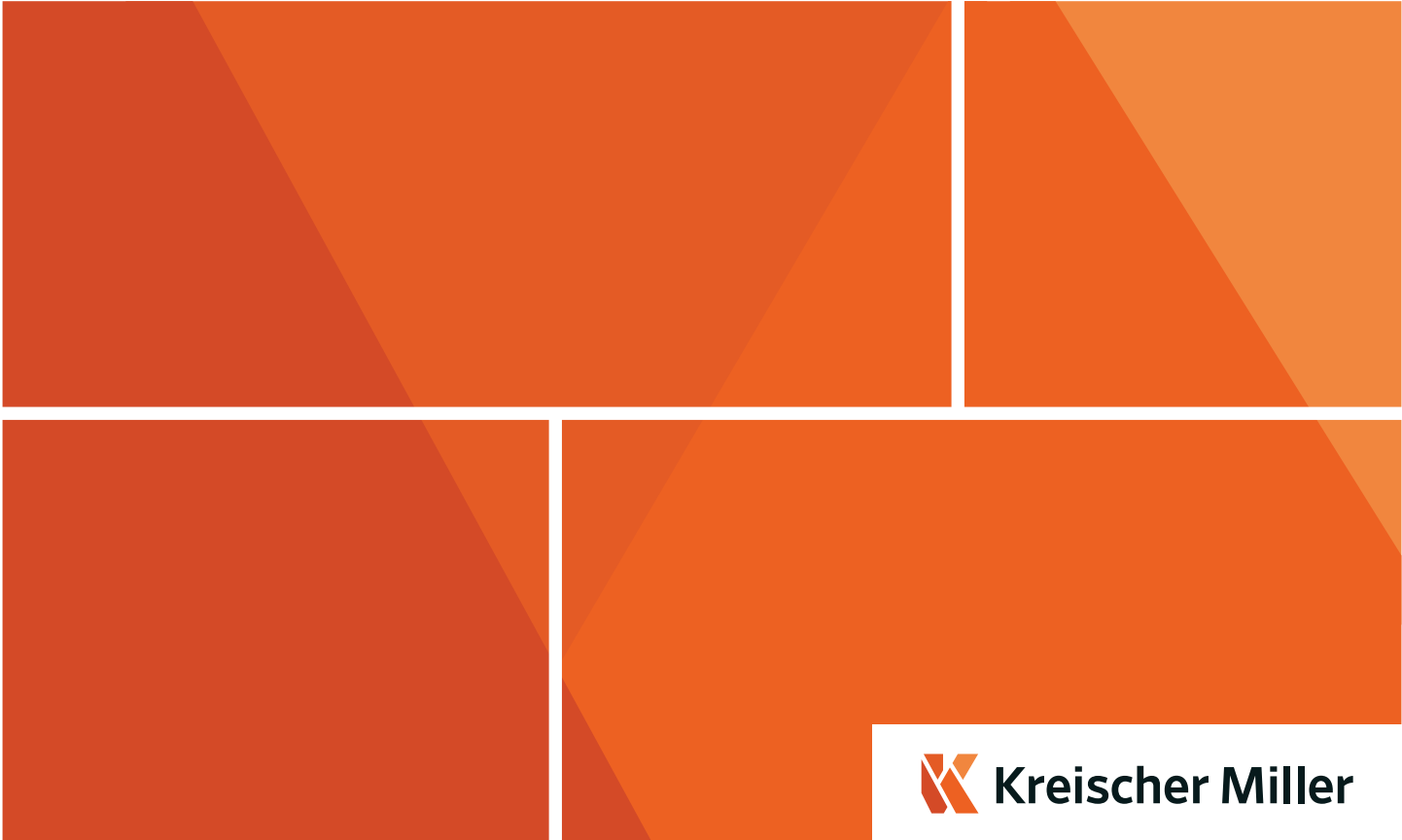

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Easter Seals of Southeastern Pennsylvania Defined Contribution and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

June 30, 2024 and 2023

(1) Description of Plan

The following description of the Easter Seals of Southeastern Pennsylvania Defined Contribution and 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of Easter Seals of Southeastern Pennsylvania (the Agency) who are credited with 30 consecutive days of service and are age eighteen or older. Participation for a non-safe harbor matching or discretionary contribution requires the employee to have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Temporary and casual employees are not eligible for this benefit. The 401(k) Committee (Committee) is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Agency's Audit Committee.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, subject to Internal Revenue Service (IRS) limitations. Participants may elect to have their deferrals be either pre-tax or after-tax (Roth) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The terms of the Plan provide that the Agency may make non-safe harbor employer matching contribution on behalf of each eligible participant in an amount equal to a percentage of the eligible contributions made by each eligible participant during the contribution period. In addition, the Plan provides that a discretionary contribution may be made by the Agency on behalf of any participant. The discretionary contribution allows the Agency to differentiate the percentage or amount of contribution based on whether a participant has 15 years or more of service with the Agency. Both the matching and discretionary contributions require the employee work at least 1,000 hours during the plan year and be employed on the last day of the plan year. The matching contribution authorized for the plan years ended June 30, 2024 and 2023 were \$0 and \$101,022, respectively. No discretionary contribution was authorized by the Board of Directors for the years ended June 30, 2024 and 2023. Contributions are subject to certain limitations.

Contributions, Continued

The Plan includes an automatic enrollment provision as well as an automatic increase feature. The auto-enrollment provision applies to all newly eligible employees and existing employees who contribute less than 4% of eligible compensation to the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a Vanguard Target Date Portfolio fund until changed by the participant. The contribution percentage for participants who were contributing less than 10% and did not opt out of this provision will increase by 1% each September 1 thereafter until their contribution percentage equals 10%.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Agency's contributions, (b) plan earnings and (c) an administrative expense allowance, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Agency's contribution portion of their accounts is based on years of credited service according to the following schedule:

Notes Receivable from Participants

Participant loans are not permitted by the Plan.

Payment of Benefits

On termination of service due to death, disability, or qualified retirement, as defined, a participant or surviving beneficiary will be entitled to 100% of their account balance. For termination of service due to other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in their account.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$12,343 and \$175, respectively. These accounts will be used to pay administrative expenses incurred by the Plan or to reduce future employer contributions. During the year ended June 30, 2024, no forfeitures were used to offset employer contributions from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Agency and are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

(3) Investments Certified by Qualified Institutions

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value held at June 30, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended June 30, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by John Hancock Trust Company, LLC (John Hancock) and John Hancock Life Insurance Company (U.S.A) (JH Life), the qualified institutions. JH Life held the Plan's investment assets as of June 30, 2023. John Hancock held the Plan's investment assets as of June 30, 2024 and executed investment transactions for the Plan year July 1, 2023 through June 30, 2024.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common/Collective Trust: Valued on the net asset value (NAV) of units of a bank common/collective trust. The NAV, as provided by the qualified institutions, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisers reserve the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled separate accounts: Valued on the NAV of units held by the Plan at year end based on the market value of its underlying investments. Although the pooled separate accounts are not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market.

Guaranteed interest accounts: Value of the guaranteed interest accounts is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

There were no significant transfers among investment levels during the years ended June 30, 2024 and 2023.

(5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are a guaranteed interest account managed by JH Life and common collective trust accounts managed by John Hancock and JH Life. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest, which are exempt from the prohibited transaction rules. Fees paid by the Plan for investment management services amounted to \$60,789 for the year ended June 30, 2024.

(6) Plan Termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

(7) Tax Status

The Plan uses a preapproved plan document sponsored by The Cafaro Group LLC. The IRS has determined and informed The Cafaro Group LLC by a letter dated June 30, 2020, that the preapproved plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
