### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Employee Benefit Plan of Sarah Tuxis Residential Services, Inc. (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended June 30, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Employee Benefit Plan of Sarah Tuxis Residential Services, Inc.’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Employee Benefit Plan of Sarah Tuxis Residential Services, Inc. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 — PLAN DESCRIPTION**

The following description of the Employee Benefit Plan of Sarah Tuxis Residential Services, Inc. (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The descriptions provided herein are for informational purposes only and should not be relied upon by participants or others.

**General** — The Plan was established effective July 1, 2000. It is a defined contribution plan, covering all employees of the Sarah Tuxis Residential Services, Inc. (“the Employer”) who meet the Plan’s eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees (as defined by the Plan) are eligible to participate in the Plan on the first day of the following month after they have attained the age eighteen. Employees are eligible to receive employer matching contributions after they have been credited with one year of service and made contributions to the Plan during the Plan year and are actively employed on the last day of the Plan year that the base contribution was declared.

**Employee Contributions** — Participant contributions are based on a discretionary dollar amount of pre-tax compensation, which is limited to a maximum annual contribution as permitted by the Internal Revenue Code Section 401(k). The limit for June 30, 2024 and 2023 is \$23,000 and \$22,500 of compensation. Participants may elect to make voluntary contributions from after-tax compensation, subject to certain limitations. In addition, participants may contribute rollover amounts representing distributions from other qualified benefit plans.

Participants direct the investment of their contributions into one or more funds held in trust by the designated trustee, Mutual of America. The Plan participants may change their investment options at any time. There is no nonparticipant directed funds.

**Employer Contributions** — The Employer, at its discretion, may make matching contributions on behalf of the participants. Discretionary contributions are allocated to the accounts of eligible participants on the basis of the ratio that each eligible participant’s salary reduction contribution amount bears to the total salary reduction contributions amount of all participants for the Plan year. Age 50 catch-up contributions are not eligible for a matching contribution. During the Plan year ended June 30, 2024 and 2023, the Employer contributed \$300,000 and \$172,000 into participant accounts for matching contributions, which related to the June 30, 2023 and 2022 Plan years. The Employer accrued \$300,000 and \$300,000 in matching contributions payable, which relate to the 2024 and 2023 Plan years, respectively.

The Employer, at its discretion, may make base contributions. Base contributions are allocated to the accounts of eligible participants on the basis of the ratio that each eligible participant’s eligible compensation bears to the total eligible compensation of all participants for the Plan year. For the years ending June 30, 2024 and 2023, the Employer accrued \$0 in base contributions.

**Vesting** — Participants are 100% vested in their accounts at all times. The amounts in the participant employer contribution accounts vest 100% after three years of vesting service.

***Payment of Benefits*** — Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed the life expectancy of the participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeited Accounts*** — Forfeitures are used to increase future employer contributions. For the years ended June 30 2024 and 2023, employer contributions were increased by \$0 and \$1,803 respectively, by forfeited non-vested accounts.

***Participant Loans*** — Participants may not borrow from their fund accounts.

***Summary of Plan Amendments*** —

Effective August 1, 2021, the Plan adopted an auto-enrollment provision whereby all newly eligible employees become automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 1% of eligible compensation.

The Plan was amended on May 27, 2014 to include the following:

- 1) The Plan year will begin July 1 and ending June 30.
- 2) Section 1.2(b)(1)(B)(i) was updated to read “The minimum service requirement is 3 months of eligibility (not to exceed 12 months) whether or not completed consecutively. For this purpose, a month of eligibility service means a month of vesting service determined in accordance with Section 3.3 and 3.4 but without regard to Section 1.5(a)(7)”.
- 3) Section 9.4 was changed to include an additional paragraph that states if the value of a terminated participant’s vested account is not greater than \$1,000, the terminated participant shall receive a one-time distribution of the value of the entire vested portion of such accounts and the non-vested portion shall be treated as forfeiture.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting*** — The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates*** — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition*** — The Plan’s investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The interest accumulation account is included in the financial statements at contract value, which is deemed to be fair value. The interest accumulation account is credited with a contractual rate of return rather than a market value. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The effective annual yield was 1.0% at June 30, 2024 and 2023.

***Administrative Expenses*** — The Employer sponsors the Plan. Personnel within the Employer perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these series are not included as Plan expenses but are paid by the Employer. Participant accounts are charged for the processing of distribution requests, hardship withdrawals and minimum required distributions.

***Payment of Benefits*** — Benefits are recorded when paid. For the years ending June 30, 2024 and 2023, benefits paid were \$530,823 and \$158,207, respectively.

***Delinquent Contributions*** — As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company will be remitting the lost earnings to the affected participants into the Sarah Tuxis Residential Services, Inc Employee Benefit Plan.

***Date of managements review*** — Subsequent events were evaluated through April 2, 2025, which is the date the financial statements were available to be issued.

### **NOTE 3—FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 inputs for the periods presented.

### **NOTE 4 — RELATED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS**

The Plan offers investments that are managed by Mutual of America, Mutual of America Life Insurance Company, a party related to Mutual of America, is the trustee of the Plan assets, therefore transactions in these Mutual of America funds qualify as party-in-interest transactions as defined by ERISA. Fees paid by the Plan for administrative expenses amounted to \$1,308 and \$839 for the years ended June 30, 2024 and 2023, respectively.

**NOTE 5 — PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 6 — TAX STATUS**

The Internal Revenue Service has determined and informed the Employer by a letter dated November 29, 2005 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Plan participants are not subject to federal income taxes on their contributions or on income accruing to their accounts until distributions are made from the Plan. Plan distributions are taxable as ordinary income, however, lump-sum distributions (as defined in the IRC) are not taxable in the year of distribution to the extent that, within 60 days of the distribution date, the participant transfers all or a portion of the cash to an Individual Retirement Account or another qualified plan or retirement annuity.

**NOTE 7 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements, including total investments held at June 30, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, and interest for the year ended June 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America.

**NOTE 8 — RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, which such changes could materially affect participants’ account balances, and the amounts reported in the statement of net assets available for benefits.
