As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Ballard Spahr LLP (the "Partnership") 401(k) Plan for Associates (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General:

The Plan was established on July 1, 1991 as a defined-contribution salary deferral plan and was amended and restated effective April 9, 2020. Eligible employees include all associates, as defined, staff attorneys, lawyers designated as counsel and special counsel and, effective January 1, 2016, a lawyer who is first designated as senior counsel on or after January 1, 2016. Associates and staff attorneys exclude individuals classified by the Partnership as leased employees, key employees (as defined) and senior counsel designated as such prior to January 1, 2016. Partners, support staff and lawyers designated as counsel and senior counsel, designated as such prior to January 1, 2016, participate in a separate 401(k) plan. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA").

Employees who have attained age 21 become eligible to participate on the first day of the calendar month following their date of employment.

[2] Contributions:

A participant may elect to contribute a portion of compensation, as defined, on a pre-tax or Roth after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to make voluntary non-deductible contributions in accordance with limits established by the Plan. In no event may participant pre-tax, after-tax and voluntary non-deductible contributions exceed the maximum amount permissible under the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans. There are no Partnership contributions to the Plan.

[3] Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Partnership's contributions, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant may designate the investment fund options in which to participate. Investment fund options of the Plan include various registered investment companies which are mutual funds and money market funds, participant-directed brokerage accounts and a common trust fund.

Participant account balances for associates who were admitted to the Partnership during the year ended June 30, 2023 were transferred from the Plan to the Ballard Spahr LLP 401(k) Plan for Partners and Employees, and these amounts are included in transfers into the Plan, net in the accompanying statement of changes in net assets available for benefits. In addition, participant account balances for partners who become of counsel or special counsel during the year are transferred into the Plan from the Ballard Spahr LLP 401(k) Plan for Partners and Employees, and these amounts are included in transfers into Plan, net in the accompanying statement of changes in net assets available for benefits. For the year ended June 30, 2024, transfers between plans were as follows:

[4] Vesting:

Participants are vested immediately in their elective deferral contributions, rollover contributions and earnings thereon.

[5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balances, plus any accrued but unpaid interest. A participant may borrow from his or her fund account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. Each loan is secured by the balance in the participant's account and bears interest at the bank's prime rate plus 1%. The interest rate on outstanding loan balances ranged from 4.00% to 9.50% as of June 30, 2024 and 4.00% to 9.25% as of June 30, 2023. Principal and interest are paid ratably through payroll deductions. Participants who have a severance from employment for any reason other than a layoff are required to repay any outstanding loan balance within 60 days of termination. If severance from employment is due to a layoff, the participant may elect to continue to make monthly loan repayments directly to the trustee. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

[6] Payment of benefits:

Upon termination of service due to death, disability, retirement or other reasons for severance of employment, a participant (or beneficiary) may elect to receive his or her vested accrued benefits. If the vested account balance is \$5,000 or greater, the participant (or beneficiary) may elect to receive his or her payment in a lump sum or by substantially equal installments. If the vested account balance is less than \$5,000 and the participant has not elected a lump-sum payment or installment arrangement, the participant's balance will be automatically distributed from the Plan. Benefit payments may also be made for qualified domestic relation orders, hardship withdrawals and in-service withdrawals.

The Coronavirus Aid, Relief, and Economic Security ("CARES") Act also provided optional distribution, as well as suspension of required minimum distributions ("RMDs") for anyone required to receive an RMD in 2020. The Plan Sponsor implemented the following provisions of the CARES Act, and the Plan formally amended effective December 31, 2022.

Participants, who met specific conditions, were eligible to take a COVID-19 related distribution up to \$100,000 without a 10% early withdrawal penalty. Eligible distributions could have been taken from January 1, 2020 through December 31, 2020, and may be repaid within three years. The repayments will be treated as tax-free rollovers into the participant's account.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The accompanying financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

[2] Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits are recorded when paid.

[5] Plan expenses:

Certain direct costs related to the administration of the Plan are paid by the Partnership. Other direct costs, including custodian and recordkeeping fees paid to the trustee, are paid by the Plan. Fees and commissions incurred in connection with any participant-directed brokerage accounts are charged directly to the Plan account for whom the trades were made.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity Management Trust Company ("FMTC") has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended June 30, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of June 30, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 or 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the respective fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common trust funds – Common trust funds are comprised of shares or units in commingled funds that are not publicly traded. The underlying assets in these funds are primarily publicly traded equity securities, fixed-income securities and commodity-related securities and are valued at their NAV, as a practical expedient, that is calculated by the investment manager or sponsor of the fund and have varying liquidity, redemption period notices and other restrictions. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Withdrawals directed by the Plan Sponsor must be preceded by twelve months written notice to the investment advisor, however, that the investment advisor may, in its discretion, complete any such plan level withdrawals before the expiration of such twelve-month period.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Participant-directed brokerage accounts – Accounts primarily consist of mutual funds and common stocks that are valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Changes in fair value levels:

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments consist of a common trust fund managed by FMTC. FMTC is the Plan trustee and recordkeeper and, therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan to FMTC were \$27,471 for the year ended June 30, 2024.

NOTE F - TAX STATUS

The Internal Revenue Service has determined and informed the Partnership by a letter dated February 26, 2016 that the Plan was qualified under the IRC and, therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the tax determination letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, at any time, the Partnership has the right to terminate the Plan subject to the provisions of ERISA.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of June 30, 2023 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through April 14, 2025, which is the date the financial statements were available to be issued.
