Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Exceptional Medical Transportation, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Exceptional Medical Transportation, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

[1] General:

The Plan was a defined contribution plan covering all eligible employees, as defined, of Exceptional Medical Transportation, Inc. (the "Company") who had completed three months of service. There was no minimum age requirement for participation. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The trustee of the Plan was Nationwide Trust Company, FSB, ("Nationwide Trust"), and the insurance company was Nationwide Life Insurance Company ("Nationwide Insurance").

On November 3, 2023, the entire Plan merged into DocGo 401(k) Plan. All participants, surviving beneficiaries in the Plan prior to that date became participants in the DocGo 401(k) Plan on that date. The account balance of each transferred participant in the DocGo plan immediately following the merger will equal to the account balance of such transferred participant in the Plan immediately before the merger. The Plan's loans and assets of \$7,084,276 were transferred over from Nationwide Trust Company, FSB to Ascensus Trust Company.

The participant and employer contributions under this plan ceased effective May 12, 2023 (except those that were accrued as of such date). Effective May 12, 2023, the Company became a participating employer in the DocGo 401(k) Plan. As a result, eligible participants, as defined under the DocGo 401(k) Plan, began contributing to that plan on May 12, 2023. Payments on existing notes receivable from participants continued through the effective merger date.

[2] Contributions:

Participants could contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants could also contribute amounts representing Roth elective deferrals. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. In no event could participant contributions exceed any statutory limitations. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company matched 50% of the participant contributions, up to 6% of base compensation, as defined in the Plan. The Company did not match the catch-up contributions. Participants directed the investment of participant and employer contributions into various investment options offered by the Plan.

[3] Participant accounts:

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings, and would have been charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

[4] Vesting:

Participants were immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts, plus actual earnings thereon, were as follows:

Participants became 100% vested upon death or total and permanent disability.

[5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants could borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years; however, terms could exceed five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bear interest at a rate of prime plus 1.5%, as defined. Interest rates on outstanding loan balances ranged from 4.75% to 7.75% at December 31, 2022. Principal and interest were paid ratably through payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. Related fees were recorded as administrative expenses and were expensed when they were incurred.

[6] Payment of benefits:

On termination of service, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a partial distribution. In-service distributions are permitted in case of hardship or when the participant reached the age of 59½. Hardship distributions are permitted only from a participant's elective deferral portion of his or her account balance.

[7] Forfeitures:

Forfeited nonvested accounts may be used to reduce future Company contributions and pay Plan expenses. During the final period ended November 3, 2023, forfeitures of \$4,025 were used to reduce employer contributions. Forfeited nonvested accounts available at November 3, 2023 and December 31, 2022 were approximately \$0 and \$712, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

[2] Subsequent events:

The Plan has evaluated subsequent events through April 11, 2025, the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits are recorded when paid.

[5] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in value of investments. The Plan also pays asset-based fees and transaction fees to the recordkeeper and the third-party administrator directly for the services rendered. The Plan pays investment advisory fees to investment advisors.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

[7] Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Nationwide Trust Company, FSB, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity as of November 3, 2023 and December 31, 2022 and for the final period of January 1, 2023 through November 3, 2023 in the accompanying statements of net assets available for benefits as of November 3, 2023 and December 31, 2022 and the statement of changes in net assets available for benefits for the final period ended November 3, 2023.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - FIXED INTEREST CONTRACT WITH INSURANCE COMPANY

In July 2019, the Plan entered into a benefit-responsive fixed interest contract with Nationwide Life Insurance Company (the "insurance company"). The insurance company maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the fixed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed interest contract. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 2.22%. The crediting rate ranged from 2.22% to 2.32% for the final period January 1, 2023 through November 3, 2023. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated without a 90-day notice from either the Plan or Nationwide Life Insurance Company.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Such events include the following:

1. Plan termination;
2. Merger of the Plan; or
3. A fifteen (15) percent or greater reduction in number of participants.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following:

1. Transfer of assets to a new investment vehicle or investment provider;
2. Cash payments to officers and owners for in-service withdrawals (except loans, financial hardships of \$50,000 or less taken at least twelve (12) months prior to separation of services, and amounts required to be distributed as a result of compliance with Section 401(a)(9) of the Internal Revenue Code), disability payments if such disability does not meet the Social Security definition, or upon severance of employment or retirement;
3. Outstanding loan balances of officers and owners upon payment of a cash payment on or after severance of employment; or
4. Cash payments resulting from a termination of a Plan or a fifteen (15) percent or greater reduction in number of participants, which is the result of any change in the Plan or action taken by the employer.

NOTE F - TAX STATUS

The Plan has adopted a Volume Submitter Profit Sharing Plan with CODA sponsored by Delaware Valley Retirement, Inc., the Plan's third party administrator. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an advisory letter that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related accounts are exempt from taxation. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related accounts are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of November 3, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Nationwide Financial Services, Inc., including its subsidiary Nationwide Trust Company, FSB, and Nationwide Life Insurance Company are considered related parties to the Plan. Certain investments are shares of mutual funds and insurance contracts managed by Nationwide Trust Company, FSB, and Nationwide Life Insurance Company. Nationwide Trust Company, FSB, and Nationwide Life Insurance Company are the Plan's trustee and insurance company. Therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan to Nationwide Trust Company, FSB, and Nationwide Life Insurance Company were \$24,472 for the final period January 1, 2023 through November 3, 2023. The Plan also pays accounting fees and the participant-initiated transaction fees to Delaware Valley Retirement, Inc., the Plan's third party administrator, and investment advisory fees to Wells Fargo Clearing Services, LLC and Iron Financial, LLC. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$29,885 for the final period January 1, 2023 through November 3, 2023.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE I - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE K - NONEXEMPT PARTY-IN-INTEREST TRANSACTION

During the final period ended November 3, 2023, the Company failed to remit certain loan repayments totaling \$2,860 to the Plan within the period prescribed by DOL regulations. As of the report date the Company is in the process of determining the lost earnings to be remitted to the impacted participants.

NOTE L - SUBSEQUENT EVENTS

The Company is delinquent on filing a complete Form 5500 for the Plan for the final period ended November 3, 2023 and has received correspondence from the DOL dated March 31, 2025 including consequences for non-filing and notice of intent to assess a penalty. The Company is in the process of obtaining the necessary information to file a complete Form 5500 for the year ended December 31, 2023.
