Independent Auditors' Report

To the Plan Administrator and Participants of the
Donnelly-Boland and Associates Welfare Benefits Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Donnelly-Boland and Associates Welfare Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

The following description of Donnelly-Boland and Associates Welfare Benefits Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan provides premium payments for health insurance, dental insurance, vision insurance, disability and life insurance and makes payments for self-insured short-term disability, cafeteria benefits, HRA, education and long-term care insurance claims to eligible participants of Donnelly-Boland and Associates, The Alliance for Infants and Toddlers, Human Services Administration Organization and Community Family Advocates (collectively, the Company or the Corporations). The Plan also provides payment to vendors for wellness related programs such as flu shots, biometric screening and healthy snack initiatives. The Plan was funded from the general assets of the Corporations through June 30, 2003. A voluntary employee benefits association (VEBA) trust (the Trust) was created in June 2003 to receive and hold the assets of the Plan and to disburse those assets for participant benefits. The Plan and the related Trust are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan and the Trust are intended to constitute a plan and trust under Section 125 of the Internal Revenue Code (the Code), as amended and are meant to comply with the applicable provisions of the Code and with the applicable provisions of ERISA.

Benefits

The Plan provides the benefits described above to eligible participants. Employee eligibility to participate in these benefits is based on their full-time or part-time status. Participation in the Plan by eligible employees is voluntary, except for vision insurance, which is provided for all eligible employees.

Claims of active participants, dependents and beneficiaries are processed by various insurance carriers. However, the Plan is responsible for payments of insurance premiums to insurance carriers retained by the Plan and payment of claims to participants receiving cafeteria benefits, short-term disability, education or long-term care benefits.

The Plan has a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The available HRA balance of an eligible participant is used to reimburse payments that are subject to the deductible. Any remaining balance due after available HRA balances are exhausted is billed to the participant. The Company is not permitted to refund any part of the balance to the employee, and the account cannot be used for anything other than reimbursements for qualified medical expenses. Amounts remaining when the employee leaves the Company are not portable, unless the participant is eligible for retirement under the Company's retirement plan. Effective January 1, 2018, the Company established the Donnelly-Boland Retiree-Only HRA Plan. Under this plan, terminated employees are eligible to participate if they are of normal retirement age under the terms of the Donnelly-Boland and Associates 401(k) Savings Plan and had a balance in their HRA when they retired. There is no unfunded post-retirement benefit obligation related to the Plan.

Participating employees, which include both full-time and part-time depending on their status, make monthly contributions depending on enrollment status and coverage type (individual, employee plus one and family) as outlined in Table I. Some of the features of the Plan are funded by Company contributions. For part-time employees, the features of the Plan that are funded by Company contributions are pro-rated, with employees paying the balance. Employees contribute \$1 per month for disability coverage with the Company paying the balance for short-term disability and the Plan paying the balance for long-term disability from forfeitures.

Forfeitures

Participants in the cafeteria benefit must submit qualifying expenditures for reimbursement prior to 90 days following the end of the Plan year in which the cafeteria contributions were made. Unused contributions remain in the VEBA. HRA contributions accumulate and are available to employees in subsequent years as long as they participate in the Plan. Unused HRA contributions are only forfeited when employees are terminated and are not eligible for retirement. Forfeitures totaled \$362,514 and \$451,516 for the years ended June 30, 2024 and 2023, respectively, and \$292,459 and \$239,398 were used to pay for plan benefits in these respective years. Cumulative forfeitures totaled \$2,289,143 and \$2,219,089 as of June 30, 2024 and 2023, respectively, from inception of the Plan. Forfeitures are and have been used to fund a noncontributory vision benefit, company portion of the cost of long-term disability coverage for employees and various wellness initiatives, to self-insure and enhance short-term disability benefits and to increase and expand the eligible uses of amounts allocated to employees under the Company's Section 125 benefit plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein; claims incurred but not reported; claims payable; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan obligations at June 30 for claims incurred by active participants but not reported at that date are estimated by the Plan and are included in the Statements of Benefit Obligations.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

Plan Expenses

All administrative expenses associated with providing benefits to the participants of the Plan are paid by the Plan. All corporate trustee, tax and audit fees of the Plan are also paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through April 14, 2025, the date the financial statements were available to be issued.

3. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation method used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Common stock is valued at the closing price reported on the market on which the individual security is traded.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Related-Party and Party In Interest Transactions

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Donnelly-Boland Tax Services, an affiliate of the plan sponsor, is paid for tax preparation services performed for the Plan.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

If the Plan and Trust are terminated, all contributions shall cease as of the date of termination. Assets remaining in the Trust after termination will be used for the payment of (1) benefits to employees with respect to claims arising prior to such termination, (2) reasonable and necessary expenses incurred in such termination and (3) taxes, until all assets of the Trust are liquidated.

6. Tax Status

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Code and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter dated March 9, 2005 from the Internal Revenue Service (IRS), and the plan administrator believes that the Trust, as amended, continues to qualify and operate in accordance with applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Amounts currently payable to or for participants, dependents and beneficiaries are recorded on the Form 5500 for cafeteria benefit claims that have been processed and approved within 90 days of the Plan's year end according to plan provisions, but have not yet been paid as of that date. The Company self-insures and the Plan pays directly for the short-term disability portion of the Company's employee benefit program, along with eligible education and long-term care benefits. The Company makes Plan contributions for these benefits based on an administrative charge per participant and payroll rates in effect when the Company began self-insuring these benefits in 2010.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

As of June 30, 2024 and 2023, the Plan had an investment of \$2,093,621 and \$1,794,576, respectively, that was concentrated in a mutual fund.
